On this occasion, the site inspection could not be conducted as high winds would not allow access to the pens. This inspection will be rescheduled.

Additional Case Information:

Site was visited earlier in the year, but due to high water temperature, EC inspection had to be rescheduled.

Wellboat is expected on site this week after the inspection for a FW treatment.

Fish came on from Loch Shin, Garasdale and Yetts O' Muckart. Fish have been feeding and growing well. AGD has been diagnosed on site and is the main cause for mortality. HSMI has also been detected on site but is not causing significant mortalities. Mixed stock from Stofinfisker and Aquagen. Stofinfisker stock have not been coping as well with the AGD and have made up the majority of the mortalities in recent weeks. Wk46 mortality event has been attributed to AGD combined with a period of bad weather and the site being unable to FW treat. FW treatment has been scheduled for the weekend following the inspection.

Site is being used as a nursery site and fish will be transferred to Skelwick and Moclett in the new year. Passive grading will be done in January and the largest fish will be moved first.

Fish were sitting deep in the water but those that were observed appeared in good physical health and were active in the cages. 2 moribunds and 2 mortalities were observed across the site. No other clinical signs were observed so were not sampled.

Updated 21/12/2023 [REDACTED] VMD samples collected were surplus to requirements and will not be processed.
