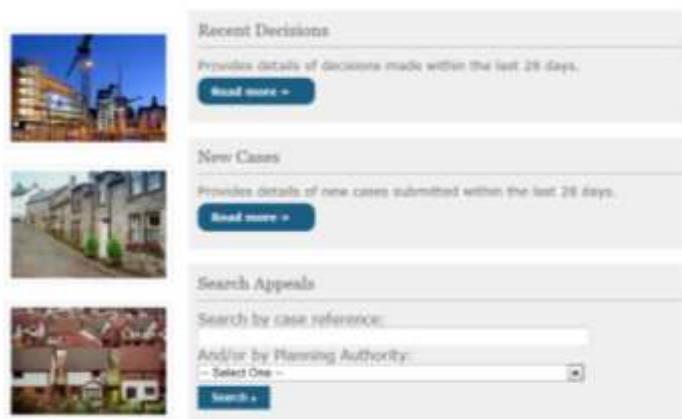
Homepage

There is a section with a short explanation about our website.



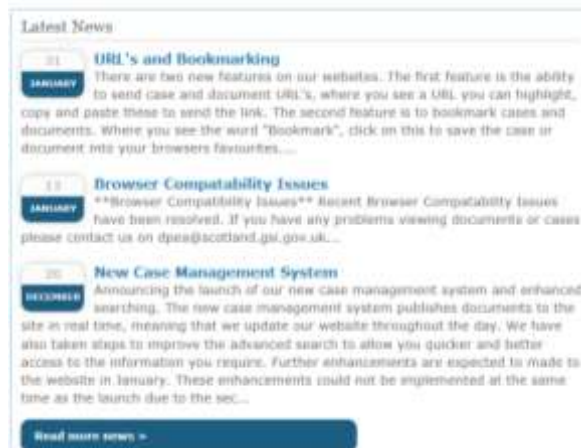
Search Functions for planning appeals and links to recent decisions and new cases.

A news section. This will be used for a number of reasons including to update users on website changes or current know issues and public holidays.



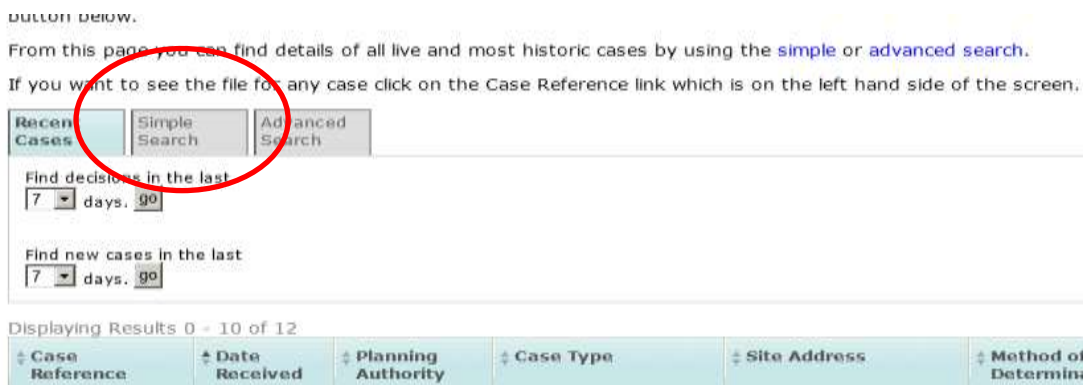
Simple Searching

The Public Website allows you to search for appeals that are and have been with the DPEA.

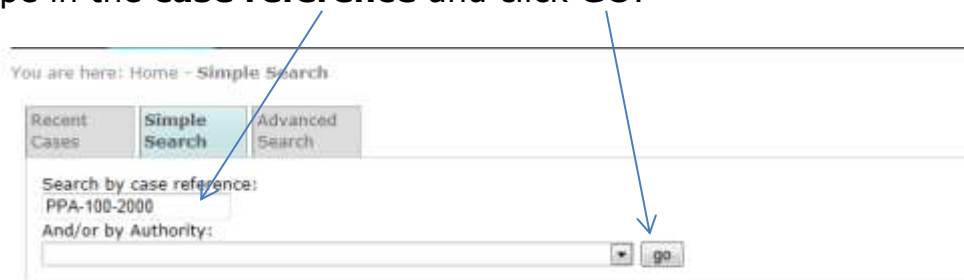
If you know the case reference of the appeal the simple search will be the best option for you locating the case on the DPEA Public Website. Click on **Search**, on the homepage.



This will bring up the Recent Decisions page, Click the **Simple Search** tab.

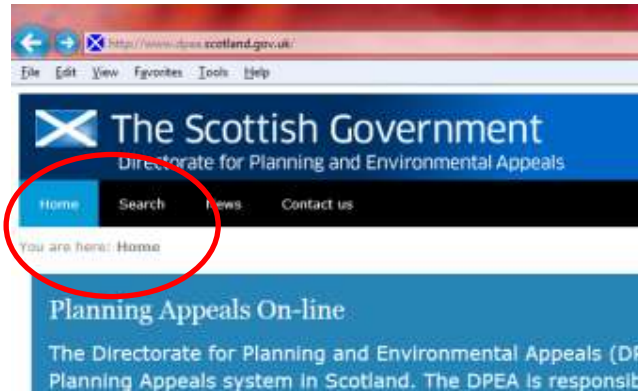


In the box type in the **case reference** and click **GO**.



Advanced Searching

The Public Website allows for an advanced search for specific cases to be carried out. From the homepage click **Search**.



This will bring up the Recent Decisions page, Click either of the **Advanced Search** buttons.

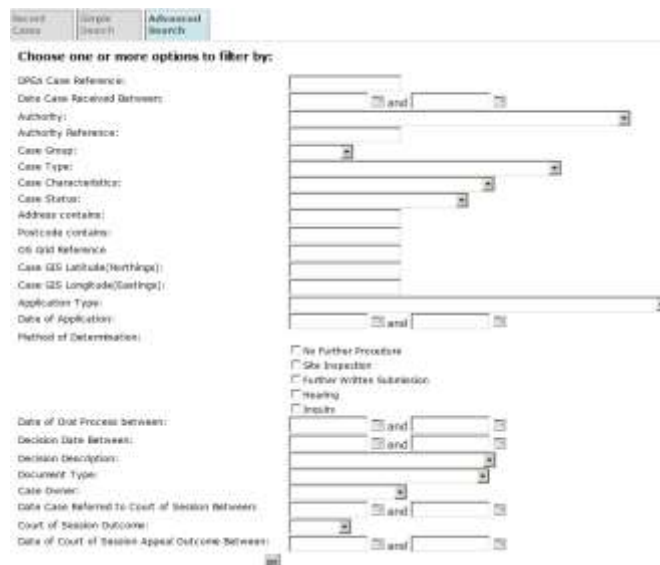

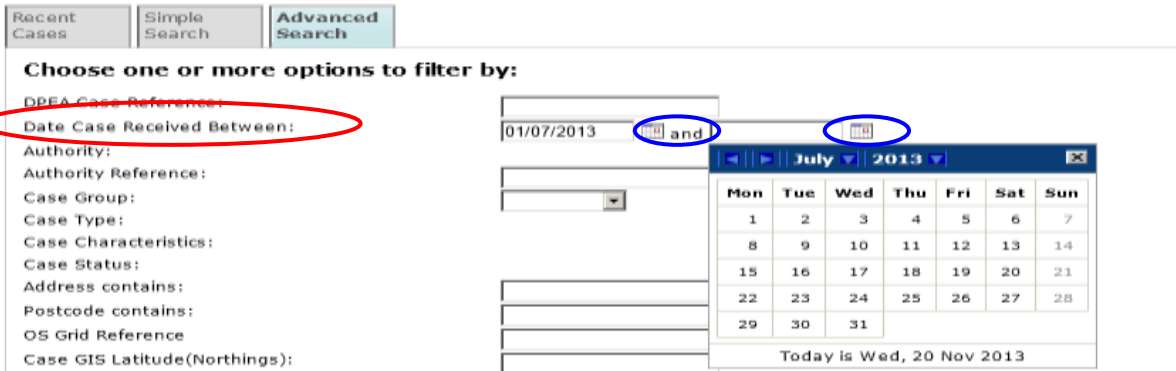


This will bring up the Advanced Search Screen. The detail the search goes into depends on the information entered. For example, if no data is entered then you will receive a list of every case available on the web. This Guidance will show how to search for Cases.



In this example, we are looking for a case involving a wind turbine in Aberdeenshire in July 2013. The only other information available is that a Site Inspection was carried out.

To build up the search, enter the known details, the more entered the more refined the search. Enter the **Date the Case was Received**, July 2013, by using the **Calendar** buttons. This will return all Cases Received by DPEA in July 2013.



To Select the **Authority**, Aberdeenshire Council, Click the **drop menu** and select the Authority. This will return all Cases Received in July 2013 from Aberdeenshire Council.



To select a **Case Characteristic**, in this case a single wind turbine, Click the **drop menu** and select the Case Characteristic.

This will return all single wind turbine cases from Aberdeenshire Council received in July 2013.



To select **Method of Determination**, in this case site inspection, tick the appropriate **box**. (To search multiple methods of determination, tick multiple boxes)

This will return all single wind turbine cases from Aberdeenshire Council received in July 2013 that were subject to site inspection.

Click **Go** to run the search, for the example case search this returns 3 cases. To view further details on the cases, click **the blue case reference on the left**. This will open the case and give access to in-depth case details and publically available documents.

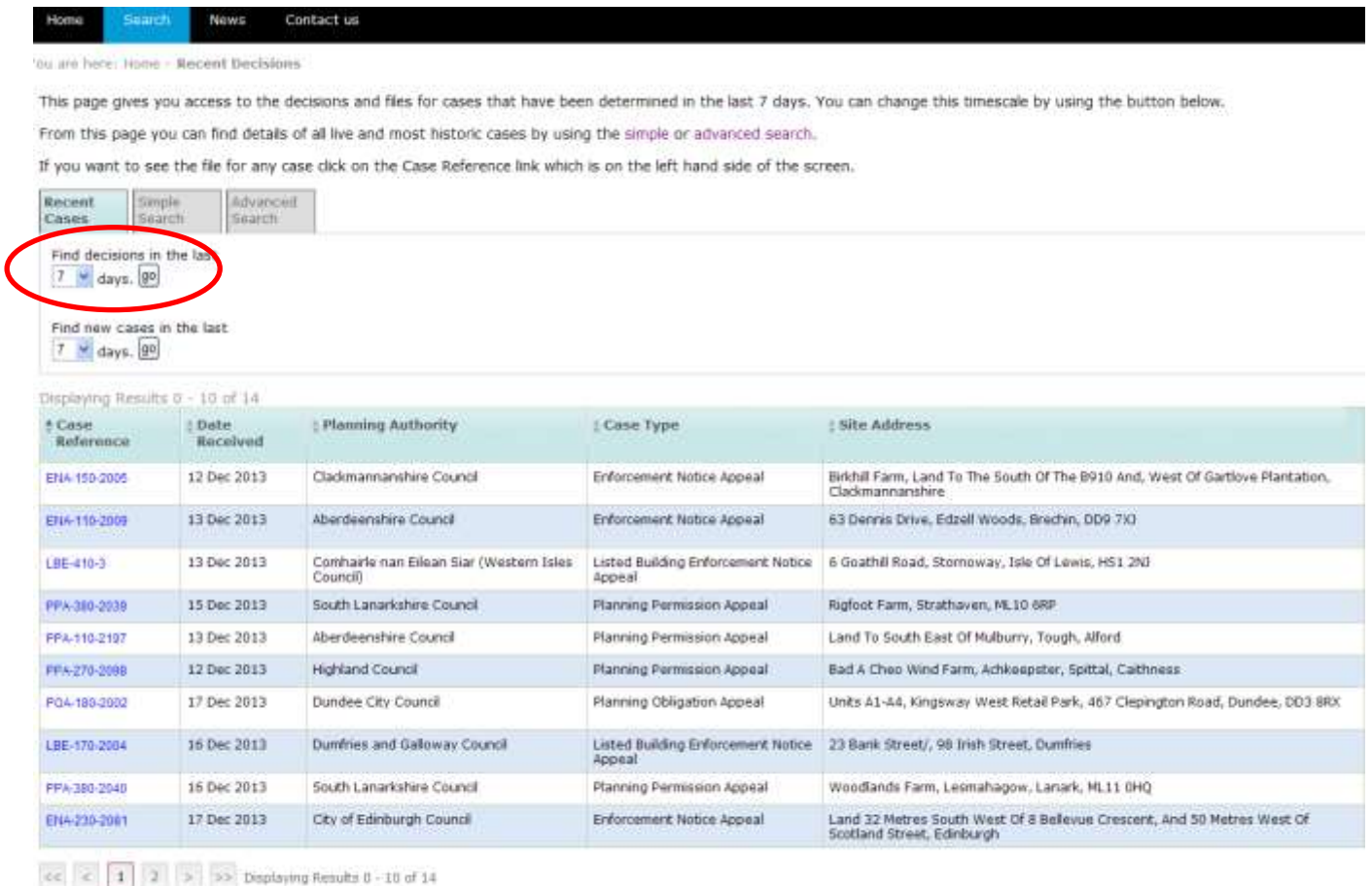

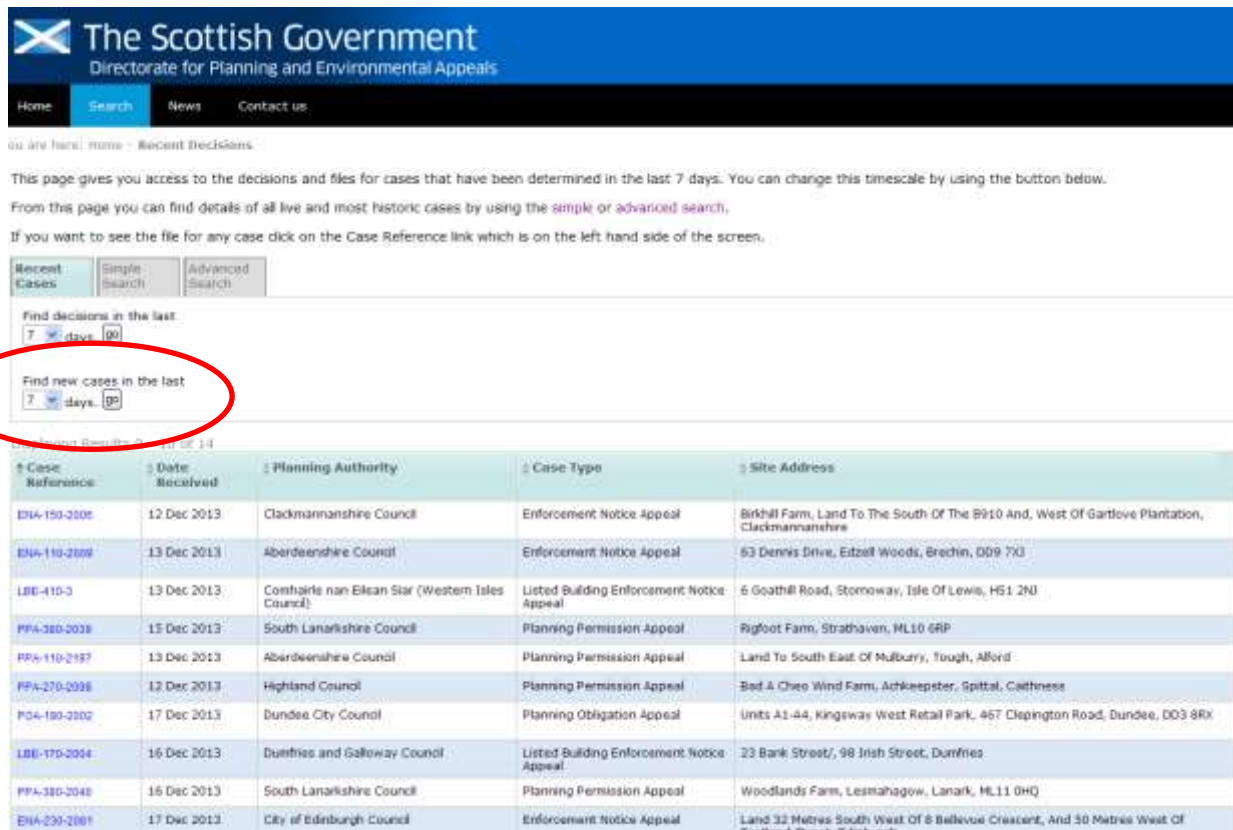

Searching Documents, within cases

Once in a case, you will see there is a way to search/filter the documents within it. The function sits at the bottom of each page of documents and searches all documents on the case, not just the page's documents.



It is a keyword search. To use it you need to select the button to the left of "Document" then choose whether you want to search only by document Name or within the Content of the documents by selecting the appropriate option in the dropdown to the right of "Document". You should then enter the word, or phrase, you wish to search on in the box after "contains" and click on the search button.

For example, this search is for all documents that contain the phrase "underground cabling"



It will not find documents that only have these words separately i.e. not as a phrase.

To clear a search, click on the "No document filter" button.

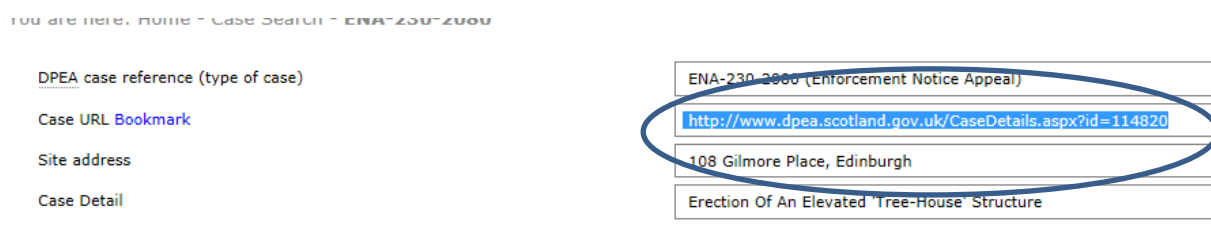

To send the case URL, highlight it and copy and paste it into your letter/e-mail etc.

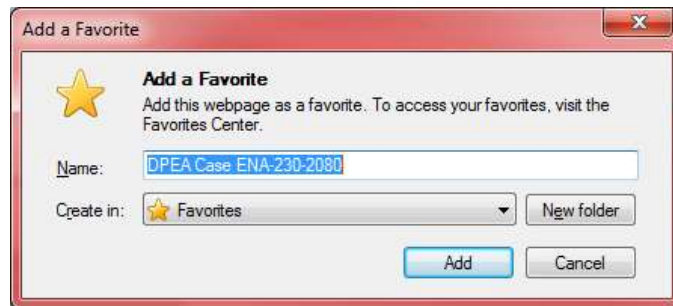


To create a bookmark for the case, Click **Bookmark**.


