The Delegation of Functions in relation to the Regional Marine Plan for the Scottish Marine Region for the Shetland Isles (Amendment) Direction 2022

Made: Coming into effect: June 2022 30th June 2022

The Scottish Ministers give the following Direction to Shetland UHI and Shetland Islands Council in exercise of the powers conferred by sections 12 and 13 of the Marine (Scotland) Act 2010(a) and all other powers enabling them to do so.

In accordance with section 12(4) of that Act, the Scottish Ministers have obtained the consent of Shetland Islands Council.

In accordance with section 13(1) of that Act, the Scottish Ministers will publish this Direction in such manner as they consider most likely to bring it to the attention of persons likely to be interested in or affected by it.

In accordance with paragraph 3 of the 2016 Direction, the Scottish Ministers have given notice in writing to the Shetland Fisheries Training Centre Trust.

Citation, commencement and interpretation

- 1.—(1) This Direction may be cited as the Delegation of Functions in relation to the Regional Marine Plan for the Scottish Marine Region for the Shetland Isles (Amendment) Direction 2022 and comes into effect on 30th June 2022.
- (2) In this Direction, "the 2016 Direction" means the Delegation of Functions in relation to the Regional Marine Plan for the Scottish Marine Region for the Shetland Isles Direction 2016(b).

Amendment of the Delegation of Functions in relation to the Regional Marine Plan for the Scottish Marine Region for the Shetland Isles Direction 2016

2. In paragraph 5(a) (Delegate) of the 2016 Direction, for "the Shetland Fisheries Training Centre Trust" substitute "Shetland UHI, a private company limited by guarantee registered in Scotland with company number SC646337 and having its registered office at Gremista Industrial Estate, Lerwick, Shetland, Scotland, ZE1 0PX and which is also a registered Scottish charity with charity number SC050701 and which has its principal office at Gremista, Lerwick, Shetland, ZE1 0PX".

Continuing Effect of the 2016 Direction and Saving

EXPLANATORY NOTE

This Direction amends the Delegation of Functions in relation to the Regional Marine Plan for the Scottish Marine Region for the Shetland Isles Direction 2016 (the 2016 Direction).

Paragraph 2 of this Direction amends paragraph 5(a) of the 2016 Direction by substituting Shetland UHI for the Shetland Fisheries Training Centre Trust. This is because, by virtue of an asset transfer agreement, the assets and liabilities of the Shetland Fisheries Training Centre Trust transferred to Shetland UHI on 1 August 2021.

In accordance with section 12(6)(a) of the Marine (Scotland) Act 2010, Shetland UHI must comply with the 2016 Direction as amended by this Direction.
