Waste Contingencies	1 April 2020	<p><u>Email Communication</u> <u>Scottish Government to Sector Forum Stakeholders, 01 April 2020</u></p> <p>Hi All,</p> <p>Thanks for your continued efforts to support our understanding of supply and demand of core PPE for frontline workers. I thought it would be helpful to draw together the material we have received so far and to summarise those areas where further information is required. <u>To note, our colleagues who are coordinating cross-sector supply chain efforts have asked that we provide answers to all outstanding questions by close, today. Apologies for the tight timescales involved.</u></p> <p>Turning first to hand sanitiser, colleagues have estimated that frontline workers will require approximately 800ml per month for the duration of the pandemic.</p>

		<p>Workers will require 100ml containers so they can carry product with them during their shifts. There seems to be scope to facilitate the refill of pocket-sized containers at a local level. SG colleagues who are coordinating cross-sector supply chain efforts are keen to quantify requirements in litres. In order to provide this, we need to estimate the number of workers who require access to sanitiser. We are also keen to understand the extent to which demand can be met through existing supplies and suppliers. I know that some colleagues have been successful in securing additional stock over the course of the last week but others are raising concerns that shortages are already being experienced.</p> <p>We are in a broadly similar position in relation to the availability of nitrite gloves. Again, feedback seems to suggest that staff will require 1 pair per day but we won't be able to quantify overall demand until we better understand the number of staff affected. While some colleagues have signalled a shortage in available gloves, it would be helpful to know how long current supplies are likely to last and whether anticipated pressures can be managed through local arrangements.</p> <p>So in summary, the immediate outstanding questions are:</p> <ul style="list-style-type: none"> • How many staff will require access to the above equipment? • What proportion of these supplies can be met through existing stock (measured in weeks)? • What proportion of these supplies can be accessed through local purchasing arrangements going forward? <p>Of course, very happy to discuss further when the Forum meets at 3pm.</p> <p>Regards</p>

All,

Thanks again for your involvement in yesterday's telephone meeting of the Waste and Resources Sector Forum. As **[Redacted]** mentioned on the call, I have been asked to co-ordinate a piece of work to better understand the demand which currently exists across the sector for both hand sanitiser and other forms of core personal protective equipment used in the course of normal duties. Developing a better understanding of the quantities required of such materials will allow us to progress discussions with others elsewhere in the Scottish Government about how we might best meet demand. As outlined yesterday, we continue to progress discussions about the range and nature of health and safety measures to be adopted by waste management workers delivering services over the coming period.

[Redacted] – Do you feel you would be in a position to support us in understanding the demand which currently exists in the commercial sector?

[Redacted] – Would one of you be happy to support us in quantifying the 'ask' across local government?

The key questions we are looking to answer at this point are as follows:

- What is the current unmet demand for hand sanitiser across waste services within (i) local government and (ii) the commercial sector, measured in litres?
- What is future demand likely to look like on a per month basis, again measured in litres?
- How much, if any, of this future demand will individual services be able to fulfil through readily available supply arrangements?
- How many staff will require access to sanitiser?
- What size of hand sanitiser unit/container is optimal for waste management staff to support them in undertaking their duties?

		<ul style="list-style-type: none"> • What other forms of core personal protective equipment (i.e. that used in the course of normal duties) are expected to be in high demand and in what quantities? <p>While there is no firm deadline for concluding this work, there is collective recognition of the need to make swift progress. I'd appreciate your thoughts on what a realistic timetable for completing the analysis might be.</p> <p>We will probably also wish to agree a process through which we can monitor demand for these supplies for the duration of the pandemic. There may be scope to consider this as part of the wider monitoring of service capacity and demand which we discussed yesterday afternoon?</p> <p>[Redacted] – it would be good to have your input into this exercise. No current issues but anticipated increase in public demand for face coverings coupled with increased industry requirements at peak harvest time may cause pressure on supply. 1. MAGB (**[Redacted]**) – brewing mainly suppressed particularly the craft sector, we should recognise this too not just distilling. Volumes are beginning to pick up, mainly due to hopes that some pubs opening end of this month in England, exports are a small part of trade. All malting companies operating did not find it difficult to follow guidelines. Forthcoming harvest presents more challenges with labs being busier etc, all audits are remote with paperless transfers. PPE not been a problem to date but concern there may be a bigger demand for it and worried general public will strip supplies. Concerns for future demand on haulage. Storage a concern too. Working on different solutions. Going forward, as most companies work in both Scotland and England there is concern about working between the two with different rules in place.

Further extension to driver hours would be useful as has been allowed so far during COVID. Want more help with PPE from Scot gov but realise there is some help being offered there.

Previous Meeting Actions [new actions in red]

2.1 NFUS had anecdotal reports of some members struggling to secure bedding, shavings and PPE [Action: NFUS to liaise further with **[Redacted]**]

- NFUS reported that there were issues reported at a round table call this morning with securing bedding/ sawdust, including in the poultry and cattle sectors.
- Animal Health and Welfare has been working with Food and Drink Division to take these issues forward. Production and availability of bedding/ sawdust is being taken forward on a GB wide basis.
- On PPE, industry and Animal Health and Welfare Division have been pulling together a spreadsheet of PPE equipment shortages. This has been fed into the SG Procurement Centre. There is now a contractor in place to supply non health PPE equipment.
- A request was made that industry continue to utilise existing supply routes where possible. The SG scheme is not a replacement for existing supply chains and there is no guarantee that you will get the equipment requested, but it is hoped this will address some shortages. Please get in touch with **[Redacted]** if you would like to discuss further.
- NFUS queried when the PPE contact access list will be agreed. SG confirmed that the list has already been agreed and we await official guidance from the centre on next steps.

3.2 APHA Update

- TB testing is going well and there are relatively few delays due to COVID. No current concerns regarding fallen stock/ reasonable uplift times despite there being staff shortages. There are also currently no significant concerns regarding PPE supplies with the fallen stock collectors in Scotland.
- From joint GB discussions APHA has become aware that some abattoirs taking TB cattle are running low on PPE south of the border. This is being considered at GB level.

4. Science and Research

- SRUC outlined that they have been submitted bids to fund various bits of Covid work to help the farming community, and are engaged in applied research with NFUS. SRUC are involved in testing PPE kit for the NHS.
