Following my correspondence of 9 March, I have attached written updates relating to the priority areas identified by the Poverty and Inequality Commission to facilitate scrutiny of efforts to tackle child poverty in 2019-20.

As you know, the events of recent months and the escalation of the country wide response to the Covid-19 pandemic has meant considerable changes for all of us. I am therefore grateful of your understanding in postponing this scrutiny, allowing officials to focus on the government's response to this crisis.

The situation continues to develop and as such we must all be innovative and agile in our response. This means that timescales for certain work, including the 2019-20 Progress Report, may need to be revised at short notice as issues emerge. Should any further changes or delays be required, then I would be grateful if you could keep officials informed – my officials will do the same.

The pandemic has also meant that changes to our proposed delivery of key support has been subject to delay, and as we progress out of lockdown and into recovery phase, I am aware that delivery may need strengthened or revised in its entirety to ensure we actively respond to emerging need.

As a government we will continue to monitor the situation and to do our absolute utmost for the people and communities we collectively serve and in particular those that are most vulnerable who need to know their government is there for them in words and actions.

Tackling child poverty is and continues to be a priority for us all, and in times of crisis the need to tackle child poverty comes into ever sharper focus.

DELAY OF 2019-20 CHILD POVERTY PROGRESS REPORT

Purpose

1. To seek your approval for a Government Initiated Question (GIQ) to notify the Scottish Parliament of delays to the publication of the “2019-20 Second Annual Progress Report on Child Poverty”.

Priority

2. Routine

Background

3. As per my submission of 16 April 2020, the annual progress report on child poverty, covering the period 2019-20, is required to be published by the end of June 2020. To fully comply with the requirements of the Child Poverty (Scotland) Act 2017, in preparing the report Scottish Ministers must consult the Poverty and Inequality Commission – the information to enable this scrutiny is awaiting final clearance before issued.

4. Given the unprecedented impact of Coronavirus officials across SG have been redeployed to focus on the response to the virus. This includes officials within the Social Justice Strategy Unit who have been working on the £350 million package of communities funding, including delivery of priority funding for national partners and food funding, and the support offer for individuals who are Non-Shielded at Risk.

5. The Coronavirus (Scotland) Act 2020 accounts for redeployment of this nature and provides for the delay of compliance with reporting duties. The Act outlines the criteria for doing so:

“The Scottish Ministers or the Scottish public authority may decide to postpone complying with the duty if they or, as the case may be, it are of the view that complying would be likely to impede their or, as the case may be, its ability to take effective action to prevent, protect against, delay or otherwise control the incidence or transmission of coronavirus”

6. This advice is provided as per your indication of 5 May that you are content to delay the progress report on this basis.

GIQ Text

7. The below draft GIQ has been prepared, and Special Advisors have nominated Bob Doris to log the question:

Question: To ask the Scottish Government by what date the second annual progress report on child poverty will be published.

Answer: Due to the unprecedented impact of Coronavirus we have made the difficult decision to delay preparation and publication of the 2019-20 Progress Report on Child Poverty, which was required by end June 2020.

This has allowed officials to focus efforts on protecting communities from the impacts of the virus in line with the powers provided by the Coronavirus (Scotland) Act 2020.

We will consult with the Poverty and Inequality Commission in relation to progress made and the further progress required, ensuring they have the time they need to consider this request.

Tackling child poverty remains an absolute priority and we are committed to publishing the report as soon as reasonably practicable in the circumstances.

Timing for GIQ

8. The Coronavirus (Scotland) Act outlines that the notification to delay should be provided before the date the report is due, or as soon as possible afterwards. Special Advisors have indicated the GIQ should be published immediately, or following the SG led debate on 9 June 2020.

Recommendation

9. You are invited to approve, if content, the draft GIQ.


