### Dear Chief Executive,

- 1. AGGREGATE EXTERNAL FINANCE FOR 2002-03
- 2. REDETERMINATION OF REVENUE SUPPORT GRANT FOR 2001-02
- 1. The Local Government Finance (Scotland) (No 2) Order 2002 was debated and approved by the Scottish Parliament on 20 June. This Circular provides authorities with a summary of the figures contained in that Order.

## Aggregate External Finance 2002-03

- 2. Finance Circular 1/2002, issued on 21 February 2002, covered Scottish Ministers' original distribution of AEF for 2002-03. Subsequent revisions were notified to you in Nikki Brown's letter of 30 May. The resulting allocations were approved by Parliament on 20 June 2002, and are shown in Annex A to this circular. Annex B summarises the breakdown of total AEF for 2002-03 and replaces Annex B to Circular 1/2002.
- 3. Annex C confirms the individual distributions as detailed in Nikki Brown's letter of the 30 May.

#### Additional Allocations 2002-03

4. Discussions are still on-going between the Scottish Executive and COSLA about the allocation of additional funding for 2002-03 for the fire pensions. We will confirm the allocations for individual authorities in due course.

#### Redetermination of RSG for 2001-02

5. The Local Government Finance Order also redetermined RSG for 2001-02 to take account of resources that are no longer required to support the PPP project for which they were set aside

- 6. Annex D summarises the adjustments that will be made to RSG/NDRI payments profiles for 3 July as a result of the redetermination of RSG for 2001-02, backdated Care Home Fees for 2001-02 and the new monies for present year. Revised payment profiles for 2002-03 will be sent to councils shortly.
