Introduction

The 2017 Technical Handbooks are being published on 1 July 2017. There are a number of changes being made including the introduction in Section 0, General of a new building type for detached single-storey buildings used for shelter or sleeping in connection with recreation. Changes in Section 2, Fire on Independent schemes of certification and accreditation and changes in Section 5, Noise to include 'Robust Details Scotland'. A number of minor corrections and updating website hyperlinks have also been made.

The guidance comes into force on 1st July 2017.

The handbooks are available, free of charge, in electronic format only. They can be viewed or downloaded from the BSD website at – www.gov.scot/bsd.

This summary guide is set out to facilitate ease of referencing across the Sections where material changes have been made. Minor typographical changes are outwith the scope of this document.
