#### 4. Framework period

The Framework start date was 1 April 2024, for an initial period of three years, meaning the current end date is 31 March 2027.

There is an option to extend for a further 12 months, meaning the maximum end date will be 31 March 2028.

## 5. Entitlement to use the Scottish Procurement Water and Waste Water Billing Services Framework

It is the responsibility of any buying organisation wishing to use the Framework agreement to satisfy itself that it is eligible to do so. Entitlement can be established from the Public Contracts Scotland (PCS) advert issued at the start of the Framework procurement process, if there is any doubt on eligibility, legal advice should be sought.

#### PCS: View Notice - Public Contracts Scotland

The Framework Agreement will be available for use by the Scottish Ministers (including Agencies), Scottish Non-Departmental Public Bodies, offices in the Scottish Administration which are not ministerial offices, cross- border public authorities within the meaning of section 88(5) of the Scotland Act 1998, the Scotland Office, the Scotlish Parliamentary Corporate Body, councils constituted under section 2 of the Local Government etc. (Scotland) Act 1994, Scottish Fire & Rescue Service, the Scottish Police Authority, Scottish health boards or special health boards, all NHS Scotland, The Integrated Joint Boards established further to the Public Bodies (Joint Working) Act 2014. bodies registered as social landlords under the Housing (Scotland) Act 2001, Student Loans Company Limited, the Commissioner of Northern Lighthouse operating as the Northern Lighthouse Board, Equality and Human Rights Commission, Business Stream Ltd, the Business Gateway National Unit at the Convention of Scottish Local Authorities, further or higher education institutions being fundable bodies within the meaning of section 6 of the further and Higher Education (Scotland) Act 2005, any public body established by or under the Scotland Act 1998 or any Act of the Scotlish Parliament, any association of or formed by one or more of the foregoing, bodies financed wholly or mainly by one or more of the foregoing, bodies subject to management supervision by one or more of the foregoing and bodies more than half of the board of directors or members of which, or, in the case of a group of individuals, more than half of those individuals, being appointed by one or more of the foregoing. In addition to the contracting authorities listed, the framework agreement will be available to charities entered on the Scottish Charity Register, voluntary organisations entered on the Membership Database of the Scottish Council for Voluntary Organisations and departments of UK Government facilities operating in Scotland.

#### 6. Framework benefits

- annual cost avoidance savings for the duration of the framework;
- **automated meter reading** (AMR) offering: free AMR loggers on 30mm 40mm & 50mm with 15% discount on 20mm and smaller & 10% discount for 25mm;
- **dedicated customer service** team and account management;
- **emergency planning** service for sensitive sites. Emergency planning also available for non-sensitive sites as an ancillary service;
- Improved discounts for the two different options for advanced payments;
- Free leak detection surveys To encourage the prompt detection and rectification of leaks, 100 days of free on-site leak detection surveys across the Framework term;
- Online Discounts 10% discount when using the 'Business Stream' online shop where customers can buy water devices such as water efficient taps and shower heads;

• Water Efficiency Fund – a fund offered by 'Business Stream' for framework customers to fund water efficiency initiatives suggested by framework customers, over the framework term

#### Climate emergency

- **intelligent water management** programme for reducing water usage with associated reduction in CO2 emissions. This can include leak detection, investigation and site survey
- water efficiency advice and case studies in monthly e-newsletter
- 'Business Stream' are now officially a fully carbon neutral company after being awarded 'Gold' status by 'Ecovadis' (a global provider of sustainability assessments and ratings). - Schools Outreach Deliver eight in person/virtual classroom sessions annually to educate school children on the importance of saving water and create a water-saving education pack to be distributed electronically to all Scottish primary schools.

### 7. Pricing

The framework tariff is published annually and is aligned to the contract year, 1 April – 31 March.

The framework tariff consists of the Scottish Water wholesale rates and the supplier's margins.

The Scottish Water wholesale rates are subject to annual price rises in line with the Scottish Water Wholesale Determination. Rates of increase to apply for particular Wholesale Determination periods are set to ensure sufficient funding to maintain/develop infrastructure during that period. The next Wholesale Determination period is due to last from 2024-2028.

#### 8. How to sign up to the Water and Waste Water Billing Services Framework

To join the Supply of Water and Waste Water Billing Services Framework, the first step is to complete an Agency Agreement. This Agreement allows Scottish Procurement to sign a supply agreement with Business Stream on your behalf. The Agency Agreement is available on request from Scottish Procurement: <u>stephen.ogilvie@gov.scot</u>

Instructions will be provided on how to complete the Agency Agreement, once we have the signed agreement, we will arrange for Business Stream to contact you to collect details of your sites and arrange transfer. Business Stream will provide full support and advice with this process.

Once signed up to the Framework you will be obliged to give 3 months notice should you want to leave the Water and Waste Water Billing Services Framework at any point.
