## **Police Negotiating Board for Scotland Agreement**

1. The Official and Staff Sides of the Police Negotiating Board for Scotland have reached agreement on pay with effect from 1 April 2023. Details are set out in the attached memorandum.

## **Memorandum**

The Official and Staff Sides of the PNBS have reached agreement on a pay award for police officers, as set out in PNBS circular 2023/01, the revised rates for allowances are as follows:

### **Additional Disruption Allowance**

With effect from 1 April 2023 the Additional Disruption Allowance is set at £48.34.

### **Dog Handlers Allowance**

With effect from 1 April 2023 the Dog Handlers Allowance is set at £2,708.61.

### **Excessive Rest Day Disruption Allowance**

With effect from 1 April 2023 the Excessive Rest Day Disruption Allowance is set at £22.96.

### **Minimum Standards Allowance**

With effect from 1 April 2023 the Minimum Standards Allowance is set at £108.77.

### **On-call Allowance**

With effect from 1 April 2023 the On-call Allowance is set at £28.92.

### **Overnight Disruption Allowance**

With effect from 1 April 2023 the Overnight Disruption Allowance is set at £72.51.

### **Plain Clothes Allowance**

With effect from 1 April 2023 the Plain Clothes Allowance is set at £16.34.
