The Bill should be rejected in its entirety as the consultation paper (section 2.13) states our current legislation fully meets European law and there is no requirement for it to be reformed. There is absolutely no justification for allowing someone to switch the sex on their birth certificate without a medical diagnosis of gender dysphoria. Only people with this rare medical condition and who have been through a sincere, professionally monitored medical process should continue to have this right.

The Government has failed to take into account the consequences of changing the meaning of 'man' and 'woman' from a biological definition to one based on a self-

declared feeling. There is plenty of evidence that taking this stance has already been detrimental to women's and children's rights.

Many women like us are old enough to remember when there were no women's sports, and it was legal to sack a woman due to pregnancy. Two women a week are being killed in this country by men. Women are a distinct sex class. Already the lines are being blurred and transwomen are being sent to women's prisons. [REDACTED] highlights exactly how vulnerable women are in prison. They should not be locked up with male rapists. It is a disgrace that women are still thought of as second class citizens that their rights are being shoved aside for the rights of a tiny minority of people.

Why should our girls have their privacy and dignity removed in toilets and changing rooms to make way for the feelings of boy and men that feel like a woman. Women and girls have the right in law to have privacy in changing room and sleeping accommodation. If any man can self-id as a woman, then the Equality Act is useless and women's rights will have gone.
