# Part 1: About this Consultation

# Purpose

The purpose of this consultation is to seek views from individuals and companies including Professional Operators (seed merchants, seed processors, seed packers), Licensed Crop Inspectors, Licensed Seed Samplers, Licensed Seed Testing Stations (LSTS), farmers and interested members of the public on the Scottish Government's proposal to:

• Amend fees for seed certification, seed testing & associated seed functions to allow full cost recovery

Any amendments to the fees will become effective from 1 July 2020.

# Background

The Scottish Government has five Scottish Statutory instruments which legislate for the marketing of agricultural seed crops:

- The Beet Seed (Scotland) (No 2) Regulations 2010
- The Cereal Seed (Scotland) Regulations 2005
- The Fodder Plant Seed (Scotland) Regulations 2005
- The Oil & Fibre Plant Seed (Scotland) Regulations 2004
- The Vegetable Seed Regulations 1993

Within Scottish Government, SASA and the Rural Payments Inspection Directorate (RPID) have responsibility for carrying out the technical and administrative work associated with seed certification including field inspection of crops, testing of seed and the training and examination of people who undertake these activities.

Scottish Government's policy objective is that the fees set for public services should be full cost recovery, to avoid unnecessary public expenditure. SASA are the Seed Certifying Authority for Scotland and they review the fees for seed testing, seed certification and associated functions annually to ensure that costs incurred, are met by those businesses which benefit directly from the services provided.

# Scope of Consultation

The proposals set out in this consultation apply only to Scotland.

# **Costs and Fees**

<u>Seed Lot Fees</u> – These fees relate to issuing an Official Certificate or a Breeders Confirmation in respect of a seed lot, certifying the seed to be -

- (1) of a Multiplication category
- (2) of a final generation category

The specific nature of these costs entail documentation processing relating to seed lot applications, preparation and the issuing of official certificates along with invoicing costs. The total costs incurred for these services operated by the Certifying Authority, Scotland was £74,515.14, compared to the total cost recovered of £70,577.60. This resulted in a 94.7% recovery.

<u>**Crop Entry Costs</u>** – This includes fees per hectare for entering a seed crop into the certification scheme in Scotland, late application fees applicable in addition to crop entry fees.</u>

- (1) Pre basic or Basic seed
- (2) Certified Seed, Certified Seed of 1st Generation, 2nd Generation or 3<sup>rd</sup> Generation.

The costing for this area includes documentation processing relating to crop entries, preparation and issue of inspection results, invoicing and Certification Plot Control costs. The total expenditure was £102,949.32, while the total income received was £98,515.19, resulting in a recovery of 95.7%.

As a result of this shortfall and keeping in line with the Scottish Governments policy of achieving full cost recovery, fees for seed certification, it is proposed to increase in fees by 5%.

<u>Seed Testing Fees</u> - The Official Seed Testing Station (OSTS) is the principle centre for seed testing and seed quality information in Scotland. The OSTS Scotland offers a wide range of laboratory tests that provide practical and reliable information for the seed industry:

- (1) Certification tests (analytical purity, determination of other seeds by number, germination/STZ, moisture and disease tests if required);
- (2) HVS Verification;
- (3) Testing of seed for non-statutory purposes;
- (4) Training and examination of Seed Analysts and Laboratory Managers and;
- (5) Provision of International Certificates.

In a wet harvest, as in 2019, seed quality can be lowered (e.g. poor germination and higher disease). These samples are more difficult to assess and take longer for seed analysts to complete, therefore increasing the amount of staff time taken to conclude

these tests. To meet the Scottish Governments objective of achieving full cost recovery for seed testing fees, it is recommended that an increase of 8% would be required.

**Licensed Seed Testing Station** - The licence fee is levied annually and covers the cost of the official supervision provided by the OSTS to undertake the following functions:

- (1) An inspection of the laboratory, the storage areas and equipment to ensure everything meets a satisfactory level for seed testing;
- (2) The Analyst in Charge of the LSTS is suitably qualified;
- (3) Other analysts have passed official examinations and maintain their competency;
- (4) Official records are correctly maintained.

The OSTS, Scotland introduced a new supervision method for LSTS's in 2018. Supervisory visit now take place once year rather than bi-annually, however the proportion of LSTS tested certification samples required for retesting and checking by the OSTS are requested at more frequent intervals. (fortnightly.) These efficiencies still allow for effective monitoring, but at a reduced cost. As a result of these new procedures and the savings made, it is recommended that the reduced overheads are passed on to the LSTS's and a 9% reduction in the fee is proposed (reduced to £1547) to prevent any over recovery of fees by Scottish Government.

# **Options for consideration**

**Option 1**: Maintain the status quo – all fees remain at current level

This option would mean no fee increase, but this is likely to leave the Scottish taxpayer having to subsidise the seed industry using these services. As a result, this would not comply with the Scottish Government approach to setting charges for public services. Scottish Government would not achieve full cost recovery and would incur a deficit for the services provided to the seed industry.

#### **Option 2:**

Full cost recovery for all services provided to the seed industry by Scottish Government. This would result in:

- An increase for seed certification and associated licensed activities fees by 5%;
- > An increase in all seed testing fees by 8%;
- > A reduction of Licensed Seed Testing Stations fee by 9%;
- > To maintain all cost associated with Seed Testing Course at present level.

Option 2 is Scottish Government's preference, as it allows for full cost recovery of all services provided.

Scottish Government welcomes your views on the above options.


# Part II- Background to Services Provided by Scottish Government and Licensed Individuals/Companies

### Introduction

Crop certification schemes exist to protect farmers buying seed that has no identity. The scheme ensures that the product they receive meets certain quality standards. The current UK Cereal Scheme incorporates several quality control mechanisms, including official testing to ensure seed meets prescribed standards for germination, freedom from weeds, has varietal identity and purity, and has undergone a crop inspection.

SASA are a division of the Agriculture and Rural Economy Directorate, within Scottish Government, act on behalf of Scottish Ministers as the Certifying Authority for Scotland. Responsible for the certification of beet, cereal, fodder, oil & fibre and vegetable seed, they are situated at Roddinglaw, just to the west of Edinburgh.

All agricultural seeds subject to the regulations (except vegetables, which can be sold as Standard Seed) have to be officially certified and can only be sold in labelled containers which preserve the integrity of the seed inside. The certification process requires that the seed be tested to ensure that it meets all the standards that apply to it. Some of these tests are made on the crop and some are made on the harvested seed. The majority of crops certified in Scotland are cereals. Table 1 below provides the most popular species and number of crop applications in Scotland over the last 3 years, while Table 2 shows other application over on average over a 3 year period.



# Seed Certification

Scottish Government has overall responsibility for seed certification in Scotland, but there are various functions within the process which can be carried out either by Government Officials or licensed individuals or companies. Scottish Government will license individuals to undertake crop inspections, seed sampling and/or seed testing if that person can demonstrate their knowledge and expertise. In addition Scottish Government will supervise and check at least 5% of the work carried out under licence. It is mandatory that those who wish to market, process, package or test seed must have the necessary qualified personnel, equipment and premises to carry out this work.

#### Certified Seed in Scotland in 2018/2019

In the 2018/19 season 53,828 tonnes of cereals were certified in Scotland. There has been a drop of approximately 4000 tonnes on the previous year. Table 2 Below shows the total area of Crops grown in Scotland (Ha) over the last 3 years.

# Seed Testing

The OSTS Scotland and five LSTS undertake the testing of seed intended for certification. As well as seed testing, the OSTS Scotland provides supervision of the licensed seed testing stations, and provide the training and examination of new and existing seed Analysts & Laboratory Managers. In this way, the high quality of Scottish certified seed is maintained.

#### Licensed Seed Testing Stations (LSTS)

There are currently 5 Licensed Seed Testing Stations (LSTS) in Scotland. The staff undertaking the testing are all trained and examined at a UK level. Individuals can sit a number of seed divisions, which cover various agricultural and horticultural species. The OSTS check the proficiency of the individual seed analysts throughout the year using proficiency tests and check testing. A minimum of 5% of seed will be selected at random, tested by the OSTS, and the LSTS & OSTS results compared.

### **MySeeds**

Since the introduction of MySeeds the uptake in those submitting application through the electronic system continues to grow in both seed crop and seed lot applications as shown in Table 3 below.

# Licensed Professional Operators (Seed Merchants, Seed Processors and or Seed Packers)

Once a company or individual licenced with the Certifying Authority as a seed merchant, seed processor and / or seed packer, Scottish Government must ensure that the seed sold, processed or packaged by them:

- 'is what it says it is, on the label' certified seed of a registered variety, that meets standards listed in Schedule 4 of each of the Scottish marketing regulations;
- is correctly packaged, labelled and sealed and;
- has the appropriate documentation that forms an audit trial.

RPID staff must routinely visit registered premises where seed is being stored in a warehouse or being processed/packaged, to ensure compliance with the licencing and marketing regulations. Where the individual / company acts solely as a seed merchant, buying and selling, but is never in physical possession of the seed, only a check of records is required to satisfy the licencing conditions.

#### **Courses and Exams**

In order to undertake any of the above licensed functions, Scottish Government provide training and refresher courses at SASA. Courses and exams are run on an annual basis, with licensed crop inspectors and seed samplers returning every five years to be re-examined.

# Partial Business & Regulatory Impact Assessment

# PURPOSE AND INTENDED EFFECT

#### Background

Under current legislation, Scotland is obliged to implement seed regulations which comply with the marketing of certain species of seeds. Seed lots can only be marketed following analysis (official or under official supervision by licensed individuals), and certification that the seed meets the specific minimum seed quality standards for growers. This process ensures that farmers and growers receive seed of a minimum known quality.

#### Objective

In their role as an official service provider / supervisor for seeds marketing, Scottish Government has an obligation to ensure full cost recovery for all the services it provides, which includes field inspection of crops, testing of seed and the training and examination of people who undertake these activities. Within the Scottish Government, the Certification Authority part of SASA, take lead responsible for the technical and administrative work associated with seed certification.

#### Rationale for Government intervention

This work contributes to the Scottish Government's Wealthier and Fairer strategic objective by creating a high quality public service. Essentially, failing to make full cost recovery means, the Scottish tax payers subsidising services that should be covered by the industry using it. Currently we review fees for seed testing, seed certification and associated functions annually, this allows fees to be met by those businesses which benefit from them directly and not the taxpayer.

# CONSULTATION

#### Within Government

Scottish Government's policy team have consulted with the Certifying Authority, who working closely with RPID and the Official Seed Testing Station (OSTS) for Scotland, have reviewed the processes and procedures to provide the information contained within this Partial BRIA. The Certifying Authority have provided the costings for undertaking this work, and predicted the fees associated with seed testing, seed certification and other associated functions required to make full cost recovery in 2020/2021.

#### **Public Consultation**

This partial BRIA will accompany the 12 week consultation which will be issued on the 12 February 2020. The consultation documents will be sent electronically and by post to all interested parties registered with Scottish Government (~100 businesses /individuals). An electronic copy will also be placed on the Scottish Government and SASA websites. No informal consultation has taken place.

#### Business

In addition to this, in line with Scottish Governments Better Regulation practises, around 10 to 12 individuals / companies will be interviewed, in order for Scottish Government to establish what these proposed changes will mean to their business.

### FEE STRUCTURE OPTIONS

To accomplish the stated aim of introducing a full cost recovery regime for the seed certification, seed testing and associated functions, we have considered the following options:

#### 1. Maintain the status quo, no increases in fees.

No change, will not achieve full cost recovery and any deficits will continue to rise. To avoid unnecessary public expenditure it is Scottish Government policy to set fees for these services that should meet full cost recover.

#### 2. Increase fees to achieve full cost recovery in financial year 2020.

This option would achieve the Scottish Government's objectives to recover the full cost of the service. Fees would increase so that those who benefit from the service would be required to meet the true costs of providing a Scottish seed certification scheme.

The OSTS, RPID and the Seed Certification branch at SASA have conducted their annual review of the services they provide and have identified that costs are not being fully recovered in some areas. Seed testing fees vary due to staff costs, seed quality, and the seed testing season. In a wet harvest such as 2019, seed quality can be lowered (e.g. poor germination). These samples are more difficult to assess and take longer for seed analysts to complete, therefore, increasing the amount of staff time taken to conclude these tests. To take account of the rise in costs for seed testing, it is necessary to increase seed testing fees by 8%.

The fee charged to licence a Seed Testing Station (LSTS) covers the cost of the official supervision provided by the OSTS, which includes a check of their premises, stores, records and equipment. A new method of supervision for checking the samples tested by the LSTS was introduced in 2018, with only one visit now taking place instead of two. Reserve portions (check samples) are now requested fortnightly by the OSTS. These efficiencies still allow for effective monitoring at a reduced cost. As a result of the savings being made by the OSTS, it is recommended these savings are passed on to the LSTS, and the fee is proposed to be reduced by 9%.

Fees for certification, the training and examining licensed persons from the seed industry require to be increased by 5% to maintain full cost recover. The use of the online application system continues to increase with over 90% of the seed industry now using it.

#### **Preferred Option**

Option 2 is preferred by the Scottish Government.

To be in line with Scottish Governments policy of meeting full cost recover, the following changes would need to be made to the fees associated with seed testing, seed certification and other associated functions to meet this objective

- An increase for seed certification and associated licensed activities fees by 5%;
- An increase all seed testing fees by 8%;
- A reduction of Licensed Seed Testing Stations fee by 9%;
- To maintain all cost associated with Seed Testing Course at present level.

#### Sectors and groups affected

- Professional Seed Operators
  - Seed Merchants
  - Seed Processors
  - Seed Packers
- Licensed Seed Testing Stations (LSTS)
- Licensed Seed Samplers
- Licensed Crop inspectors
- Farmers

Based on the information we hold, we have provided an estimate of costs that an 8% increase in seed testing fees and 5% increase for all other seed certification service will have on a 30 tonne seed lot of cereal and a 10 tonne seed lot of Timothy online application is attached in **(Annex A)** 

# SCOTTISH FIRMS IMPACT TEST

To obtain a better understanding of what these proposed increases will mean for Scottish individuals / companies, Scottish Government will need to speak to a cross section of the seed industry. Interviews will take place during March/April, and our findings will be summarised in the Final BRIA, which will be published along with a summary of the responses we receive.

<u>Competition Assessment</u>: We do not anticipate any impact on competition. However we will update this section after interviews with industry.

<u>Test run of business forms</u>: No new forms for business to fill in will be introduced as a result of our proposals.

# LEGAL AID IMPACT TEST

Having consulted with the Legal Aid Team, we do not anticipate that the contents of this BRIA will impact the Legal Aid Fund.

# **ENFORCEMENT, SANCTIONS AND MONITORING**

The Scottish Government Accounting System (SEAS) team, the Certifying Authority & the OSTS Scotland all work together to insure invoices are issued timeously. The normal action for non-paid invoices is used by the SEAS team for any statutory services not paid for by an individual or company after the time allotted.

Non-compliance result in companies or individuals being put on a client blacklist. Failure to pay for a service means no further work is carried out by the Certifying Authority or by the OSTS.

### **IMPLEMENTATION AND DELIVERY PLAN**

Any increase will be implemented by way of The Seed Fees (Scotland) Regulations 2020, with the exception of the seed testing fees, which uses Section 24(4) of the Plant Varieties and Seeds Act 1964, as it provides Scottish Ministers with powers to allow the Official Seed Testing Station for Scotland to make charges for services provided.

The proposed increases and reduction of fees would come into force on the 1 July 2020.

#### **Post-implementation review**

Scottish Ministers have given their assurance to the Rural Economy and Connectivity Committee, that the statutory fees charged for seed testing, seed certification, and associated licensed activities should be reviewed on an annual basis.

# SUMMARY AND RECOMMENDATION

Scottish Government preferred option is Option 2 - A 5% increase to maintain full cost recovery for seed certification and associated fees and an 8% increase for seed testing fees, to reduce the deficit that the OSTS and the Certifying Authority currently have for providing seed certification / testing services. The proposed increases are anticipated to bring full cost recovery.

The reduction in the licence fee for official supervision of Licensed Seed Testing Stations would ensure that no inappropriate over recovery of fees for this function occurs.
