# **UEFA EURO 2028 – Protecting Rights**

#### Introduction



Scotland will co-host the European Championship or 'EURO' in 2028. This will be part of a UK and Ireland football contest. It will happen in Summer 2028 and last 4 weeks.



Matches in Scotland will be played at Hampden Park in Glasgow. There will be host cities across the UK and Ireland. Hampden Park and other areas in Glasgow will be called 'event zones' during the event.



Some big sport events need special protection.

UEFA is the Union of European Football Associations

It wants to protect its rights during the event.



These rights include their own and companies that sponsor the event. It also wants to ban re-selling tickets.



These rules are mostly the same as for EURO 2020. We think these rules worked well.



The Scottish Government wants to ask people for their views. This is called a consultation. We are asking for views on how we should protect rights in Scotland for EURO 2028.



We want to hear from businesses in event zones who have outdoor adverts. This includes bars and restaurants. These businesses could be affected.



Some rules would only affect event zones. Rules for ticket re-selling would be for all of Scotland. We want to hear views from people all over Scotland.

## **Street Trading**



Street trading means selling or offering to sell things or services in an open public place.



Street trading without a license was banned in event zones for EURO 2020. This was done to stop event zones getting too busy.



We expect this to happen again for EURO 2028. There would be an event zone around Hampden Park and an event zone in part of Glasgow City centre.



These rules would not be for everyone. Selling newspapers, busking, and transport services were allowed in event zones during EURO 2020.



People found guilty of street trading without a license during EURO 2020 could be fined up to £20,000. We think this should be the same for EURO 2028.





We think Police should make sure laws on street trading are followed.



There should be guides on street trading. These would help people understand and follow the rules.

## **Advertising**



Advertising without a license was not allowed in events zones during EURO 2020.



These rules are meant to stop event zones getting too busy. We expect to use the same rules for EURO 2028.



These rules would not be for all advertising.

Demonstrating and campaigns would be allowed. This may be about political or religious beliefs.



Some advertising that was already in the event zones was allowed to stay. This was to reduce the impact on business.



People found guilty of advertising without permission during EURO 2020 could be fined up to £20,000. We think this should be the same for EURO 2028.





We think Police should make sure the laws on advertising are followed.



There should be guides on advertising. These would help people understand and follow the rules.

## **Ticketing**



UEFA is the only seller of tickets for EURO 2028 allowed. Touting tickets means buying them then selling them to other people for a higher price.



The touting of tickets was banned during EURO 2020. This was meant to protect rights and give people fair access to tickets.



In 2020 re-selling tickets was allowed for charity auctions and some other promotions.



UEFA says these rules for were not enough. There should be no exemptions for EURO 2028, not even for charity auctions.



For EURO 2020, people found guilty of advertising without permission could be fined up to £5,000. We are unsure if this should be made more at £20,000.
