PROPOSED DEVELOPMENT OF 18 HOLE GOLF COURSE, ERECTION OF  
CLUBHOUSE, RENOVATION OF EXISTING BUILDINGS FOR MAINTENANCE  
FACILITY, PRO-SHOP, CADDY HUT, WORKSHOP, ADMINISTRATION BUILDING,  
INFORMATION BOOTH, FORMATION OF NEW PRIVATE ACCESS FROM C1026 ON  
LAND 1700M NW OF EMBO COMMUNITY CENTRE, SCHOOL STREET, EMBO**

I refer to your e-mail of 4 July 2018 notifying the above application to the Scottish Ministers following consideration by your Council who were minded to grant planning permission against the advice of Scottish Natural Heritage.

Having considered the proposal, the Scottish Ministers have decided, in terms of Section 46 of the Town and Country Planning (Scotland) Act 1997, to require the application to be referred to them for determination. Accordingly, a Direction in terms of Section 46 is attached.

The Scottish Ministers have given this Direction as the proposal raises issues of national importance in relation to natural heritage issues and its compliance with SPP which require further scrutiny at a national level.

Regulation 35 of The Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013 requires the planning authority to serve notice on the applicant for planning permission: of the terms of the Direction; of the reasons for issuing it; that the application has been referred to the Scottish Ministers; and that the decision of the Scottish Ministers will be final. In connection with the service of notice, your attention is drawn to Regulation 48 of those Regulations which applies Section 271 of the 1997 Act. In this respect, your Council should serve the required notice and let me have a copy. The

planning authority is also required to include a copy of the decision to call in the application on the planning register in accordance with Regulation 16 and paragraph 3(d) of Schedule 2.

In terms of the Town and Country Planning (Appeals) (Scotland) Regulations 2013, the application will be submitted to the Planning and Environmental Appeals Division (DPEA) for an examination by a reporter. I would be grateful if you would prepare all the application documentation and send it to [dpea@gov.scot](mailto:dpea@gov.scot) or on disc to David Henderson, Head of Performance and Administration, 4 The Courtyard, Callendar Business Park, Callendar Road, Falkirk, FK1 1XR who will make arrangements for processing the case. Thereafter, the appointed reporter will submit a report, with recommendations, to the Scottish Ministers for their consideration and determination.
