

## GYPSY/TRAVELLER DELIVERY PLAN – TRACKER

### E. Improve Gypsy/Traveller Representation

The table below sets out the progress that has been made in delivering the representation actions in the Gypsy/Traveller Action Plan. The COVID 19 pandemic has resulted in delays in progressing some of the actions. We are therefore reviewing the actions, with the intention of continuing them for a further 18 months.

| <p><b>32.</b> Supporting local authorities and the wider public sector to listen to Gypsy/Travellers in their areas in a meaningful and supportive way and engage them through local policy, planning and budgetary processes.</p> | <p>COSLA to scope and understand Gypsy/Travellers current participation in local decision-making, with a focus on participatory budgeting</p> <p>COSLA to work with 2-3 local authorities to strengthen participation in local policy, planning or budgetary processes agreed with communities</p> | <p><b>By March 2020</b> – Scoping work was completed.</p> <p><b>By January 2021</b> – local delivery of identified projects began.</p> <p><b>By March 2021</b> – evaluation and promotion of work will be delivered.</p> <p>These actions were delayed during Covid19, but remain a priority for moving forward with during the plan’s 18 month extension.</p> <p>Local Leaders network meetings will consider the ways in which Gypsy/Travellers’ participation can be enabled and sustained locally to improve outcomes going forwards.</p> |
