### **NUS/NUS Scotland Outward**

- Mike Day, International and NUS-USI Director was key note speaker at a conference organised by Landelijke Studentenvakbond – LSVb (national student representatives in the **Netherlands**) on governance. Conference was held in Utrecht on 30 September to 2 October. Visits were also made to Interstedelijk Studenten Overleg – ISO the other national union in the Netherlands.
- Delegates from NUS attended the 74th European Students' Union Seminar and Board Meeting in Jerusalem, **Israel** from 27 November to 3 December, hosted by the National Union of Israeli Students - NUIS. The seminar focused on innovation and entrepreneurship, the boards focus was on the upcoming EHEA Ministerial and developing HE policy around access. Delegates also took the opportunity to visit the Palestinian Federation of Student Councils in Ramallah, Palestinian Territories. The study visit was organised by Danske Studerendes Fællesråd – DSF (the national student representative organisation in Denmark) who have been leading a project to develop student representation in the Palestinian Territories.

- A delegation from Landelijke Studentenvakbond – LSVb (national student representatives in the **Netherlands**) made a study visit to NUS to discuss how we developed our commercial services. This took place 6 – 8 October.
- NUS Wales hosted the European Students Convention (run by the European Students' Union) in Cardiff from 9 – 13 October, The conference focussed on the future of higher education, and discussed the implications of Brexit and learning in a second language amongst other areas. The event was attended by representatives from Unioni i Studentëve të Kosovës (KSU the national student representative organisation in **Kosovo**) who were attending for the first time to discuss candidate membership of the European Students' Union. NUS Scotland has been working with KSU for the last three years to help develop their structures and capacity as part of a TEMPUS project. The project is now complete.

#### **SCQF (Scottish Credit and Qualifications Framework)**

In October 2017, we joined with colleagues from Croatia, Poland and Macedonia (FYROM) in Skopje to take part in a conference to mark the end of almost two years of work to support the implementation of a National Qualifications Framework for **Macedonia** (FYROM). The Twinning Project had as its main aim the development of a comprehensive National Qualifications Framework (NQF) aligned to the European Qualification Framework (EQF) which would improve the transparency, access and quality of qualifications in the country.

This project has supported the work of the Ministry of Education and Science to review the legislation and update the protocols to improve the working practices required for qualification systems functioning. It has also strengthened the institutional capacity for implementation of an effective qualifications system. Working with the Ministry of Education and stakeholders a set of tools including a comprehensive NQF Manual and Road Map for implementation of the NQF along with a specification for the Register for National Qualifications aligned to the NQF was also produced.

Following a review and tendering process earlier this year we appointed an external agency to design and develop our new **website** which will be launched in the coming weeks.

The SCQF homepage design is being completely revamped, while still retaining the look and feel of the SCQF brand and in redesigning the site structure, we will reduce the number of levels within the site and cut down on clicks. This will make it easier for users to find information and navigate the many different areas of the site including news and information about our European and International engagement and activity

## **RSE**

### IEP Bilateral Exchange Programme

The RSE's International Programme seeks to increase Scotland's research and development connections internationally; and increase the number of world-class science and culture researchers working in Scotland. The RSE administers exchange schemes to provide researchers of at least post-doctoral status with short visit opportunities (normally up to four weeks) to and from Scotland, with a view to developing relationships leading to collaborative projects and leveraging further research funding from other sources. The deadlines for these schemes are quarterly in late February, May, August and November. Between November 2017 and January 2017, 2 applications were supported by the RSE.
