Introduction

Safe, Secure and Prosperous

The importance of cyber resilience in the third sector has never been greater. Digital technologies are revolutionising our world, bringing significant opportunities for our third sector organisations, but are also creating challenging new patterns of crime and online exploitation which we must take decisive action to manage.

In summer 2018, a cross-sectoral group of Third Sector Cyber Catalyst organisations was formed to work with the Scottish Government and the National Cyber Security Centre (NCSC) to help tackle these challenges, share good practice and develop practical solutions.

Membership of the working group is voluntary and made up of organisations who have committed at board level to work with the Scottish Government and the NCSC to support a broad programme of work, which includes:

- **Strengthening leadership, and helping drive greater awareness and uptake of good cyber-resilient behaviours in Scottish small and medium third sector organisations – including their supply chains,**
- **Improving coordination and knowledge-sharing of cyber resilience good practice across key third sector organisations operating in Scotland, and**
- **Supporting and promoting uptake of key educational initiatives in Scotland, including cyber security apprenticeships.**



Cyber Catalyst Members

Aberlour Child Care Trust
