Terms of Reference / aims

The Scottish Coastal Forum was formed in 1996 to encourage debate at national level on coastal issues. Its members advise Marine Scotland, from an operational perspective, on the development of policy relating to marine planning and licensing within a sustainable marine environment. The Forum also provides a network for circulating information and best practice in coastal management amongst its own varied membership and the wider ICZM community.

- Encourage the formation of local coastal fora, providing a point of coordination for these as well as acting as a central point to communicate their views and concerns.
- Encourage debate on coastal issues at a national level.
- Seek opportunities for better coordination of national frameworks and policies, consider the need for further advice and guidance and assist in its preparation.
- Gather information about approaches to coastal management and disseminate good practice to local Fora.

Pentland Firth and Orkney Waters

Aim: Ahead of future statutory regional marine spatial plans being developed around Scotland, a non-statutory pilot marine spatial plan in the Pentland Firth and Orkney Waters area is being developed by Marine Scotland, Orkney Islands Council and Highland Council. The Plan is likely to be ready to go out for consultation in summer 2015 and completed by the end of 2015.

The Plan aims to put in place a planning policy framework in advance of statutory regional marine planning to support sustainable decision making on marine use and management. It is anticipated that this Plan will establish a useful basis for the preparation of the two separate regional marine plans for Orkney and the North Coast Scottish Marine Regions.

5. Marine Spatial Planning Forum

Terms of Reference / aims

The Marine Spatial Planning Forum is an informal group that aims to provide an opportunity for marine spatial planners to get together and discuss on-going work and to provide a way in which ideas can be exchanged and any common issues and problems discussed.

The idea for a Forum such as this was a result of a discussion during a marine spatial planning discussion session at a conference where it was noted that despite all the work being undertaken in Scotland there were few, if any, opportunities for everyone to get together to have an informal discussion.

Marine Scotland offered to organise and host the first session in May 2014. It is intended that each of the members take turns in hosted the Forum and the meetings will be held on an ad-hoc basis as required. Marine Scotland has offered to collate the agendas and minutes of the meetings. The members of the group are listed below but as the Forum is informal other interested parties are welcome to attend.

6. Marine Spatial Planning Community Project / Forum (MASTS)

Terms of Reference / aims

The MASTS Marine Spatial Plan Community Project aims to develop a focussed, interdisciplinary approach of Scotland's marine science to support marine spatial planning (MSP) in Scotland.

The project serves two broad functions:

- Provide a forum by which strategic actions can be identified to support co-ordination of MSP-related research across MASTS institutions;
- Develop collaborative proposals to access wider funding mechanisms and increase MASTS research to support marine planning.

The project is building an understanding of the capacity, expertise and experience across MASTS institutions, and engaging directly with planning authorities (including Marine Scotland) to understand their needs. Interim activities were identified to support marine planning activity (such as a MASTS hosted web-based portal for knowledge exchange) and possible priority research topics were discussed, under the three following themes:

1. Data and information for planning (e.g. tourism and recreation, bathymetry, etc.)
2. Methods, techniques and tools for planning (e.g. cumulative impact assessment, planning for optimised resource use, co-location, etc.)
3. Approaches to governance, stakeholder participation and communication (e.g. integrating non-licensable activities, testing consultation techniques, etc.)

The Project held its first workshop in June 2014. Download the workshop final report and presentations from Lucy Greenhill and Matt Gubbins on MASTS web site. At a second workshop in September 2014, progress of the Community Project was discussed and a decision made to develop a forum (leader currently being sought).

9. Scottish Offshore Renewables Research Framework (SpORRAn)

The aim of the new Scottish Offshore Renewables Research Framework (SpORRAn) is to provide a mechanism to create a co-ordinated strategic research programme needed to facilitate the sustainable development of the Marine Renewable sector in Scotland. The SpORRAn framework will be structured to include a high level coordination group, and specialised research groups for a number of important receptors e.g. marine mammals and birds.

The Framework has three strategic Objectives:

1. Coordinate, prioritise and address evidence needs to:
 - support Marine Scotland’s risk based licencing and consenting approach.
 - increase understanding of the environmental, social and economic interactions of renewables development in Scotland; including interactions with species and habitats protected though European and national legislation.
2. Provide a mechanism for
 - Project level and post consenting impacts to inform the strategic planning for offshore renewables.
 - Monitoring, review and update of the offshore renewable Sectoral plans for Wind, Wave and Tidal Energy.
 - Interacting with relevant UK, EU and International Renewable Energy groups.
3. Ensure most efficient and effective use of expert time.

The TORs for the groups have not been finalised.

9. Marine Scotland Fishing Focus

Aim: To provide a strategic and co-operative forum to ensure commercial fishing interests are considered in the development of Marine Scotland policy in relation to marine planning, marine renewables and marine conservation. To provide for an integrated approach to information dissemination and discussion.

The Marine Scotland Fishing Sector Focus Group provides a forum to discuss a range of strategic marine issues that are relevant to the fishing sector.

Made up of representatives from both Marine Scotland and the fishing sector, the forum is designed to offer a cooperative forum where commercial fishing interests are considered in the development of marine planning, renewables and conservation policy. In addition, it will also provide a more integrated approach to information dissemination and discussion.
