

## Strategic Framework for Farmed Fish Health Working Group Terms of Reference

### Introduction

In March a [Joint Ministerial Statement](#) on aquaculture was endorsed by the Rural Economy Secretary Fergus Ewing and Environment Secretary Roseanna Cunningham. The statement emphasises the Scottish Government's focus on enabling aquaculture to realise its potential in an economically, environmentally and socially sustainable way.

In order to ensure that growth is sustainable, addresses biological and environmental challenges and support the ambition of industry Mr Ewing proposed the development of a strategic framework for farmed fish health at a meeting of the AILG. Members were receptive to the proposal and Scottish Government has committed to progressing the delivery of this framework in its [Programme for Government](#). The framework will be co-owned with industry, reflect the importance of fish health in sustainable production and provide a mechanism to map out key milestones and address the biological challenges faced by industry.

While acknowledging that understanding the scale of any interactions between farmed and wild fish and addressing these is of importance, it is recognised that this is not the appropriate forum to consider these issues. The discussions of the group will focus specifically on farmed fish, whilst acknowledging that many of the anticipated outputs from the discussions and the final framework document may have wider benefit.

### Group Objectives

The group has two clear objectives:

1. To deliver a high level framework for farmed fish health by Spring 2018. This will include prioritised work streams, each with clear milestones and measurable outputs.
2. To oversee and facilitate the implementation of the fish health framework and provide biannual updates on progress against agreed milestones within each of the priority work streams.

Prioritisation of work streams and consideration of new work streams will be reviewed on an annual basis. The framework will be reviewed on an annual basis.
