

# Grangemouth Future Industry Board - Workstreams

To facilitate collaboration with a *Team Scotland* approach across the Scottish Government, Scottish Enterprise and Falkirk Council, in pursuit of long-term sustainable economic success for Scotland's core manufacturing cluster, in recognition that Grangemouth must remain competitive in future with business strategies for coming years to grow into new markets and attract investment.

## Net Zero Grangemouth

SG & SE

Lead Individual

Lead on engagement with partners to prioritise and coordinate cross cutting decarbonisation projects across the Grangemouth cluster as part of a Just Transition towards Net Zero economy.

Develop a plausible vision and roadmap for the future of the site in Net Zero emissions economy. Create a near term vision, that will form the basis and be followed by an iterative, collaborative planning process to deliver on a Just Transition for this cluster.

Plan for a Just Transition in this roadmap, cognisant of the potential to capture opportunities via existing mechanisms for engagement with local community.

Strategically position Grangemouth industrial cluster businesses to capture suitable UK and Scottish decarbonisation funding streams.

Promote engagement between cluster, and Scottish programme of work on hydrogen, CCUS, Bioeconomy and Low Carbon mobility

Inform engagement between strategic initiatives and cluster for partnership working (e.g. NECCUS).

### Strategic Investment

Scottish Development International and Scottish Government

#### Scope

Development of a roadmap to identify potential investment opportunities that will generate significant environmental, social and economic benefits and gain an understanding of gaps.

#### Goals

- Effective coordination of overall public sector business case for any strategic or transformational investment (public and private).
- Using our 'Team Scotland' approach, establish how we can best support investment to the cluster and necessary projects to support the transition to Net Zero.
- Ensure Grangemouth's interests are reflected in key policy outputs (e.g. Inward Investment Plan and Capital Investment Plan).
- Ensure strategic investment activity maximises the Scottish supply chain benefits and captures local content where possible realising the benefits of inclusive growth.
- Encourage new complementary investors to Grangemouth.

### Infrastructure

Scottish Futures Trust and Falkirk Council

#### Scope

Lead on engagement with partners to ensure infrastructure requirements for current and future economic activity at Grangemouth are appropriate.

#### Goals

- Shape and maximise Growth Deal opportunities.
- Develop proposals across Transport Scotland, Falkirk Council and Region Deals teams to improve effectiveness of infrastructure across the cluster.
- Inform engagement with Infrastructure Commission for Scotland to ensure visibility of challenges and opportunities.
- Engage experts to better understand adaptation requirements for Grangemouth businesses and build resilient infrastructure.

### Project Development

Scottish Enterprise

#### Scope

Working with others to lead on the development of a pipeline of projects that can be considered for further investment to facilitate growth.

#### Goals

- Shape and develop growth deal opportunities to maximise impact.
- Identify projects and growth opportunities for cluster realising the benefits of transition to a net zero economy and inclusive growth impacts.
- Working with partners, identify a pipeline of projects for development, which expertise of board could advance and support.
- Provide value-add scrutiny to maximise deliverability of projects to grow economic footprint of site.
- Ensure projects maximise emission reductions, air quality improvements, indigenous supply chain activity, circular economy and economic potential.

### Grangemouth Regulatory Hub

Scottish Environment Protection Agency and Scottish Government

#### Scope

Provide updates on the current regulatory environment across the Grangemouth sites, striving to ensure its at its best: solving compliance problems quickly and driving innovation and transformational change

#### Goals

- Drive energy efficiency and greenhouse gas emissions reductions using shared regulatory tools.
- Use a sector and circular economy approach to target areas across supply chains that will deliver an accumulated benefit to reducing emissions.
- Use regulatory and planning roles to create a low carbon and resilient place for industry and communities – a just transition whilst protecting the environment and human health.
- Create a space for innovation and ensure that a clear pathway to transition delivers an environment that supports the areas' inclusive growth, competitiveness, jobs and skills development.
- Ensure interdependencies between land use, air and water are recognised with particular focus on climate adaption, flood risk and resilience.

### Resilience Planning

Scottish Government

#### Scope

To ensure resilience plans for the Grangemouth industrial cluster are fit for purpose and understood by partners.

#### Goals

- Stakeholder engagement (Government, Responders and Infrastructure owners/operators), to provide expertise and policy knowledge to shape Critical National Infrastructure considerations at Scottish and UK level.
- Inform Scottish Government, Scottish Enterprise & Falkirk Council input to Local Resilience Partners to ensure coordinated approach to challenges.
- Provide flow of information to group, where appropriate, in response to resilience matters / incidents.
