I spoke with REDACTED last night about recent progress and outstanding issues on the legal front, particularly having regard to the diminishing time available for agreement.

It was pleasing to hear how much has been accomplished in recent days subject to confirmation of the structures for the guarantee. REDACTED

This positive view is, of course, predicated on the assumption of reaching early agreement on the power supply arrangements.

REDACTED Our submissions to the Permanent Secretary and the Finance Committee were based on the security package and structures as we understood them to be.

This appears to be the last significant hurdle to be overcome in relation to the guarantee and security package. REDACTED has our clear instruction to pursue a model that is strongest from a Scottish Government perspective.
