Purpose

Background

- 3. have been the proprietors of Their title is registered in the Land Register of Scotland. Following an application in 2016 to register a discharge of a standard security over their property, they raised a number of concerns with the Keeper of the Registers of Scotland (RoS) about the policy and process of registration in the Land Register.
- 4. The concerns result from two errors that register title sheet, following the application to register the discharge. Firstly, they discovered that one of the boundaries on their property had been changed on the cadastral map. The change appeared to reduce the extent of their garden, by showing the line of their fence as a straight line rather than a curved line. This resulted from an updating error by the Ordnance Survey (OS) in 2006, and has now been corrected on the base map by OS and on the cadastral map by RoS.
- 5. The second issue was that, following registration of the discharge, the title sheet erroneously stated that was "now deceased". The title sheet was corrected as soon as the solicitors drew their error to the Keeper's attention.
- 6. - 7. propose that the 2012 Act should be amended to require RoS to carry out individual site surveys on each occasion that the OS map differs from the Keeper's cadastral map. Section 11(7) of the 2012 Act requires the Keeper to make any necessary consequential changes to the register whenever the OS map is updated. RoS receives 400-450 updated map tiles per week from the OS, each of which may contain multiple updates to boundary features.
- 8. We do not think it would be realistic to undertake individual site surveys or to correspond with owners and their neighbours as a matter of routine before we update the cadastral map. This would add significantly to the operating costs of the register. In our experience mistakes are highly unusual, and without taking professional advice proprietors would in most cases be unable to express a view about the impact of a mapping update on the extent of their legal title. We do, however, make use of technology such as aerial imagery, which was not so advanced in 2006 when the OS updating error occurred in this case.
 - A certified death certificate should be provided as evidence of death
- 9. propose that a certified death certificate should be provided to RoS in support of an application notifying the death of a proprietor. Applications for registration are typically submitted by the applicant's solicitor, who is under a professional duty to establish the identity of their client. The present case, where solicitor incorrectly advised the Keeper that to pursue with their own solicitor.
- 10. Section 111 of the 2012 Act requires solicitors to take reasonable care to ensure that the register does not become inaccurate as a result of an application for registration (ie to ensure that the information in the application is correct). Section 112 prescribes that it is an offence for a solicitor to make a materially false or misleading statement in relation to an application.
- 11. RoS takes the view that Parliament intended solicitors to be responsible for ensuring that what they state in an application is true and correct, rather than requiring them to submit supportive documents so that the Keeper can check the accuracy of the solicitor's statements as a matter of routine. The Keeper is entitled to rely on what solicitors tell her, especially in relation to such a fundamental matter as whether the client

is alive. We are unaware whether have raised a formal complaint with their solicitors for incorrectly stating that was deceased.

- Information from the Land Register should be made available free of charge to allow proprietors to examine and check their validity
- 12. On completion of an application for registration, RoS issues a free-to-access link to the register showing the updated title sheet and plan which can be printed off or saved. The link is issued to the submitting solicitor and any other e-mail address provided by them with the application. The link is available for a period of 50 days and can be shared freely allowing unlimited views.
- 13. Information in the Land Register is openly available to any member of the public. The fees for information are prescribed by Ministers by Order. RoS is self-funded from the fees charged for its services, and the fees for information and paper copies are broadly set to recover costs. Income in 2016 from Registers Direct and our Customer Service Centres was £4,956,000. If this information were provided free of charge, the costs of doing so would have to be funded from elsewhere.
- 14. In addition to providing information to proprietors and others who wish to see an individual title, RoS offers a number of other methods of obtaining information, including its business-to-business service Registers Direct which is widely used by solicitors and professional searchers. In October 2017, RoS plans to launch the first phase of a new digital land information system (ScotLIS).
 - Investigations by the SPSO should not be carried out in private
- 15. We have asked the SG Tribunals and Administrative Justice policy team for advice on this proposal. Their response is included as Annex C.

Recommendations

- 16. We recommend that you advise Ms McKelvie that it would be unnecessary and disproportionate to amend the 2012 Act along the lines proposed by The errors in the Land Register identified by Information provided by their solicitor and by OS, rather than from inherent defects in the 2012 Act or the Keeper's policy. The 2012 Act already provides for the Keeper to rectify inaccuracies in the register, and in this case the inaccuracies have been rectified without any loss of title.
- 17. We recommend that you advise Ms McKelvie that SPSO is a Parliamentary body that functions autonomously. It is independent of SG in order to safeguard its investigations and decision-making processes. Accordingly, any review of the 2002 Act would be a matter for the Scottish Parliament rather than for Ministers, and in the first instance should be raised with the Scottish Parliamentary Corporate Body.

Annex A

Suggested key lines to take

- 1. Carrying out individual site surveys before updating the cadastral map is unnecessary and would add significantly to RoS costs, which would have to be paid for. Aerial imagery is increasingly used in the few cases where there is doubt about the impacts of updates to the OS map.
- 2. RoS is entitled to rely on information from solicitors, who have a duty to be accurate. Solicitors have specific responsibilities for checking their clients' identity.
- 3. RoS provide access to the title sheet free of charge for 50 days after completing an application for registration. Proprietors have access provided their solicitor includes the client's email address on the application form.
- 4. SPSO conducts its investigations in private to protect any sensitive information it may receive.





Annex C

REQUEST TO REVIEW THE SCOTTISH PUBLIC SERVICES OMBUDSMAN ACT 2002

ISSUE: Christina McKelvie MSP, on behalf of her constituents, is asking the Scottish Government to consider a review of the Scottish Public Services Ombudsman Act 2002 ("the 2002 Act") to allow correspondence relating to an investigation by the SPSO to be made publically available.

Lines to Take:

- 1. The SPSO has the power to collect personal and sometimes highly sensitive information during the course of an investigation.
- 2. It is therefore prudent that there are provisions in place that protect members of the public from the disclosure of information that may be personal to them or damaging if released in the public domain.
- 3. Section 12 of the 2002 Act, states that investigations should be carried out in private. This provision exists to provide protection to members of the public. I am therefore not minded to amend the legislation.

BACKGROUND:

The SPSO was set up as an independent body, not accountable to the Scottish Government or the Scottish Parliament, in order to maintain an independence from the public services which they could be investigating.

Christina McKelvie MSP (on behalf of her constituents requested consideration be given to changing the 2002 Act (at section 12(1)) which states that investigations by the SPSO must be carried out in private. This change is requested so as correspondence relating to the investigation can be made publically available. Ms McKelvie's constituents are of the opinion that this would allow transparency and Freedom of Information (FoI).

Ombudsman is a parliamentary body that functions autonomously and are therefore seeking a review of the founding legislation.

However, Section 12 of the 2002 Act exists to provide protection to members of the public. Information collected in the course of an investigation can be of a highly sensitive nature. The SPSO has very broad powers to access information and therefore release of this information is limited (section 19 of the 2002 Act). There may also be relevant exemptions under FoI for much of the information the SPSO holds e.g. personal information (section 38, FoI Scotland Act 2002) or prejudice to effective conduct of public affairs (section 30). There are also powers at section 18 of the 2002 Act which protect statements made to the SPSO in certain situations from acts of defamation. These all sit alongside the requirements to investigate in private and the limitations on what can be released.

Simon Stockwell and I supported Mr Brown at a meeting with Ms McKelvie yesterday. Ms McKelvie explained that her constituents are determined to pursue legislative change.

Mr Brown has agreed to write to Ms McKelvie, confirming that he agrees with the Keeper's view that there is no need to amend the 2012 Act. We agreed that RoS and SG Property Law would collaborate on the draft letter.

On the points raised:

1. Site surveys and correspondence with proprietors and neighbours when a MBM update occurs Mr Brown asked whether there was a potential sub-category of updates for which a survey might be beneficial, but seemed content that we now have access to aerial imagery etc to check any cases where we have a concern before referring them back to OS if we think the map update may be incorrect. For the draft letter, spell out in more detail the resource and cost implications of routine site surveys and correspondence, so that Mr Brown can demonstrate why this proposal is unrealistic as well as unnecessary. We will work up an estimate of RoS annual resource and costs, based on the assumption of a site survey and correspondence in every case – and the draft letter will also point out that there would be additional costs for proprietors and lenders.

(I should say that the additional information supplied by Alison Wellwood about MBM – including slides showing how aerial imagery can be matched against OS detail – was extremely helpful in demonstrating to Mr Brown and Ms McKelvie how the process works when there is dubiety about an update, and how modern technology helps us to overcome errors that might not have been spotted in 2006 when the OS error in this case occurred. I'm grateful to Alison for supplying this level of detail so quickly.)

- 2. Checking death certificates where the solicitor certifies that a client has died Mr Brown was content that this is the solicitor's responsibility.
- Free-of-charge access to title sheets

Ms McKelvie questioned why the link was only available for 50 days. I explained that this was to allow sufficient time for solicitors and clients to check the title position, without undermining the general principle that we charge for supplying information because we are self-funding and have to cover our costs.

4. Transparency of SPSO investigations

Mr Brown was content that this is not a matter for Ministers, because SPSO is an autonomous parliamentary body.

Policy Unit will prepare a draft letter and seek input from SG before getting it cleared by the Keeper for submission to Mr Brown.
