



That's quite alright. I was expecting you (or someone like you) to be in touch. I'd be happy to meet Ms Cunningham and to take her to the Dunfermline fulfilment centre. We could perhaps arrange a visit to our customer call centre in Waverley and Tech Development centre in the same building and then a tour of the fulfilment centre in Dunfermline (or vice versa depending on whether she can fit in a whole morning). Then she'd get a picture of the jobs, training and Amazon experience at both ends of the spectrum.

I just tried your number but it says "The extension you have dialled is unavailable". But I'm on the number below until 2 and after 3.

I attach also the full press release we issued this morning on UK expansion. In summary, Amazon announced our plans to create more than 2,500 new permanent jobs in the UK this year, taking the total number of permanent full-time employees across Britain from around 12,000 today to more than 14,500 by the end of 2016.

We will also be hiring to support the new Amazon Web Services.

Technology teams in our UK R&D centres including that in Waverley, are working on innovations that improve our customers' experience on the Amazon website and mobile apps, the Amazon Prime Video service, Amazon's device range and voice recognition technology Alexa, Prime Air, and cloud services.


