
Thank you for your email and apologies for missing your call this morning. I'm afraid I will not be able to join a call to discuss this matter today.



We write further to your correspondence with James Westhead and Jonathan Dando regarding the freedom of information requests mentioned above.

We appreciate that the Scottish Government is subject to transparency obligations, and recognise that your approach must balance the public interest with any individual or organisational interests in the release or withholding of information. We additionally appreciate the courtesy you have shown us in consulting with us prior to disclosure.

We would like to reiterate our concerns about the release of unredacted documents into the public domain. Our concern focuses predominantly on the release of information about Teach First's current plans for a Scottish programme, in particular our projected programme design, programme philosophy and partnership structures. Our concerns are that:

- 1) Release of this information will fundamentally hamper Teach First's ability to submit a competitive bid for any forthcoming tender for an initial teacher training route in Scotland, by making our planned approach a matter of public record. As you know, we deliver a programme which meets similar (although non-identical) needs in England and Wales, and as such our planned approach in a Scottish context would, we think, be of significant interest to potential competitors. Releasing our confidential information will weaken our competitive edge. This leads to our second concern:
- 2) Release of this information will jeopardise the Scottish government's ability to undertake a truly competitive procurement process, by reducing the ability of one bidder (namely Teach First) to develop a programme of which other bidders are unaware.

As a result, we believe that sections 33(1)(b) and 30(c) are both relevant exemptions from disclosure under the Freedom of Information (Scotland) Act 2002, which should be taken into account when determining the information which should be disclosed.

In addition, we would be grateful if the names and any further personal data of all Teach First employees could be removed from any documents released pursuant to these requests.

We have reviewed the documents which you intend to release, and have highlighted in the enclosures to this letter the sections which we particularly believe to raise the concerns voiced in points 1 and 2 above. We would like to request that highlighted sections be considered for redaction prior to the publication of these documents. As you will see we have tried to be as restrained as possible in our suggested redactions, focusing on information which we believe would particularly hinder our bid if made publicly available prior to the release of a tender, because they expose our pre-bid planning. We would be extremely grateful if your team could consider redacting these sections prior to their release, and could let us know the outcome of this determination.
