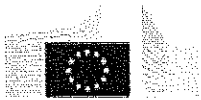

I'm so sorry but Mr Russell's plans have had to change and he is now not able to be in Strasbourg on Tuesday 14<sup>th</sup> March.

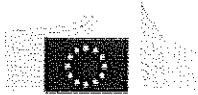
I just wondered whether your original option of 16:00 on Monday 13<sup>th</sup> at the Berlaymont might still be an option for him to meet the Commissioner?

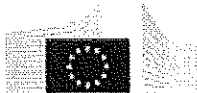

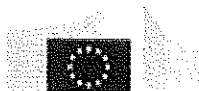
