To be aware, one of the team has alerted me that the Daily Record is today running a story entitled "Nine dead as crazed mobs hunt down 'blood-sucking vampires' in Malawi" - http://www.dailyrecord.co.uk/news/uk-world-news/nine-dead-crazed-mobs-hunt-11382642

I have drafted brief reactive lines to take below in case this story gains traction in the Scottish media – for comms/spads sign off.

For ease of reading on BBs, the story says:

\* Around 140 people have been arrested in Malawi after deadly mob attacks on people suspected of being "vampires".

- \* Police said more arrests are expected after the situation spun out of control, with nine people having been killed.
- \* The attacks began last month after rumours of "blood-suckers" spread.
- \* In the latest case, a man with epilepsy was burned to death in Blantyre, the southern African nation's second-largest city. Another person there was stoned to death
- \* President Peter Mutharika has appealed for calm in the four districts where the mob attacks have taken place, saying this week that "my government will offer protection from these alleged blood-suckers".
- \* The United Nations and US Embassy have blacklisted some of the areas as dangerous zones for staffers.
- \* Inspector general of police Lexon Kachama said: "The biggest challenge is that thieves and robbers have now taken advantage of the situation and are mounting illegal roadblocks at night in order to harass people."
- \* Government officials have said the attacks are harming the deeply impoverished country's image.
- \* Residents including health officials, teachers and traditional leaders have said their homes were destroyed after rumours spread that they were harbouring "vampires"

The Minister will wish to note a story running in the Press regarding people being attacked and murdered in the Blantyre/Mulanje area in Malawi, after being accused of being 'Vampires'. The President of Malawi has spoken out about this issues, and has recently visited the areas concerned calling for order. This is brought to the Minister's attention as 2 member of Police Scotland arrived in Blantyre yesterday to commence work in relation to our Child Protection and Violence against Women project.

The 2 Police Scotland officers ([REDACTED]) who deliver the child protection and gender based violence programme in our partner countries arrived in Blantyre this morning. They are scheduled to remain there until 26 October delivering a series of workshops with the Malawian Police Force as part of the pre-planned project work in country.

I have been advised by their colleague at Tulliallan that the officers experienced difficulty departing Blantyre airport as all surrounding roads were blocked by people protesting in relation to the latest murders. They have now managed to reach their accommodation and are in regular contact with the Security Manager at the British High Commission. The situation is under review and while the British High Commission have advised the officers to carry on with their in country activity as planned, they will advise them immediately if there is any escalation which means they should depart the country. Officials in the International Development Team are in regular contact with officers at Tulliallan who are keeping them up to date.

To date it is reported that 8 people have died in these attacks (see attached article in the Guardian). The FCO have changed their advice on their website yesterday:

'following unrest and violence in the Mount Mulanje area, there are reports of tensions and unrest spreading to rural parts and township areas of Blantyre, Zomba and Nsanje districts. On 19 October 2017, there are also reports of unrest and disturbances on the Chileka Road which is the main route to the airport from Blantyre; you should exercise extreme caution in these areas, especially after dark, avoid any demonstrations or large groups of people and follow local security advice.'

Dear All,

The Bloodsucker (Vampire) Issue around Risk Assessment for Staff working on the CJF programme has been ESCALATE TO RED so that All Activities Must be Risk Assessed on the Day and appropriate action taken. The previous Risk Assessment on this issue approved T-Shirts (some are with CJF staff in Malawi) and ID cards for our activities (13th Oct). In response we have 24/7 contact via Whatsapp with UoS staff (our standard Daily H&S checks) and with BaseFlow and WFP ([REDACTED]).

Since then we have been reviewing the day to day changes in conjunction with the Gov't of Malawi and with MSF who we have been sharing knowledge and information. They have kindly provided us Daily updates on the matter (see attached). There has been an escalation in incidents in the southern region in the past 24 hours.

All activities planned for today in Chikwawa by UoS CJF Staff have been cancelled as a result and also as we were informed by the Gov't that the President would be travelling to Chikwawa to assist in calming the situation and many Gov't staff will be reassigned accordingly today. There were two serious incidents yesterday in rural Blantyre as well http://www.bbc.co.uk/news/world-africa-41692944

## **Project Specific Concerns**

One CJF Enumerator was chased from a village yesterday as a suspected Bloodsucker. Action was immediately taken last evening to review activities.

Early this morning I have been in contact with Malawi Gov't, BaseFlow, WFP ([REDACTED]) and UoS Staff (Via Strathleyde Safety Checks Whatsapp group) and have agreed the following actions.

### Strathclyde Specific Issue

- 1) Activity for UoS Staff were suspended until RA updates have been actioned, I have met with Staff by phone and are liaising with Gov't on appropriate RA revision.
- 2) Precautionary Principal Applies, do not undertake any CJF activity if any H&S issues are in doubt.
- 3) All UoS staff activities will require prior approval of village chief and Ministry Staff (DWDO and Regional) on day before activity
- 4) Any UoS activity requires prior approval when arriving on site, Ministry Staff (WMA) must seek again approval on site from Chief and Water Point Committee.
- 5) If any of the above are not met, then the site visit is cancelled until approvals are sanctioned.
- 6) No UoS staff shall travel without prior RA and no UoS staff shall travel after dark.
- 7) UoS RA to be updated daily if required.

## WFP / Mapping Specific Issues

- 1) WFP to provide update RA in response to enumerator safety. UoS will provide on 21st Oct updated UoS Risk Assessment for reference.
- 2) WFP to provide indication of what steps are being taken to assure safety of enumerators.

Safety is of utmost importance so please keep staff and all those working on the CJF Programme up to date (daily) and do not undertake any CJF activities if H&S issues are in doubt.

### FROM THE BBC NEWS

At least five people have been killed in southern Malawi after they were accused of behaving like vampires.

Malawian President Peter Mutharika has vowed to launch an investigation into the killings.

A night-time curfew has been imposed by the government to prevent vigilante mobs from killing more people.

The UN says it has pulled staff out of two districts as the vampire scare swept south of the country.

The people killed were suspected of drinking human blood as part of magic rituals.

The government-imposed curfew restricts movement to ten hours from 07:00 until 17:00 local time (05:00 to 15:00 GMT).

Meanwhile, the president's office said in a statement: "This development has been of grave concern to the president and the entire government."

The UN said in a report that the vampirism rumours appear to have originated from Mozambique, and "speared across" the border to the Malawi districts of Mulanje and Phalombe

But, it said, it is unclear what sparked them.

"Temporary suspension of UN activities in the area until the situation is normalised," the report added.

This is brought to the Minister's attention as 2 member of Police Scotland arrived in Blantyre yesterday to commence work in relation to our Child Protection and Violence against Women project.

The 2 Police Scotland officers ([REDACTED]) who deliver the child protection and gender based violence programme in our partner countries arrived in Blantyre this morning. They are scheduled to remain there until 26 October delivering a series of workshops with the Malawian Police Force as part of the pre-planned project work in country.

I have been advised by their colleague at Tulliallan that the officers experienced difficulty departing Blantyre airport as all surrounding roads were blocked by people protesting in relation to the latest murders. They have now managed to reach their accommodation and are in regular contact with the Security Manager at the British High Commission. The situation is under review and while the British High Commission have advised the officers to carry on with their in country activity as planned, they will advise them immediately if there is any escalation which means they should depart the country. Officials in the International Development Team are in regular contact with officers at Tulliallan who are keeping them up to date.

To date it is reported that 8 people have died in these attacks (see attached article in the Guardian). The FCO have changed their advice on their website yesterday:

'following unrest and violence in the Mount Mulanje area, there are reports of tensions and unrest spreading to rural parts and township areas of Blantyre, Zomba and Nsanje districts. Following on from my update at Team Leaders' mtg this morning, I spoke to [REDACTED] who returned from Malawi on Saturday. He advises that the situation with regards to vampires/blood sucking has been relatively calm for the last week. While they were there, the Govt and Police were very active and visible in communities affected (south of the country). The President and the Inspector General of Police both travelled to the south and issued statements saying that blood suckers do not exist. Police officers have been sent in to the more rural areas to cascade that message, however the belief still remains due to it being so deeply ingrained.

There have been no attacks on NGO employees. Police and BHC advice remains that they (and tourists) should not travel to the border area with Mozambique. [REDACTED] (sp?) the [REDACTED] at the BHC is reasonably relaxed about the situation and are happy to accept the Malawian Police Service's (MPS) advice as it currently stands.

Apparently a number of the attacks are not in fact blood sucking related, instead organised crime groups are using them as an excuse to attack people and steal their possessions. The incident of the doctor being attacked was in fact a robbery but some of this seems to have been lost in possibly sensationalist reporting.

Good to have this flagged to grant-holders. We've been monitoring closely, with daily updates with MaSP and the High Commissioner. Very sadly, the situation has worsened this week, spreading out to the outskirts of Blantyre.

Obviously we don't give security advice but have been alerting members working in the area and encouraging everyone to get the FCO auto alerts. We then feed news we receive from the area to the High Commission, which in turn feeds into the advice.

A number of visiting Scottish groups have diverted to, for example, treks on the Zomba plateau rather than the Mulanje massif. While not giving security advice or stirring alarm, we are welcoming such precautions.

We've also been keen this week to support members to understand the cultural context behind these attacks, which are tied to traditional belief systems. This is a very similar situation to one fifteen years ago and, very sadly, these sort of issues are more common in times of social and economic stress.

We invited a prominent anthropologist with expertise in this area, who was previously a SG-funded fellow in Malawi, to write a guest blog to provide some insight for members and counter some of the sensationalist reporting.
