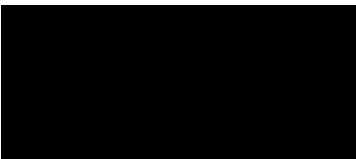
I have now completed the application form, and gathered all the necessary additional information which I will send by mail tomorrow along with the application fee.

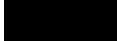
We will except either digital or paper copies of the application form. For the application fee, this is based on the cost of the works, please see fees table link:

This can be paid either via cheque payable to 'The Scottish Government' (quickest option) or we can send you an invoice once we have received your application. application until we receive payment. Marine Scotland aim to determine a marine licence within 14 weeks of payment.
