Thank you for your further email of 20 September 2017 regarding flag flying from the Scottish Government's building at Victoria Quay.

As highlighted in our earlier correspondence Saltires are flown daily from Victoria Quay. The Rainbow flag was flown from Victoria Quay on 1 February for the Start of LGBT History Month and again on 17 May for International Day Against Homophobia, Biphobia and Transphobia (IDAHOBIT). It was also flown on 17 June for Edinburgh Pride and 19-20 August for Glasgow Pride. Other flags flown at Victoria Quay were the Commonwealth flag on 13 March for Commonwealth Day, the Europe flag on 9 May for Europe Day and the Merchant Navy flag on 3 September for Merchant Nay Day.

Is there any reason this hasn't been happening in Victoria Quay? There are 4 flagpoles on this building but the only flags flying are the St Andrews Cross.

Since sending my initial email on 15 August, I have noticed the Red Ensign and Rainbow Flag being flown at Victoria Quay. However, I am not aware of any other flag other than the Saltire having been flown on designated days in 2017 and wondered what the reason behind this was.

The Royal Banner of the Royal Arms of Scotland (the 'Lion Rampant') and other distinguished flags are flown from St. Andrew's House our principal Scottish Government building to recognise specific dates such as Royal birthdays and anniversaries as well as other commemorative dates such as Armed Forces Day and Commonwealth Day.
