#### **Details of request**

3. **Overall Cost:** The only external costs in relation to research, writing and publication of SPIE 2 are the services received from APS for the preparation of and printing of the document. 4. **Estimated Civil Service Time:** The request also asks for the estimated civil service time spent on research, writing and publication. As Scottish Government officials do not record time spent on individual tasks we don't hold any relevant information in respect of this part of the request.
