2. Arrangements for Analysis in Collaboratives

5. National Statistical Outputs

The Scottish Government publishes a range of statistical outputs on school education, including the publications *Summary Statistics for Schools in Scotland*, *Acheivement of Curriculum for Excellence Levels*, *Summary Statistics for Attainment*, *Leaver Destinations and Healthy Living* and *Initial Destinations of Senior Phase School Leavers* as well as a range of background datasets. Headline data is produced at national level but a range of data is published by local authorities and some data is published at school level in supplementary tables. We would like to discuss whether publications and/or background datasets should routinely include data at Regional Improvement Collaborative level and if so, which datasets this should apply to.

7. Future working arrangements and data requirements

We would like to discuss how we can continue to work together to collectively support the development of analysis in Regional Improvement Collaboratives. For example, should there be future meetings of this group, would individual meetings with each Collaborative be helpful, are there other ways to facilitate analytical support. Education Analysis provided a range of data to each Collaborative in December. It would be useful to understand the analysis that Collaboratives are looking to take forward and what other datasets would be useful in the future.
