Whilst it is clear that you wish to give the impression that your organisation provides a high level quality of service by using the word 'Royal', I do not see that as sufficient reason for the Scottish Government to grant permission.

I must stress that this in no way reflects badly upon either the quality of the organisation or its request; rather it is an indication of the rarity with which such Royal Names are granted nowadays.
