Dear Alastair,

I hope you are well and have had a nice weekend.

I saw the attached article in the Telegraph on Saturday. Would you be able to give me more information about the funding announced by Rosanna Cunningham. How will it be distributed?

It mentions that the purpose will be for research and fisheries management to safe guard stocks. Would it be possible for the AST to make an application for some funding to go towards its salmon tracking project?

We are planning a 1.2m tracking project involving a number of important salmon rivers that flow into the Moray Firth such as the Deveron, Spey, Ness, Beaully, Conon and Oykel in 2019. The first steering group meeting will take place on the 26th March. The project will track salmon through the rivers to the outer Moray Firth.

We will be launching a high profile fundraising campaign at the end of March. It will be good opportunity to show partnership working and would be helpful to the project if we were able to apply for some government funding.

Hi Sarah,

My contact details are below and very happy to chat further. I just tried your office number but missed you.

We have a bidding process in place for the £200k Wild Fisheries Governance Fund, but are not running a similar process for access to the remaining circa £500k.

I have a meeting later this week to try to finalise the allocation of it against an internally derived list of research and activities which already exceed the budget! So I'm afraid the current position is that we are very unlikely to have any funds available to support the AST salmon tracking project.

However, we will certainly keep your project in mind. Had AST been in a position to deliver the project this summer, for example, I know we were considering if and how many of our circa 670 unused acoustic tags (purchased for last season's Armadale tagging project) could have been utilised. You may be aware that we have subsequently agreed to give 100 of them to this season's Loch Laxford sea trout tagging project, which AST are involved in, provided it is able to go ahead (necessary licensing and mooring approvals are received in time). I hope and expect that, if it can go ahead, we will also utilise some of the £500k funding to pay for the associated sweep netting by the West Sutherland Fisheries Trust.

Hi Matt,

I send you a handful of maps so you can get an idea of the fishing that is likely to impact on your array.

Scallop, Squid, Demersal mobile, Nephrops fishing intensity all come from VMS data points that have been represented using Kernel density.

Fishing value amalgamated shows the relative value of the fishing in that area for all fisheries (Fishing value amalgamated all Scotland gives context of what the rest of Scotland looks like so you can get a sense of scale of the monetary value in MF).

I've also included an AIS map with only the fishing vessels selected for 7 months (Apr-Nov) of 2016. It is mostly useful as a footprint impression because 1) many of those vessels are just transiting 2) there is no density analysis on it.
