SGS used BS EN 1130 as the accreditation standard against which the baby box's safety was measured. The BSI said this is a "furniture standard" and there is no standard for baby boxes and they are in the process of drawing one up.

We have consistently said that the Baby Box was awarded BSEN 1130 accreditation as a crib for domestic use – the first non-commercial box in the world to do so.

The Baby Box meets all relevant safety standards in place at the time of its introduction and we will ensure that Scotland's Baby Box complies with the new standard specifically for baby boxes once it is developed.

The safety certificate issued by SGS states that the material used in the box was not tested. Was this the case and why this was not done "at request of client"? The cardboard and the ink used to make the box were tested separately and the accreditation certificates are on the ParentClub website. The manufacturer pundertook the testing as it is their design and accreditation.

Securing accreditation is the responsibility of manufacturers and the Scottish Government has only included items in the box that have the relevant safety certificates. The cardboard and the ink used to make the box were tested separately and the accreditation certificates are on the ParentClub website. The Baby Box was awarded BSEN 1130 accreditation as a crib for domestic use.

The Baby Box and its contents meets all relevant safety standards in place at the time of its introduction and we will ensure that Scotland's Baby Box complies with the new standard once it is developed.

The certificate states the material used in the lid was not tested. Was this the case? All cardboard and ink on any part of the box was tested as part of materials testing.

The lid is not to be used when the box is used for sleeping and this is made clear on the lid itself and in the safe sleeping advice included with the box and on the lid itself. As a result the lid is not tested as part of the BSEN1130 certificate for the box as a crib.

In response to Dr Peter Blair's view that there is no evidence that the boxes reduce cot death

The Scottish Baby Box was introduced to help tackle deprivation, improve health and support parents.

In response to Dr Peter Blair's view that the boxes represent a risk to a baby's health because they are so high-sided that a parent would have to hover overhead to ensure their safety.

The height of the sides of the box was set in order to meet the standards required for the baby box to achieve the BSEN1130 safety accreditation.

In response to Dr Peter Blair's view that parents should only use them for their children if "there isn't anything else available."

There is some confusion, deliberately perpetrated by some of the commercial companies that the baby boxes "meet BS and EU standards" They don't because there is no standard for a baby box. The only standard that is relatable is the EN 1130 – which was developed for cribs and bassinets which are solid pieces of furniture. The 1130 standard is a very old one and came out long before Baby Boxes emerged so not really much use in terms of testing the suitability of a cardboard box for sleeping an infant. I know that the Scottish scheme is not primarily about safer sleep or use of the box as a sleeping environment – however – it would be helpful for us given we are frequently attacked on social media in Scotland and unfairly accused of opposing the Scottish Baby Box scheme – if the Scottish Government could be public in their support of developing a standard and share your expertise with BSI in the construction of your own box.





Dear Minister,

I saw your tweet to 'Pablo Escobar' (@bigaljnr) on Twitter on 3 January, in which you invited him to contact you about the baby box's safety certification (BS EN 1130-1:1997) if the information you gave him did not answer his question. Forgive me for writing to you on the back of your exchange with him. But his interest seems to have arisen from a blog post I wrote on the subject that you have probably seen and it seems appropriate to do so. If you haven't seen the post, here is a <u>link</u>.


I am taking the liberty of asking the same question that he did, that is, are you able to make publicly available a copy of the BS EN certificate for the box (not the contents) together with the associated test results? You will see that my attempts to obtain a copy ended in an FOI response from your civil servants that it was not possible to make a copy of this documentation available. Most of the period covered by my FOI requests and the responses relate to a time before you were in office. On the basis of your tweets yesterday that I refer to above, I am very much hoping that you will see the merits of making a copy public. Unless this is done, it just is not possible to prove the various assertions that have been made about the safety of the box.

Thank you for your help. I'm sure you will understand that I would like to make any response public on my blog, although if you can provide the documentation my comment is not likely to be much more than a further 'Thank you, and well done for ensuring transparency on an important subject'.
