TRAFFICKING AND EXPLOITATION STRATEGY - STRATEGIC OVERSIGHT GROUP

NOTE OF MEETING HELD ON 2 MARCH 2017

Chair: Cabinet Secretary for Justice

Attendees and apologies at Annex A.

1. Introductory remarks by chair

The Cabinet Secretary thanked the members of the Strategic Oversight Group for their engagement with the process of developing the Trafficking and Exploitation Strategy and made the following points:

- The Strategy needs to be meaningful on the ground for victims and for agencies involved in tackling human trafficking. This Strategy will make that contribution.
- Scotland cannot operate in isolation and we must look beyond our borders and reinforce international connections, whatever happens post Brexit.
- Engagement with partners, collaboration and cooperation are crucial, exemplified by initiatives such as the Romanian police officers seconded to Police Scotland.
- Once finalised the formal review of the Strategy is due in three years, but it should be a living document that will adapt as we learn lessons.

2. Update from Lord Advocate

The Lord Advocate indicated that he was happy with the strategy subject to refinement of some of the language in it. He endorsed the Cabinet Secretary's remarks that the document reflects a commitment to action and to change.

- The Lord Advocate's Instructions for Prosecutors when Considering the Prosecution of Victims of Human Trafficking and Exploitation are operational and in use.
- Lead prosecutors have been appointed with a view to ensuring consistency and robustness.
- The Crown Office and Procurator Fiscal Service (COPFS) are in the process of rolling out training to staff. The Solicitor General is preparing a short video for this purpose.
- Cross border work continues with other Prosecutors through the Joint Commitment across the UK and collaboration with prosecutors beyond the UK.

The Lord Advocate reaffirmed his commitment to the prosecution of perpetrators and the non-prosecution of victims and noted that these principles had been evident in recent cases, including the setting aside of convictions for victims.

3. Update from Police Scotland –

indicated that Police Scotland are extremely supportive of the Strategy and are committed to driving it forward. He welcomed the Cabinet Secretary's approach to review the Strategy in real time as required.

- An update on recent Police Scotland operations was given, including the role that Migrant Help had played in establishing a reception centre for victims for some of these operations, which was seen as good practice. A focus on joint agency enforcement activity had also taken place to mark Modern Slavery day on 18 October.
- 165 NRMs were submitted between April 2016 and February 2017. 41 children and 124 adults; 92 females and 73 males. 65 victims were trafficked for the purposes of labour exploitation; 50 for sexual exploitation; 19 for forced criminality; 17 for domestic servitude and 14 for unknown purposes. The main nationalities of the victims were Vietnamese (71), Chinese (27), Albanian (14) and Nigerian (10).
- A great deal of work is ongoing between Police Scotland and COPFS and with the Independent Anti-Slavery Commissioner.

- Police officers have been seconded from Poland and Romania and Police Scotland are
 exploring the possibility of secondments from Vietnam. These secondments have been
 beneficial to both sides and have also meant the victims can be signposted to the support
 available back home.
- Police Scotland are restructuring where the Human Trafficking Unit sits within the
 organisation to make stronger links with the Serious Organised Crime Taskforce, officers and
 resources whilst maintaining the interest in Public Protection and a continued focus on
 victims.
- The co-location at the Scottish Crime Campus of a number of relevant organisations is helpful but contact with victim support processes could continue to be improved.

4. Update from TARA and Migrant Help

TARA and Migrant Help gave the group an update on support provided to victims and fed back some of the comments made by victims as part of the consultation process on the Strategy.

- Both organisations have seen a rise in the number of victims this year to date, particularly Albanian and Vietnamese in the case of TARA and Vietnamese and Chinese in the case of Migrant Help.
- Both organisations have also seen an increase in the number of women presenting in the late stages of pregnancy.
- Cases are more complex than previously.
- Presenting issues are a general distrust of authority, including the support agencies; a need for a safe place to stay; a need for early legal advice.
- TARA and Migrant Help work closely with Police Scotland to provide intelligence and with other agencies, here and abroad to provide the best possible support for victims. Broader support also includes access to positive activities locally.
- The partnership with the Anchor psychological trauma support service is seen as best practice. Trauma can affect individuals, making them hostile to engagement with police and other agencies.
- Longer term support needs for victims include: clarity about their immigration status and other legal issues; child protection; self care; social isolation. Victims' trust needs to be earned and they need to feel safe, supported and protected.

The Cabinet Secretary commented on the telling nature of the personal testimony which TARA and Migrant Help presented and the particular importance of the message around earning the trust of victims.

5. General comments on the Strategy

- The Strategic Oversight Group were supportive of the Strategy and very much welcomed the collaborative approach taken in developing it.
- COSLA welcomed the Strategy and noted that council leaders are keen to see it and take it forward. The Cabinet Secretary emphasised that local authorities are very important partners and will play a key role in making the Strategy work and raise awareness of the issue
- The Children and Young People's Commissioner for Scotland welcomed the strategy and the way in which feedback had been incorporated, but emphasised the importance of reflecting victims' voices and experiences.
- Women's Support Project, broadly supported the Strategy and welcomed the idea of the Strategy being a living document. She expressed concern that reducing the demand for prostitution / sexual services was not addressed in it but was pleased that links would be made with other strategies such as Equally Safe.
- Donald Henderson, Deputy Director, Care and Protection, Scottish Government updated the group with regard to the children's aspects of the Strategy. He also highlighted the First

Minister's commitment to supporting unaccompanied asylum seeking children and the round table that had been held the previous day.

Aberlour Childcare Trust was supportive of the strategy and asked for references to the Independent Child Trafficking Guardian to be strengthened and that it be stated that unaccompanied asylum seeking children were at a high risk of being trafficked. It was agreed that this would be discussed by the relevant people outwith the meeting.

6. Update from Kevin Hyland OBE, Independent Anti-Slavery Commissioner

Mr Hyland was also supportive of the Strategy and the consultation undertaken. He noted that it will be important that the three UK Strategies and pieces of legislation work together to address human trafficking.

The Commissioner is of the view that the National Referral Mechanism (NRM) is not working well and he is currently leading a consultation looking at how it can be reformed. Support to victims needs to be improved. In addition, the Commissioner is aware that the NRM system contains a great deal of information which could be used to disrupt the activities of perpetrators if it was effectively collated. He is clear that the crime of human trafficking needs to be treated as such by law enforcement agencies and welcomed the moves made by Police Scotland regarding crime reporting. As we move forward, he would like to see an increase in the number of prosecutions.

He has worked with Frank Field M.P. to get the Work and Pensions Committee to undertake an enquiry into how victims are supported by the benefits system.

The Commissioner's report on trafficking from Vietnam will be available in June. The problems need more than a short term solution and there are opportunities to intervene upstream. 60% of Vietnamese victims recovered in the UK are male, but none of the UK funded projects in Vietnam are for men and boys. The Commissioner's report on Greece and Italy will be available in the next few weeks.

Like the Cabinet Secretary, the Commissioner is committed to keeping relationships such as those with Europol and Eurojust going in the future.

7. Update from Willie Cowan, Deputy Director Criminal Justice Division

Willie Cowan updated the group on the work carried out over the last year by the Human Trafficking team within the Scottish Government, and thanked SOG members for their considerable and important input in developing the Strategy. He highlighted the collaborative way in which the strategy was developed and noted that such collaboration would be necessary in ongoing work to implement the legislation and the strategy.

8. Cabinet Secretary's closing remarks

The Scottish Government will consider the various comments on and amendments to the Strategy, both from the meeting and those submitted by email. The final draft will be shared before the Strategy is published and laid before Parliament by the end of May. The date of the launch will be shared with the Group once it is finalised.

The Cabinet Secretary envisages a continuing role for the Strategic Oversight Group in overseeing the implementation of the Strategy and measuring its impact.

The Cabinet Secretary reiterated his commitment to adapting the Strategy on an ongoing basis as lessons are learned and thanked the SOG for their input to date, and in the future.

As discussed at the last meeting, we're approaching the first anniversary of the Trafficking and Exploitation Strategy, and we've undertaken to report on an annual basis. I've been working on a written report to be published and submitted to Parliament, and the Cabinet Secretary for Justice may make a statement to Parliament at that time – aiming for end May / early June for this.

I've attached the latest draft report. It's still a work in progress.

I'd be grateful if you could have a look, particularly at the Action Area 3 chapter, and let me have any comments or suggested changes by Thursday 3rd May.

You'll see that the update is structured similarly to the Strategy itself, and we're also planning to have some examples of good practice and quotes from victims peppered throughout the document – these are currently at the end of the draft (some of the examples need a bit of updating). If you have additional examples you'd like to suggest I'm happy to hear them.

The separate attachment is the section reporting on the specific measures set out in the Strategy. There are two particularly relevant for our interests:

- The final measure (number of organisations with action plans or similar that contribute to delivering the aims of the Strategy) is tricky and we don't really have any way of measuring this currently – will need to make sure we make progress on this in some form over the next year.
- On public awareness we've recently completed a follow up survey which shows some
 positive movement increases in awareness of trafficking generally, a very positive shift
 from people saying they would tell friends/family if they had a concern towards telling the
 police, and 25% of respondents saying they recognised and had seen the awareness
 raising material we put out on tv and digital ads. One concerning finding is that the number

saying identifying trafficking as a serious issue in their local area actually decreased from 5% to 4% - more work to be done there. Full report on the latest survey also attached. (I've not yet updated the text of the AA3 chapter with these figures).

1. Welcome and introductions

welcomed everyone to the meeting and thanked them for participating in this important area of work. Each member of the group introduced themselves and gave a brief summary of the company they represented and their remit within the area of Human Trafficking and Exploitation.

2. Trafficking Strategy and background

provided an overview of the Scottish Government's Trafficking and Exploitation Strategy, which was published in May 2017 advised that the overall vision of the Strategy is to work, with partners, to eliminate human trafficking and exploitation. summarised the different Action Areas outlined in the Strategy. Further background was given to the wider stakeholder forum and also the corporate event also hosted by the SG, which aimed to build awareness and make connections, linking into key outcomes within Action Area 3 of the Strategy. In the Corporate Group has been established under Action Area 3 of the Strategy to support the key outcome 'People and businesses are aware of how what they do and buy can contribute to this crime'. It was agreed that members of the Corporate Group would be added to the Stakeholder Forum distribution list.

Action: to add members of the group to the stakeholder list **Action**: All to look over the key Strategy Outcomes

3. Trafficking in Supply Chains and Modern Slavery Statements

noted that the UK Modern Slavery Act (Section 54) states that organisations with a turnover of over £36m should publish a Modern Slavery Statement, however

there is no mechanism to check if this has been done or ensure compliance. advised that the Scottish Government has no locus in enforcing this but does want to support businesses and organisations to meet this requirement.

gave background on the Business Against Slavery Forum – a group of Chief Executives from major UK-based global brands which meets to discuss Human Trafficking issues, including issues in supply chains. This Group will be meeting again on 25 April and it has created a 'working group' looking at leadership, reporting against Section 54 of the Modern Slavery Act and how organisations can use assets to support the recovery of those suffering slavery. Confirmed that the SG are in contact with the UK Government (UKG) and Welsh Assembly on a range of trafficking related issues but there has as yet been no indication from the UKG on enforcement of Section 54. Confirmed that this is a journey and that there is no quick fix to some of the issues but the key action is for organisations to understand the risks within their own supply chain. Confirmed that he is happy to share materials from the Chief Executives 'working group'.

noted that the e-learning and videos produced by Stronger Together have been very powerful. 1. Welcome and introductions

The note of the previous meeting on 6 December 2017 was discussed. equested an amendment under '5. Mechanism for reporting into SIG'. The text under the fourth bullet point 'Legal support – law society needs training' should be corrected to read 'Legal support – Law Society should be engaged in training considerations'.

Action: to amend the note of meeting on 6 December 2017

noted that although the SG had not yet discussed the Child Trafficking Strategy Group (CTSG) query with the CTSG had not been amalgamated into the Action Area 1 Group and that it would continue to operate separately.

2. Awareness Raising Pack

The presentation slides and notes that SGHT team produced were discussed. Key points:

'Pack' insinuates more than one resource, 'presentation' is singular

- It encompasses the core messages about Human Trafficking and Exploitation and can be the basis for organisations to deliver awareness raising training. The presentation could be modified to meet their individual requirements.
- The chair confirmed that the messaging within the presentation is consistent with that of the Police training disc
- suggested that a simplified version of the Home Office common myths guidance would be a useful addition to the presentation.
- After discussion, the meeting agreed that the initial slide in the presentation could set out collective reporting responsibility.
 a slide on responsibility which could be reviewed and submitted for consideration.
- It would be helpful if anyone using the presentation commits to detail who the slides are being delivered to and the feedback from the audience afterwards.
 A link to the SG HT mailbox on the final slide would be useful.
- confirmed that the NRM statistics within the presentation would be updated
- Add further additional resources including posters, leaflets, newsletter, case studies, news clips of BBC coverage of McPhee case and links to other relevant strategies such as Equally Safe and Serious Organised Crime.
- suggested that the pack could be highlighted in an article for the Community Safety Network monthly newsletter. The chair requested comments/input from attendees by 5 April in order to meet the deadlines for the May newsletter. It also noted that it would be worth exploring links to the Building Safer Communities Phase 1 Group.
- Think up a catchy name or hashtag for use on Twitter
- The chair suggested that the presentation could be hosted on the COSLA website in order to oversee version control. Other organisations could offer links to the COSLA page from their individual websites. Attendees committed to updating the presentation, as time goes on, via chair.
- suggested some minor amendments are required to correct legal points.

Action: All to test the presentation with colleagues who are unfamiliar with subject.

Action: All to send comments, updates and links to chair within two weeks (by 5 April).

Action to explore obtaining McPhee case media coverage clips from BBC and the presentation created by the Senior Investigating Officer in the case.

Action: SGHT team to send prompt email to remind members of deadline for updates/additional material.

Action: SGHT team to update NRM statistics in presentation.

Action: to draft a simplified version of the Home Office common myths guidance

Action: to review and submit slide covering 'responsibility' for consideration.

Action: Chair to upload final presentation on COSLA website by mid-May. **Action**: Members to provide link via their organisation's website by end-May.

Action: SG to discuss communications approach around the 1st anniversary of the strategy.

Action: to add presentation link to CSN monthly newsletter, when available.

Action: to look into linking the group with Building Safer Communities Phase 1.

Action: to amend some legal points within the presentation.

3. Police Scotland e-learning DVD

The e-learning disc has now been produced and orders will be requested. The production cost was £234. The SGHT will control the organisations to which DVDs are issued and will maintain a log of requests. Key points made:

- Copyright will be added and a message on the disc / e-learning to say it has been produced by Police Scotland and is free of charge.
- The disc should be sent to all 32 Scottish Local Authority Community Wellbeing Boards, Scottish Ambulance Service and the Scottish Fire and Rescue Service
- The NHS have their own e-learning training
- It would be helpful to raise awareness of the disc within the business community to ensure any unscrupulous attempts to 'sell' training based on the disc content could be avoided
- A letter should be drafted containing terms of use which should be sent out alongside the disc, explaining where it was produced and what it has been designed to do.
- The disc could be launched publicly around the 1st anniversary of the Strategy
- Following discussion about the number of DVDs required, the chair confirmed that an initial order of 300 copies will be sufficient

Action: to draft a letter setting out the terms of use for the disc.

Action: to explore possible tie in with strategy anniversary communications.

4. Joint Communications Update

To keep up momentum following the media campaign a communications sub group was created and following their first meeting a communications planning document was produced to encourage joint messaging and utilising opportunities to get the core message out. The communications planning document was discussed and the chair requested any further additions from the group.

Key points:

- Add Tumbling Lassie seminar and operetta on 14th April.
- The planned Cab Sec visit to Tara on 29 March may not go ahead due to a media clash with Police Scotland's 5 year anniversary.
- The chair confirmed that discussions are contining with Perth & Kinross Council in regard to a pilot project on the licensing of Nail Bars
- Action: All to add communications events to the planner and send to the SGHT.

5. SIG preparation update

advised the meeting that the next SIG would take place on 28th March. AA1 updates will need to be provided almost immediately at the conclusion of this

meeting. Copies of the Action Plan, Progress Report Template and Risk Register documents were discussed. Key points:

- Brightworks job opportunities to Migrant Help clients big success story
- HSBC setting up bank accounts for trafficking victims big success story
- The chair suggested that moving forward, the focus of the Group should be on victims needs/awareness and making sure that victims are accessing the information available.
 Interest of the information reaches victims and that there are difficulties in how information reaches victims and that there were a numbers of barriers preventing access in some cases. TARA and Migrant Help agreed to look at what more could be done to mitigate these difficulties.

 The meeting agreed that broader awareness raising of trafficking and exploitation will assist victims to identify themselves.

advised that a discussion with TARA/Migrant Help may be required in order to explore the issues stemming from the recent court judgment against Victim Support Scotland about the quality of support provided to an applicant for Criminal Injuries Compensation. The chair suggested that this be discussed under AoB. **Action**: The chair will complete the template and submit updated documents ahead of the SIG.

6. Annual Progress Report

set out the proposed structure of the Annual Report which will be formally submitted to Parliament at the end of May 2018. The draft outline was discussed. Key points:

- Content will be around high level actions
- Include a forward look into what is hoped will be achieved in future
- Include NRM figures as evidential proof of progress and narrative
- Include results from TNS public awareness survey
- Include good news stories from Scotland cases
- Include a general narrative about ongoing support in relation to 90 days
- Average length of support 13 months use data to measure. confirmed that TARA have data on the average length of support they provide and advised that The Anchor have information about the longer-terms needs of victims and the support they provide. It is noted that it would be useful to understand the number of victims currently working with The Anchor who have left the care of TARA/Migrant Help.
- Following discussion about incorporating more material on victims into the report, and an another noted the difficulty in tracking down victims once they leave TARA/MH support.
- suggested that a letter written by a client for the Tumbling Lassie
 Operetta could be useful for the Report
- The chair suggested that it would be helpful at a future meeting to recirculate the original issues gathered from the Strategy consultation in order to understand the concerns initially raised.
- The chair requested that the proposed draft text for the Report is shared with AA1 before it is finalised.
- noted that an international perspective on Scotland's progress would be a useful addition.

Action: to gather data on The Anchor referrals and length of support required

Action: To approach client and ask permission to use her letter in report Action: Chair to add item on next meeting agenda: To hear the voices of the victims Action: To discuss draft outline at SIG and then circulate text to AA1 before it is signed off

7. AOB

The recent VSS court case has implications for TARA and Migrant Help as they support victims in accessing compensation. The advised that the judgement is a barrier to accessing entitlement for victims. It is unusual for TARA to complete a form without input from a lawyer but nevertheless the risk feels substantial for both TARA and Migrant Help. In a noted that the judgement has resulted in non-legal organisations withdrawing assistance for the completion of compensation application forms. The also advised that while legal supervision can work, there is limited financial incentive for lawyers in this area of work.

suggested that this issue needs to be considered in view of the terms and conditions of grant to clearly set out what is expected of TARA/Migrant Help.

Action: SG to meet with TARA and Migrant Help to discuss this issue further.
