#### REASONS FOR NOT PROVIDING INFORMATION

The Scottish Government does not have the information you have requested for question six because there have been no disciplinary actions taken against staff in either Education Scotland or the Scottish Government in relation to The Hamilton School.

This is a formal notice under section 17(1) of FOISA that the Scottish Government does not have this part of the information you have requested.

# Sections 30(b)(i) and 30(b)(ii) – free and frank advice and exchange of views

Exemptions under sections 30(b)(i) and 30(b)(ii) of FOISA (free and frank advice and exchange of views) apply to some of the information requested. These exemptions apply because disclosure would, or would be likely to, inhibit substantially the free and frank provision of advice and exchange of views for the purposes of deliberation. The exemptions recognise the need for Ministers and officials to have a private space within which to discuss sensitive issues arising from a special inspection of a school, particularly when the removal of registration is a possibility, before reaching a settled public position. Disclosing the content of the free and frank discussions on the special inspection of The Hamilton School will be likely to substantially inhibit such discussions in the future, particularly because these discussions involved sensitive issues.

These exemptions are subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemptions. We have found that, on balance, the public interest lies in favour of upholding the exemptions. We recognise that there is a public interest in disclosing information as part of open, transparent and accountable government, and to inform public debate. However, there is a greater public interest in allowing Ministers and officials a private space within which to explore and refine the Government's position on appropriate action following a special school inspection, like that of The Hamilton School, until the Government can reach a sound decision. This private thinking space is essential to enable all options to be properly considered, so that good decisions can be taken. Premature disclosure is likely to undermine the full and frank discussion of issues between Ministers and officials, which in turn will undermine the quality of decision making process, which would not be in the public interest.

### Section 36(1) – legal advice

An exemption under section 36(1) of FOISA (confidentiality in legal proceedings) applies to some of the information requested because it is legal advice and disclosure would breach legal professional privilege.

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is some public interest in release as part of open and transparent government, and to inform public debate.

However, this is outweighed by the strong public interest in maintaining the right to confidentiality of communications between legal advisers and clients, to ensure that Ministers and officials are able to receive legal advice in confidence, like any other public or private organisation

### Section 38(1)(b) – personal information

An exemption under section 38(1)(b) of FOISA (personal information) applies to some information which has been redacted from some of the enclosed documents. This exemption applies because the information is personal data of a third party and disclosing it would contravene the data protection principles in Schedule 1 to the Data Protection Act 1998.

This is because releasing this information could lead to the identification of pupils, staff members and members of the public in relation to the closure of The Hamilton School.

This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption.

### TWIG WORLD FOI REQUEST

### **Purpose**

1. To seek approval for the release of information pertaining to fees paid to Twig World Ltd over the past five years together with the name of associated projects, and their start and end date. This follows a Freedom of Information (FoI) request from [redacted].

### **Priority**

2. Routine – the deadline for this Fol response is **19 August 2016.** 

### Background

- 3. Twig World Ltd provide online resources through high-quality real life videos and accompanying learning materials for sciences, mathematics and social studies.
- 4. Since 2009, Twig World Ltd supplied resources have been accessible to all state schools via Glow, Scotland's national learning platform, at no cost to the end user. In Scotland, these resources are aligned to Curriculum for Excellence and our experiences and outcomes.
- 5. The nationally paid for provision was due to end in June 2015, at the natural contract expiry date. This was in line with our move away from a model of nationally procured content to enable schools and establishments to decide locally which resources to use to support learning and teaching. However, following a demand from teachers and due to the importance given to STEM within the Programme for Government a competitive procurement exercise was undertaken. Twig World Ltd were successful and licences were re-procured as a national resource in July 2015 for one year, with an optional one year extension that has since been approved. These resources will continue to be freely available to state schools until 31 July 2017.
- 6. At the end of the current contract extension it is anticipated that it should be possible for local authorities to purchase digital content, such as those provided by Twig World Ltd, via a framework agreement. To reach that point the Digital Learning and Teaching Programme team are engaging with Scotland Excel, who plan to include Education Digital Resources as an additional lot within their re-tender of the Education Materials framework with a start date of 1 April 2017.

### **Funding**

7. Since 2009, the fees paid to Twig World Ltd totalled £1,863,200 inclusive of VAT (as at 28 July 2016). The annual breakdown of this figure is as follows:

FY16/17 £64,800 (as at 28 July 2016) Note that the total value of this one year extension is £453,600.

- 8. In FYs 09/10 and 10/11, Learning and Teaching Scotland (LTS), the predecessor organisation to Education Scotland, paid Twig World Ltd a Research and Development grant to develop science related video clips from the BBC digital archive which were tagged to CfE and branded GlowScience. For that investment LTS received the Twig licence for all Scottish state schools at a reduced fee of £90,000 per annum.
- 9. In addition to the grant from LTS, Twig World Ltd received financial support of £1.7m Regional Selective Assistance (RSA) grant, £205K training grant and Scottish Enterprise Venture Fund investment. It was anticipated that Twig World's investment in Scotland's digital media sector, would create new jobs in Glasgow and provide a major new online resource providing a context for science teaching in Scotland.
- 10. Recent years payments for the national licenses have been made by Education Scotland from its core budget contribution to the Digital Learning and Teaching Programme.

### **FOI Response**

11. The requester has sought information on the fees paid to Twig World Ltd over the previous 5 years including FY 16/17 so we have based this on a start point of 1 April 2011. As such, the fees paid to Twig World Ltd over this period are £1,495,200 inclusive of VAT.

12. These fees relate to two separate contracts as detailed below:

### **Scholar**

- 14. The requester, [redacted] of The SCHOLAR Forum. The SCHOLAR forum was established in 2000 and is a not-for-profit partnership between Heriot-Watt University and The Association of Directors of Education in Scotland (ADES). The SCHOLAR forum was established with a remit to transform educational practice, manage a professional development programme in e-learning for teachers and deliver large scale e-courseware at low unit cost
- 15. The SCHOLAR forum received grant funding from Education Scotland totalling £1,289,000 over 3 financial years from FY13/14 to FY15/16. This funding was to update their resources and material in line with new Curriculum for Excellence national

qualifications. As a result of completing this activity, there was no requirement to continue the grant funding beyond 2015/16.

- 16. SCHOLAR can be accessed directly over the internet and can be accessed via Glow.
- 17. Local authorities pay an annual subscription to be members of the SCHOLAR Forum.

### **Related Fol Requests**

18. In recent weeks, there have been two other Fols relating to digital learning and teaching. These have sought information regarding costs and usage level associated with Glow. One was made by the Scottish Conservatives MSP Group and a response was issued on **2 August 2016**, while another issued on **23 June 2016** has since been made publically available at <a href="https://www.whatdotheyknow.com">www.whatdotheyknow.com</a>

#### REASONS FOR NOT PROVIDING INFORMATION

## Section 33(1)(b) – commercial interests

An exemption under section 33(1)(b) of FOISA (commercial interests) applies to some of the information requested. This exemption applies because disclosure of this particular information would, or would be likely to, prejudice substantially the commercial interests of Twig World Limited as disclosing this information would be likely to give their competitors an advantage in future similar tendering exercises, which would substantially prejudice Twig World Limited's ability to submit competitive tenders and so could significantly harm their commercial business

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open and transparent government, and to help account for the expenditure of public money. However, there is a greater public interest in protecting the commercial interests of companies which tender for, or enter into, Scottish Government contracts, to ensure that we are always able to obtain the best value for public money.

## Section 38(1)(b) - personal information

An exemption under section 38(1)(b) of FOISA (personal information) applies to some information which has been redacted from some of the enclosed documents. This exemption applies because the information is personal data of a third party and disclosing it would contravene the data protection principles in Schedule 1 to the *Data Protection Act 1998*.

This is because releasing this information could lead to the identification of staff members of Twig.

This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption.

Our client is currently involved in litigation with the liquidators of the school. We accordingly seek to obtain evidence surrounding the circumstances of the school's closure. In this regard, we would ask that you disclose to us all documents, reports and correspondence relating to your involvement in dosing the school. Essentially we are looking to obtain any evidence that the school was of such poor quality that it required to be closed down. Specifically, we understand Education Scotland instructed HM Care Inspectorate to investigate the school and we would be looking for documents instructing them as well their report.
