## FINANCIAL HEALTH CHECK

## Background

We have committed in 2018 to rolling-out a Financial Health Check (FHC) for older people and low income families:

- Our Fairer Scotland Action Plan, published in October 2016, includes a Poverty and Low Income section which pledged to tackle the poverty premium by developing a FHC service for people on low incomes. The Thriving Third Age section also pledged a FHC for older people to promote uptake of Pension Credit and Council Tax Reduction.
- Programme for Government 2017-18 included a commitment to start the rollout of a FHC Guarantee in 2018 aimed at families with children on low incomes.
- Our Every Child, Every Chance: Tackling Child Poverty Delivery Plan, published on 29 March 2018, contains specific commitments to launch a FHC Guarantee for low income families with children. The programme will be backed by £1.5 million funding per annum for 2018-19 and 2019-20.

## **FHC Delivery**

Citizens Advice Scotland (CAS) and the network of Citizens Advice Bureaux will be the delivery partners for the FHC. They offer an extensive, established and experienced advice network throughout Scotland. There are approximately 60 CAB across Scotland, offering face to face advice and telephone advice on a wide range of issues.

The FHC will offer personalised advice to people on low incomes to ensure they can maximise their income and avoid paying more for basic services. CAS estimates that this new project will deliver a FHC to approximately 15,000 additional clients.

## Commencement

The FHC service will launch on 1 November 2018.

From this date, low income families and older people can access a full financial health check in a manner which is convenient to them and appropriate to their circumstances. The check will offer personalised advice to increase people's income and reduce the 'poverty premium'. It will cover things like access to free school meals, school clothing grants, benefit uptake, council tax reduction uptake and cheaper deals on energy and other utilities to reduce household costs.
