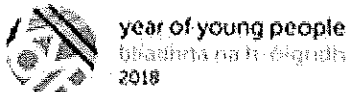

I confirm a nil response on the searches undertaken – details included in the attached document.

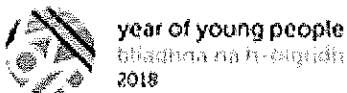

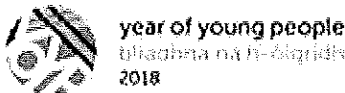

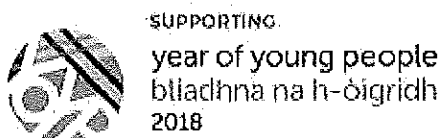
