We will contact Kilmarnock Angling Club shortly to let them know we will be on the burns surveying.

We will inform you of the results and will provide a summary report of our findings.

further to our discussion earlier this week over the timescale of electrofishing surveys that we intend to perform on the Kilmarnock and Craufurdland Waters, I confirm that we are unable to commit to any electrofishing currently in these waters due to the limited flows in the burns and the elevated water temperatures we are experiencing here in some parts of Ayrshire following prolonged drought and rising air temperatures. We visited the Kilmarnock Water this morning and found conditions unsuitable to perform any surveys.

I would have serious concerns over anyone electrofishing in the Kilmarnock Water at this point in time under these conditions and that obviously includes [REDACTED] members of Kilmarnock Angling Club who have applied for a license to do so.

I have attached an extract from an email that the SFCC circulated today to all Trusts in Scotland regarding electrofishing in unsuitable arm weather conditions. This guidance is included in the electrofishing team leader manual. I have not attached the link that followed (to the manual) [REDACTED]

[REDACTED] Several SFCC members have been in touch noting that they are suspending electrofishing due to warm and dry conditions. Fish welfare and electrofishing effectiveness are likely to be compromised in these circumstances and so caution should be exercised if considering surveying. If required, further guidance on temperature is available in the SFCC Team Leader Training Manual

This reinforces the need for adequately trained and experienced individuals to design and lead teams electrofishing. It is just one of many areas touched on in the team leader manual that isn't addressed by basic introductory courses.

I am aware that we have discussed the issues of adequate training previously however, this illustrates just another (of many) reasons why electrofishing is best undertaken by trained and qualified professionals rather than enthusiastic amateurs.

I hope this is of interest to yourselves and the department.
