

The first assurance relates to what, in extradition parlance, is called "Speciality". It is designed to ensure that a fugitive can only be tried for the offence(s) for which extradition has been agreed by the requested state. In other words it is meant to prevent requesting states pulling a fast one and putting a fugitive on trial for offences for which his extradition has not be agreed.

In our new Extradition Act 2003, there are three sections dealing with Speciality. Section 17 says that we cannot extradite to a category 1 territory (EU countries essentially) unless there are speciality arrangements between us and the requesting EU state. Section 95 covers extradition to category 2 territories (other non-EU extradition partners) and section 146 is the mirror image of section 17. However the speciality provisions in the Act do not cover states such as Pakistan which are neither category 1 nor 2. There is therefore a gap and an important one as the Pakistani legislation states that no fugitive can be surrendered if there is no provision in the law of, or in the extradition treaty with, the state asking for surrender of a fugitive. The assurance we propose to offer should fill the gap. In my view what we are dealing with here is the right of the Lord Advocate to prosecute criminals.

So far as the second assurance is concerned this is simply stating the obvious. Once we get a fugitive back he is subject to our normal criminal procedure, human rights law etc. This is perhaps more for the Scottish Ministers than the LA.

On the third assurance, I think this amounts to no more than a combination of the first two assurances but Liz will no doubt correct me if I am wrong.

My view is that I think we should tell Ministers about the assurances but not necessarily before they are given.



# EXTRADITION OF IMRAN SHAHID, ZEESHAN SHAHID AND MOHAMMED FAISAL MUSHTAQ TO SCOTLAND

In recent months you have been in discussion with the best means of seeking the extradition from Pakistan of these three fugitives from justice in Scotland. The High Commission has been good enough to obtain and provide us with a copy of the advice from Khan and Piracha about the procedure to be adopted when making a request for extradition under the Pakistani Extradition Act 1972. We have now reached the point where we can ask you to submit a request for the return of the Shahid brothers and Mohammed Mushtaq and a formal letter asking you to do so is enclosed together with the supporting documentation. We have also taken the liberty of drafting a Note Verbale to the Pakistani MFA to aid your consideration of what the Note should say. This is also enclosed. You will no doubt amend it as you think fit.

You will see from the formal letter that the location of the three suspects is given as the Lahore/Gujranwala or Toba Tek Singh areas of Pakistan. Strathclyde Police have good information that the suspects are using a mobile phone whose number is known to the police. They can therefore track the suspects to a given general area. You might wish to contact Detective Inspector, one of the main investigating officers in the case, for an update of their location from time to time and in turn advise the Pakistani authorities. His contact telephone number is +00 44 (0)141 532 or +00 44 (0)141 532. His official address is Strathclyde Police, "E" Division, London Road Police Office, 851 London Road, Glasgow G40 3RX. We would be reluctant to disclose to the Pakistani authorities how we can track the suspects' general movements in case that information was passed (inadvertently or otherwise) to the suspects. If however you judged that it was necessary to tell the Pakistani authorities we would be happy to leave such a decision to your discretion.



I am directed by the Scottish Ministers to request the High Commission to submit to the Government of Pakistan an application for the extradition to Scotland of Imran Shahid, Zeeshan Shahid and Mohammed Faisal Mushtaq.

Thank you for your letter dated 18 August 2004, addressed to the Home Secretary, on behalf of secretary, on the secretary of secret Donald. I am replying as Minister with responsibility for extradition policy.

With your letter, you enclosed articles from "the Scotsman" relating to the appalling kidnap, torture and murder of Kriss Donald in March of this year. As the articles pointed out, currently the UK has no general extradition relations with Pakistan. However our two governments are currently engaged in exploring the possibility of resolving this through the possibility of a bilateral extradition treaty.

Since 1 January 2004, the UK's extradition relations with non-EU Member States (those not operating the European Arrest Warrant) has been governed by the Extradition Act 2003 ("the 2003 Act") which gained Royal Assent on 20 November 2003 and replaced the Extradition Act 1989 ("the 1989 Act"). Under the 1989 Act, the UK could not have extradition relations with Pakistan, as Pakistan is not a signatory to the Commonwealth Scheme for the Rendition of Fugitive Offenders and the 1989 Act only allowed the UK to have extradition bilateral treaties with "foreign" (i.e. non-Commonwealth) countries. This loophole has been closed by the 2003 Act and Section 194 allows for one-off arrangements with territories with which the UK has no existing extradition treaty.

I trust this answers the points raised in your letter of 18 August and that you will find this information useful.



# CORRESPONDENCE FROM JOHN BARRATT MP ABOUT THE MURDER OF KRISS DONALD

### Purpose

1. To provide you with a draft reply to John Barratt MP in response to his letter of 3 August to the Home Secretary about the murder of Kriss Donald, to provide background to the case and to advise you of the action being taken to seek the return from Pakistan of three individuals who are wanted for their involvement in the murder.

# CORRESPONDENCE FROM JOHN BARRATT MP ABOUT THE MURDER OF KRISS DONALD

## Background

1. On 15 March 2004, Kriss Donald aged 15 years was abducted by a group of 5 Asian males from Kenmure Street in the South side of Glasgow. He was bundled into a silver Mercedes vehicle by his assailants, which then drove off. The vehicle travelled to Strathclyde Country Park, about 10 miles south-east of Glasgow, then to Dundee before returning to Glasgow in the early evening. Kriss Donald's body was discovered at approximately 7 am the following morning in the East End of Glasgow. He had been repeatedly stabbed and an accelerant poured on him and set alight. A silver Mercedes vehicle was subsequently recovered, burnt out, in the West End of Glasgow.

## The suspects

- 2. Police enquiries identified 5 individuals, all UK nationals, suspected of being involved in the abduction and murder of Kriss Donald. They are Daanish Zahid, Zahid Mohammed, Imran Shahid, Zeeshan Shahid and Mohammed Faisal Mushtaq.
- 3. Daanish Zahid and Zahid Mohammed are in custody in Scotland awaiting trial for the abduction and murder of Kriss Donald together with associated charges. Warrants were granted for the arrest of the 3 other suspects, Imran Shahid, Zeeshan Shahid and Mohammed Faisal Mushtaq, all of whom fled to Pakistan in the days following the murder. These warrants libel a charge of abduction and murder.

## Extradition from Pakistan

- 4. There is currently no extradition treaty between the UK and Pakistan, although one is currently being negotiated, and initially it appeared that in the absence of such a treaty it would be impossible to get the three suspects back for trial. And, it seemed, that so long as they remained in Pakistan they were beyond our reach and could not be brought to justice. However, the Crown Office and the Justice Department began exploring with the Home Office and Foreign and Commonwealth Office (FCO) how we might achieve their extradition. A possible means to do so was identified and confirmed by advice from the legal adviser to the British High Commission in Pakistan.
- 5. Although there are no extradition arrangements at present between the two countries, the Pakistani Government may, if it considers it expedient, extend the provisions of their Extradition legislation to non-treaty states such as the UK in relation to specific offences where a person or persons accused of such offences in the non treaty state is suspected of being in Pakistan.

6. A formal request for the extension of the Pakistani extradition legislation to the UK in respect of the offences of abduction and murder and for the extradition of the three fugitives has been prepared and sent to the British High Commission in Islamabad. It was presented to the Pakistani Ministry of Foreign Affairs on Friday 1 October 2004 under cover of a diplomatic note. A copy of the note has also been sent to the Pakistani President's Legal Adviser and to the Pakistani Attorney General, both of whom were previously been informed of the case, in an attempt to secure their support for the request.

## The Assurances

- 7. Because of the lack of a bilateral treaty setting out the basis on which requests for extradition would be dealt with we were advised to offer the Pakistani authorities certain assurances about the treatment of the suspects should they be returned. I understand that the Lord Advocate was content for the assurances to be given. These assurances were that the three named suspects:-
  - shall not, unless they have been restored or have had the opportunity of returning to Pakistan, be detained or tried in Scotland for any offence committed prior to their surrender, other than the offences for which their extradition is sought;
  - shall not be treated any differently under the Scottish criminal justice system than any other accused who are subject to criminal proceedings in Scotland; and
  - shall not be placed at a disadvantage in the absence of a permanent extradition treaty between the UK and the Government of Pakistan.
- 8. The first assurance relates to what is termed "Speciality". It is a standard provision in extradition conventions and treaties designed to ensure that a requesting state does not try a fugitive for an offence or offences for which his extradition was not agreed by the requested state, without first giving the fugitive the opportunity to leave the territory of the requesting state. The UK's Extradition Act 2003 expressly bars the extradition of a fugitive unless speciality arrangements exist between the UK and the state requesting extradition. There is a similar bar in the Pakistani extradition legislation. Without this assurance it is most unlikely that the Pakistani Government would contemplate extraditing the three suspects.
- 9. The second assurance is a statement of what would happen in any event. Once we receive a fugitive back from a foreign state he or she becomes subject to our normal laws on criminal procedure, human rights etc just like any other person in Scotland arrested and charged with a serious criminal offence. The third assurance has been offered on the basis that any treaty would be unlikely to provide any additional safeguards for an accused than already exist in Scots law.

## **Prospects of success**

10. The Government of Pakistan is essentially a military dictatorship and the laws of that country are not always upheld by that Government. Corruption is also widespread even

among the judiciary and the law enforcement agencies. Our request will not be dealt with in isolation but in the overall context of relations between Pakistan and the UK. As a quid pro quo the Pakistani's might want the return of one of their fugitives who is in the UK but such reciprocity cannot be guaranteed. Our request will also be dealt with at a pace convenient to the Pakistani authorities. On the other hand, the vast majority of the large Pakistani community in Glasgow would like to see the three suspects brought to justice in Scotland and senior figures of that community have made representations to that effect to the Pakistani Government directly and indirectly. In the circumstances however the outcome of the request is impossible to predict.

## Mr Barratt's correspondence

11. The Scotsman article which Mr Barratt's constituent has seen is critical of the Home Office and FCO for their lack of support for efforts to secure the three fugitives' extradition. The article is inaccurate. We have no complaints about the assistance we have received from the UK Government: the FCO have in fact been particularly helpful. The suggested reply to Mr Barratt while attempting to put the record straight does not reveal the action we are taking. We do not normally disclose that an extradition request has been made as a fugitive might become aware of that and flee to another country. In this particular case the fugitives are in contact with associates in Scotland so that risk is very real.

## Conclusion and recommendation

- 12. That you
  - note that a formal request has been made to the Pakistani Government for the extradition of Imran Shahid, Zeeshan Shahid and Mohammed Faisal Mushtaq for the abduction and murder of Kriss Donald;
  - note the assurances that have been offered to the Pakistani Government; and
  - reply to Mr Barratt in the terms suggested.

Thanks for this. As you hint, Sarwar's involvement is a bit of a double edged sword. So far as I am aware he has been very discreet and hopefully he will continue to be so. Pity you could not accompany him on his visit to the Interior Minister but I trust you will enjoy your visit to Afghanistan.

Mohammad Sawar MP is in Pakistan. We spoke this morning, he had made arrangements for the return of the fugitives and just needed a warrant! I expalined the realities of life to him, which he took with good grace. I stressed to him the importance of not talking freely about the case and certainly not to the Punjab Police or we would never catch the three. He rightly stressed the problems that failure to obtain extradition could cause in his constituency. (A point I said he could usefully make to the Interior Minister, see next para.)

The new Interior Minister is a friend of Sawar's and we left it that he would call on him to ask him to expedite the case and follow up iin writing copied to me. I would have accompanied him, but I have to go to Baluchistan tomorrow to monitor the Afghan elections. I do not want anyone unfamiliar with the background to accompany him, lest we get into a real mess.

This might help and I could not have headed him off anyway.



Thank you for your letter of 3 August to the Rt Hon David Blunkett, Home Secretary, on behalf of your constituent of The letter refers to an article in the 24 July edition of "The Scotsman" which claimed that the Home Office was being uncooperative with the efforts being made to secure the return to the UK of three fugitives in Pakistan who are wanted by Strathclyde Police for the murder of Kriss Donald. Your letter has been passed by the Home Office to the Scottish Executive and I have been asked to reply.

The remarks in "The Scotsman" article about the response of the Home Office, and also the Foreign and Commonwealth Office (FCO), to requests for assistance from Strathclyde Police are inaccurate and misleading. In addition, the article's claim that tensions between Whitehall and Strathclyde Police led to the intervention of the Lord Advocate is also untrue. Since it came to light that three of those suspected of involvement in the murder of Kriss Donald had fled to Pakistan, the Home Office and FCO have worked closely with Strathclyde Police, the Crown Office and my Department, which is responsible for seeking the extradition from foreign states of fugitives from justice in Scotland, to explore how their return could be secured. The Lord Advocate has informed me that he had no complaints about the co-operation from the Home Office and FCO.

Until the beginning of this year it was not possible for the UK to have extradition relations with Pakistan. Pakistan is not a signatory to the multilateral Commonwealth Scheme for the Rendition of Fugitive Offenders and the legislation governing extradition then in force only provided for the UK to have bilateral treaties with "foreign", i.e. non-Commonwealth, states. This loophole has been closed by the enactment of the Extradition Act 2003. That Act also allows for one-off arrangements with states with which the UK has no extradition treaty. The UK Government and the Government of Pakistan are currently engaged in exploring the possibility of developing bilateral arrangements for extradition between them.





Notwithstanding the absence of any current extradition arrangements between the UK and Pakistan, we are endeavouring to bring about the return of the three fugitives to stand trial in Scotland for Kriss's murder. The Home Office, and the FCO, are continuing to provide help and support in this regard.

I hope your constituent finds this response reassuring.



Thank you for your letter of 8 December to the Rt Hon David Blunkett, the then Home Secretary, on behalf of your constituent, about her concerns over the support of the United Kingdom Government for efforts being made to have several individuals wanted for the murder of Kriss Donald extradited from Pakistan. Your letter has been passed by the Home Office to the Scottish Executive and I have been asked to reply.

I understand that the individuals who are wanted by Strathclyde Police in connection with the murder have fled to Pakistan. It is not the case that the UK Government have declined to seek their extradition. It is the responsibility of the Scottish Executive Justice Department rather than the UK Government which is responsible for seeking the extradition from foreign states of fugitives from justice in Scotland.

Until the beginning of this year, it was not possible for the UK to have extradition relations with Pakistan. Pakistan is not a signatory to the multilateral Commonwealth Scheme for the Rendition of Fugitive Offenders and the legislation governing extradition then in force only provided for the UK to have bilateral treaties with "foreign", i.e. non-Commonwealth, states. This loophole has been closed by the enactment of the Extradition Act 2003. The UK Government and the Government of Pakistan are now currently engaged in exploring the possibility of developing bilateral arrangements for extradition between them.

Since it came to light that three of those suspected of involvement in the murder of Kriss Donald had fled to Pakistan, the Home Office and Foreign and Commonwealth Office (FCO) worked closely with Strathclyde Police, the Crown Office and my Department, to explore how their return could be secured. The Lord Advocate has no complaints about the co-operation from the Home Office and FCO.





Notwithstanding the absence of any current extradition arrangements between the UK and Pakistan, we are endeavouring to bring about the fugitives return to stand trial for Kriss's murder. The UK Government is continuing to provide help and support in this regard.

I hope your constituent finds this response reassuring.




Thank you for your letter of 5 December 2004 addressed to the Foreign and Commonwealth Office about the extradition from Pakistan of a number of suspects who are wanted for the murder of Kriss Donald.

Warrants are outstanding in respect of three suspects who are wanted by Strathclyde Police for their involvement in Kriss Donald's murder. It would appear that the three suspects have fled to Pakistan. Their return to the UK is a difficult issue because the UK does not have any extradition arrangements with the Government of Pakistan, although an extradition treaty between the two countries is currently being negotiated. It is not possible to say if and when these negotiations will be completed and whether or not any treaty will be signed and ratified.

In the absence of any extradition arrangements with Pakistan at the present time all possible steps which can be taken are being taken to secure the return of the three fugitives to stand trial here for Kriss Donald's murder.







#### Discussion

- 3. We have today received a very brief report from the Foreign and Commonwealth Office (FCO) about the Foreign Secretary's visit to Pakistan. Mr Straw raised the subject of our extradition request in the above case in discussion with the Pakistani Foreign Minister on 14 February but the Pakistani Foreign Minister simply "took note" of his representations. There was no flexibility evident on the Pakistani side. The FCO will, however, continue to push our request at official level in Pakistan and hope to press ahead in conjunction with the Home Office with the negotiation of an extradition treaty with the GoP. The negotiations resume next month.
- 4. You may be aware that prior to his trip to Pakistan the press reported that the Foreign Secretary was to intervene with the Government of an un-named country to try to secure the return of three suspects wanted for the Donald murder. Most of the articles also carried quotes from Mr Mohammed Sarwar MP. FCO have told us that Scotland on Sunday has been in touch with their press office which suggests that it may carry an article this weekend. The FCO used agreed press lines.

#### Conclusion

5. To note the outcome of the Foreign Secretary's representation to the GoP and the possibility of press coverage of Mr Straw's visit.



As discussed, I'm Head of Division. I am generally aware of the Kriss Donald case issues, but haven't been terribly closely involved in the detail.

The goal we all seek is actually getting these three suspects back from Pakistan for a fair trial in Scotland. I share your view that at this point it is unlikely that an interview with an FCO Minister in the Sunday Mail which effectively blamed the Pakistan Government for shielding them would be likely to achieve that goal. would, I think, be all too likely that the Pakistan Government would react in the opposite direction, possibly derailing negotiations on a bilateral treaty and/or insisting on reviving the two earlier cases where we had refused them an extradition. An interview which simply stuck to the facts and made clear that the Government was doing its absolute best to negotiate the suspects' return would in principle be fine, but there is always a question about what spin the paper would put on the facts.

The situation in the area of Glasgow (which has a large Asian population) in which the abduction of Kriss Donald occurred obviously remains somewhat tense, although attempts to exploit the situation by the BNP have hitherto been repulsed by all sides. It seems preferable to focus on low - key attempts to get the suspects back..

I note from my file that the Crown Office here wanted to add to our briefing lines on the case;

' Editors are asked to act responsibly and refrain from publishing material which could be prejudicial to any subsequent criminal investigation and prosecution'

I think that avoidance of anything which could prejudice the likelihood of a soundly based conviction should .so be a prime goal.

Happy to discuss further if that would be helpful. I have not been able to speak to the Crown Agent before e - mailing, given the timescale, but am copying to him for any comments.

# MURDER OF KRISS DONALD; EXTRADITION OF THREE SUSPECTS FROM PAKISTAN

# Purpose

1. To advise you that Mr Douglas Alexander MP, Minister of State at the Foreign and Commonwealth Office (FCO), intends to give an interview today to the Sunday Mail about this case.

### Priority

Urgent.

#### Discussion

- 3. It appears that the Sunday Mail printed an article last Sunday (20 March) which claimed that the FCO had not been active in seeking the return of the three persons wanted for the murder of Kriss Donald and who had fled to Pakistan after the killing. This is of course quite untrue. We were approached last night by FCO officials for advice about an interview which Mr Douglas Alexander wanted to give to the Sunday Mail to correct the article's misrepresentations. We expressed our concern about the proposal and pointed out that criminal proceedings are still active in this case and that nothing should be done which could prejudice the prospects of securing the return of the fugitives from Pakistan or of them receiving a fair trial once returned.
- 4. Despite our advice (and similar advice from FCO officials) Mr Alexander's office has told us that he intends to go ahead with the interview. He is aware of our concerns and his intention is simply to correct the erroneous impression given by the Sunday Mail article and no more.
- 5. Should the Sunday Mail follow this up with enquiries to our Press Office we would suggest the following lines to take:-
- there is no extradition treaty between the UK and Pakistan although one is being negotiated;
- in the absence of a treaty the UK Government are doing all they can in the circumstances to secure the extradition of the three fugitives.

The latter point reflects the fact that constitutionally it is the UK Government which is seeking extradition rather than the Executive.

#### Conclusion

6. To note that Mr Alexander is giving an interview about this case to the Sunday Mail and to agree the line to take against any press enquiries as a consequence.



# THE MURDER OF KRISS DONALD: ARREST AND RETURN OF THREE REMAINING SUSPECTS

#### Lines to take

- Must bear in mind that warrants for the arrest of the 3 remaining suspects are outstanding
  and we should not say anything which may prejudice the criminal investigation and any
  subsequent prosecution;
- I can say that the 3 suspects wanted for Kriss Donald's murder fled to Pakistan shortly after the offence was committed;
- Difficult to secure their return for trial because Pakistan is not a country with which the UK has extradition arrangements;
- Nevertheless UK Government Ministers and officials have raised the extradition of the 3
  suspects with Pakistani counterparts on our behalf and are working with them to try to
  secure their surrender. Involves difficult and sensitive issues.
- Meanwhile UK Government is currently negotiating an extradition treaty with Government of Pakistan.

### Background note

1. Although the UK has no extradition treaty with the Government of Pakistan, the Pakistani Government has the discretion to extend the provisions of its Extradition Act to states with which it has no extradition treaty. A request for it to do so in relation to the 3 suspects in this case was submitted in early October 2004.

# Related - inelevary

3. Further representations were made by the UK Government at a meeting of the UK-Pakistan Joint Judicial Co-operation Working Group in the middle of April. Since then the Pakistani authorities have asked for information to assist in the search for the 3 fugitives. This may or may not be a sign of movement on their part.

Thank you for your letter of 6 January to the Rt Hon Jack Straw, the Foreign Secretary, on behalf of about the return from Pakistan of three persons suspected of being involved in the murder in Glasgow of Kriss Donald. Your letter has been passed to the Scottish Executive and I have been asked to reply.

The extradition of fugitives from Pakistan to the UK is a difficult and sensitive issue. Until the beginning of 2004, it was not possible for the UK to have on-going extradition arrangements with Pakistan. This was because Pakistan was not a signatory to the multi-lateral Commonwealth Scheme for the Rendition of Fugitive Offenders, and the UK's legislation governing extradition only allowed for the UK to have bi-lateral extradition treaties with "foreign", i.e. non-Commonwealth, states. This loophole was closed by the enactment of the Extradition Act 2004. The UK Government and the Government of Pakistan are now currently engaged in the negotiation of bi-lateral arrangements for extradition.

Although no formal extradition arrangements exist at present between the UK and Pakistan, Strathclyde Police, the Crown Office and my Department are working closely with the Foreign and Commonwealth Office and the Home Office to explore how their return to Scotland to stand trial for Kriss Donald's murder could be secured. The Foreign and Commonwealth Office have raised their return with the Government of Pakistan on our behalf, and we are grateful for the assistance which the Foreign and Commonwealth Office has provided and is continuing to provide.

asked why the three fugitives were able to flee the country. They were able to flee because at the time no warrants had then been issued for their arrest. He is also unhappy about the media reporting of Kriss Donald's murder and of the trial of two of those involved in his abduction and murder. As you will understand, this is not something over which the UK Government or the Scottish Executive have any control. However, at the request of the prosecution, the trial judge made a Contempt of Court Order banning the media from identifying the three fugitives and from reporting





their whereabouts, among other things, for a period of 6 months from the termination of the trial proceedings. This is to ensure that once returned to Scotland they will receive a fair trial.

I hope this is helpful.





As we see it, the ball is firmly in the court of the Pakistani authorities (excuse the pun).

The HC obtained legal advice from a firm of solicitors in Islamabad in August 2004 and their advice was that a request for the surrender of the three fugitives should be made under section 4 of the Pakistani Extradition Act 1972. This particular section enables the Federal Government to apply the provisions of their extradition legislation, by means of a notification in the Official Gazette, to foreign states which do not have an extradition treaty with Pakistan, such as the UK, for fugitives who are suspected of being or are in Pakistan.

In 22 September 2004 I sent a letter to the second at the HC asking him to submit a request on that basis. The letter was also accompanied with full supporting documentation in accordance with the requirements of the Pakistani extradition legislation. The formal request was I understand lodged with the Pakistani MFA at the beginning of October 2004. I assume that in doing so the advice of the Pakistani solicitors was followed. If and when the three suspects are arrested, it will be for the Pakistani authorities to deal with them according to the requirements of their domestic legislation. If they need any information in addition to what has already been provided we would be happy to supply it. We see no need for any additional protocols such as a MoU.

Once the suspects have been cleared for extradition in due course, the normal practice would be for the GoP to notify the HC. The HC would in turn notify this Department as the originator of the request. Strathclyde Police would then be informed and agree arrangements, either through Interpol or directly with the Pakistani authorities/police, for the collection of the suspects. However, it is not unknown for decisions to be relayed from police to police with arrangements for surrender being negotiated between the two. It would fall to Strathclyde Police to send a team of officers to Pakistan to bring the suspects back to the UK.

I hope this information clarifies matters but if anything remains unclear let me know.

You may wish to consult FCO lawyers on this point as I'm not entirely sure that we would wish to use the text of the draft treaty should they require a special arrangement before being able to proceed with an ad hoc extradition request under their domestic law. As you know, outgoing extradition requests from the UK fall under the Royal Prerogative so we do not require an arrangement but understand from the Scottish Exec that the Pakistanis do.

I've separately negotiated an ad hoc arrangement with UNMIK for Kosovo and one of the issues that was raised there was the legal status that a treaty would have. We were advised by FCO lawyers that any arrangement that took the format of a treaty would have to go through the usual process before it came into force which would include publication in the UN treaty series - something we'd clearly want to avoid in an ad hoc request as it would alert the suspects that they were about to be arrested. We got round this problem by drawing up a Memorandum of Understanding - we could let you have a copy but it would need redrafting to reflect evidential requirements etc. which are slightly different and to remove any provisions that had to be included to fit in with the Kosovan Criminal Procedure

Alternatively, your lawyers could have a look at the draft Treaty and amend it to remove any "treaty wording".

As you know, we currently have 2 officers here from the Strathclyde police following up on the progress on the Kriss Donald case. Peter W and I met them, with Muhammed Sarwar MP, this morning. The officers are here to establish a police-to-police conduit through which intelligence on the three suspects can be exchanged. On this trip, they will also be handing over intelligence that should help the Pak police track them down. You should also be aware that unhelpfully, the fact that we are co-operating on these cases is now out in public.

Nevertheless, the UK police believe that it will not take long to find the suspects. We are all a

little in the dark about what needs to happen if they are apprehended. The last thing we need is for them to be returned to the UK and for the defence lawyers to ground the trial through a technicality. Does there need to be an exchange of documents between the two sides? (MFA to MFA, or AG to AG etc), do we need to have an MoU in place for this *ad hoc* arrangement?

I would be grateful if you could revert to the CPS/Home office as a priority and seek a view from them. The police believe that it would be better to have whatever arrangements were necessary in place before the suspects are arrested.

Could you also ask your CPS/HO interlocutors if there are any other procedural aspects of which we need to be aware. The UK police suppose that they will have to bring officers out to Pakistan to escort the prisoners home, but how would this happen? Would the MFA tell BHC and then we tell the police? Does INTERPOL come into the equation? Or is it the fugitive unit of NCIS.

Grateful therefore for any advice.

Thanks for this. I took the liberty of checking this again with a local extradition expert and we seem in good shape.

An update: I misunderstood the "notification" and it is - as spotted - the entry in the Official Gazette as required under section 4 of the Extraditon Act 1972. According to Agral of the Min of Interior, this has now been published (I will look for a copy tomorrow) and so the Act has been extended to the UK. So far so good. Agral told me that an enquiry officer has now been appointed who will prepare a report for the Min Interior (Agral told me that he already knew this would be +ve). On the basis of the recommendation in this report, the Min Interior will instruct the Punjab police to find and arrest the guys.

- 7. A request for the return of the Shahid brothers and Mohammed Mushtaq, who are wanted for the abduction and murder of Kriss Donald, was submitted to the Government of Pakistan in October 2004. Although there was and still is no extradition treaty between the UK and Pakistan, the latter may, if it considers it expedient to do so, extend its Extradition Act to a non-treaty state such as the UK by means of a notification in the Official Gazette. The provisions of the Pakistani extradition legislation would then apply in respect of a particular request for extradition. The request for the extradition of the three fugitives was submitted on that basis
- 8. The Pakistanis have previously shown no willingness to act on our request despite representations in support of it by the Foreign Secretary, Mr Douglas Alexander, an FCO Minister of State, and FCO officials. Mr Mohammed Sarwar MP has also been visiting Pakistan regularly and actively pressing our case. But following one such visit at the end of May, when Mr Sarwar, accompanied by staff of the High Commission, met the Minister of the Interior, this pressure appears to have had an effect with the result that the Pakistanis have taken steps to extend their extradition legislation to the UK with a view to dealing with our request. They have also sought information from us about the whereabouts of the fugitives in Pakistan.
- 9. In addition two senior Strathclyde Police officers are in Pakistan at the moment meeting Pakistani police and the latter have appointed a liaison officer through whom Strathclyde Police should deal.

Sorry not to have got back to you before.

I can confirm that the 3 suspects appeared in court on 11 August. One of my staff was present. They were asked questions by the judge about the case in the presence of their lawyer. This was done in written form and we did not have access to the answers. "Baldy" told my colleague that he wanted to go back to the UK (this chimes with what they told our Consul the previous day). The judge ordered them to reappear on 26 August. In the meantime, the judge said he would be meeting the prosecutor on 16 August to go over any details and would be making his recommendation to the Ministry of the Interior.

The judge did say before concluding the proceedings that without prejudgicing the final recomendation, the Court had noted the request of the 3 to be returned to the UK and not oppose extradition.

We expect that once the Ministry of the Interior has received his recommendation, they could take up to a week to issue the order for the extradition to take place. Once they have done this, there is a 15 day period (to allow for any appeals - unlikely in this case as they are not opposing - but the 15 days are statutory in the Extradition Act 1972). Then the suspects will be handed over to our custody.

We are currently following this up with the FIA and the Ministry of the Interior to see whether the 15 day period can be shortened, but will probably not have an answer before Tuesday.

I have been in touch with a second of the arrangements for getting the 3 home. He is likely to come out to advance once we have confirmation of the Ministry's decision. I will stay in touch with him as this progresses.

There are further details of the case in previous emails that I have sent to SAG FCO. I hope you have seen them.

It was reported on the late night news last night and again on both radio and TV this morning that the three suspects in Pakistan wanted for the murder of Kriss Donald had consented to their extradition to the UK and that they are expected to be returned next month.

Consent to extradition usually means that the fugitive or fugitives are returned within days rather than weeks as it short-circuits much of the judicial processes. On 8 August, I called on Umer H Gondal and Shaukat Ali Khan, both Dep Directors of the FIA to discuss further details of the case. Shaukat Ali Khan will be the prosecutor. They basically confirmed the details in my emails below. Just a couple of points to add:


- The suspects have engaged a lawyer (Abid Ali). Gondal and Ali Khan assumed that this meant they
  would oppose the extradition. But they had no firm evidence to back this up. This does not tally with
  what Supt MacKenzie told me on 9 August, namely that the suspects have managed to make a phone
  call to his office and left a message saying that they wanted him to come out and bring them home as
  soon as possible.
- The judge would be Ahmed Ehmad Ali who is Additional Deputy Commissioner who also holds the status of magistrate.
- At the next hearing, the lawyers would put a series of questions to the suspects the last of which would be "do you oppose extradition" (for what happens in each eventuality, see my mail below).
- The magistrate would not be judging the innocence or guilt of the suspects just whether there was a case for them to answer in the UK. Gondal and Ali Khan both beleive the case was solid. They had one of two questions of detail. I have passed Gondal's number to Supt MacKenzie to get in touch direct about these.
- The two postponements so far have been at the request of the defence. If they ask for another, the prosecutor will "resist vigorously".

I am sending I to the hearing on 11 August to get us a quick read-out.

I have spoken to the officer in charge of the Special Investigation Unit - Mr Omer Hayat Gondal (tel 9290 952/957) - who is running the inquiry into this case. I now have a clearer view of where we are and the next stage.

The three accused have now been transferred to the custody of the FIA (as the agency with federal remit). They are being housed in Rawalpindi jail (Helen to note - should we be offering consular assistance?). Gondal explained to me that the procedures laid down in Pakistan's Extradition Act 1972 mean that the 3 will be brought before an Inquiry Magistrate - in this case the Additional Deputy Commissioner General Islamabad - one Ahmet Ali Emet (sp?). The Federal Government represented by the Ministry of the Interior will act as prosecutor and the three suspects will appoint a lawyer or have one appointed for them. The initial hearing before the magistrate is set for 18 July. In the meantime they will remain in custody.

The Inquiry Magistrate will hear the evidence against the 3 and will make a recommendation as to their guilt or innocence to the Federal Government. If the recommendation is "guilty", the GoP will start procedures to hand them over to the UK will start. The length of the hearing is difficult to assess, but other recent cases have taken 3-6 months. The 3 also have the right to appeal the decision to the High Court and thence to the Supreme Court.

I asked Gondal whether the 3 could choose to be returned to the UK. Gondal said that this was academic: he had already spoken to them and they had professed their innocence and said that one of those already accused and sentenced in the UK was responsible. They said that they were afraid to be returned to the UK because they feared they would face inhumane treatment (sic).

I told Gondal that we stood ready to help in any way neccessary.

I will be on leave from Wednesday am, but Will Gelling has agreed to keep a watching brief on this.

## THE MURDER OF KRISS DONALD: EXTRADITION OF THREE SUSPECTS FROM PAKISTAN

### Purpose

1. To advise you of the latest developments with the request for the extradition from Pakistan of Imram Shahid, Zeeshan Shahid and Mohammed Faisal Mushtaq who are all wanted for their part in the murder of Kriss Donald.

### **Priority**

Immediate.

### Recent developments

- 3. It has been reported by UK news media last night and today that the Shahid brothers and Mohammed Mushtaq have consented to their extradition to the UK and that they may be returned to the UK next month. As a result of these reports we contacted the Foreign and Commonwealth Office (FCO) this morning for confirmation.
- 4. The High Commission is Islamabad has advised that the three suspects appeared in court on 11 August before the Inquiry Magistrate appointed to deal with the case. A High Commission representative attended the hearing. The function of the Inquiry Magistrate is to decide whether the suspects have a case to answer in the UK and to make a recommendation to the Minister of the Interior as to their extradition.
- 5. The suspects were questioned by the Inquiry Magistrate about the case in the presence of their lawyer. This was done in written form and the High Commission's representative had no access to the answers. The Inquiry Magistrate ordered them to appear again on 26 August but did state prior to the conclusion of the proceedings that without prejudice to his final recommendation the court had noted the request of the three suspects to be returned to the UK and not oppose extradition. The High Commission anticipate that once the Ministry of the Interior has received his recommendation it could take up to a week to issue the order for their extradition. Once this has been done there is a 15 day period to allow for any appeals which apparently is a statutory requirement. Thereafter the suspects could be surrendered.
- 6. The High Commission is currently pursuing with the Ministry of the Interior whether the 15 day period can be foreshortened but will not have an answer until the middle of next week.





I can confirm that the 3 suspects appeared in court on 11 August. One of my staff was present. They were asked questions by the judge about the case in the presence of their lawyer. This was done in written form and we did not have access to the answers. "Baldy" told my colleague that he wanted to go back to the UK (this chimes with what they told our Consul the previous day). The judge ordered them to reappear on 26 August. In the meantime, the judge said he would be meeting the prosecutor on 16 August to go over any details and would be making his recommendation to the Ministry of the Interior.

The judge did say before concluding the proceedings that without prejudgicing the final recomendation, the Court had noted the request of the 3 to be returned to the UK and not oppose extradition.

We expect that once the Ministry of the Interior has received his recommendation, they could take up to a week to issue the order for the extradition to take place. Once they have done this, there is a 15 day period (to allow for any appeals - unlikely in this case as they are not opposing - but the 15 days are statutory in the Extradition Act 1972). Then the suspects will be handed over to our custody.

We are currently following this up with the FIA and the Ministry of the Interior to see whether the 15 day period can be shortened, but will probably not have an answer before Tuesday.



I am writing to you as my MP and as the Liberal Democrat Secretary of State for Foreign affairs, to raise concerns regarding the lack of progress being made in bringing to justice those suspected of involvement in the murder of Kriss Donald.


I was incensed to read in the 16<sup>th</sup> March copy of the Scottish Daily Mail that next to nothing has been done by either the Foreign Office or the Scottish Executive to put any pressure on the country where the suspects are believed to be hiding. Whilst I appreciate that you cannot believe everything you read in the Daily Mail (especially when an election is looming) there does appear to have been very little said about the chances of extraditing the suspects in the year since the murder.

This is absolutely outrageous. It gives out the message that any suspects in a murder or any other serious crime simply have to leave the country to escape justice. We need to remember that these are suspects in a child murder case, a case that was mediaeval in its barbarity. Why is there so little being done to pressure this foreign country into hunting down and extraditing these individuals? Is this country so powerful that we cannot risk offending it? The actions of both our governments seem to be totally inexplicable.

I read recently that Jack Straw had put his considerable influence behind the campaign to bring the suspects back to Britain. I actually wrote to Mr Straw to say how pleased I was to hear that something positive was being done but it appears that this something is very little, if anything. My sense of justice is totally offended.

I do realise that this is a sensitive matter and that extradition processes are often very lengthy but can you please let me know if anything meaningful is being done and if the Foreign Office has any confidence in a positive outcome in this matter? As Shadow Liberal Democrat Secretary of State for Foreign Affairs, and a prominent Scottish MP can you bring any pressure to bear on this matter?

I have just (after some days effort) tracked down Shaukat Ali Khan, the prosecutor for the FIA. He has now confirmed how the next few days are likely (underlined!) to proceed. Apologies if previous emails have been a little contradictory, but I think now we have the story straight.

The judge is now due to produce his recommendation for the Ministry of the Interior. He has not yet done this, but Shaukat assured me that he would be seeking to get this moving "today or failing that tomorrow".

This will then proceed through the Min of Interior from the bottom up - this can typically take 4 days. The High Commissioner has spoken to the Secretary Interior to ask him to assure that there are no hold-ups within the Ministry. From recent experience in this case, they should play ball and we should see it move quickly. Once the Secretary has signed this off, a warrent for "custody and removal" is issued. It is then we have the mandatory 15 day period where nothing can happen. Even if the suspects ask to go back before, this cannot happen according to the law.

Once the 15 days are up, the suspects will be handed over to us at the airport.

The 26 August hearing will confirm the judge's decision to the suspects but we do not have wait for that before the Min of Interior does the paperwork.

I apologise for the delay in replying to your letter; I did not in fact receive your earlier letter of 4 April.

As you may be aware from reports in the media in Scotland, there have been significant developments in the case since you wrote. The three suspects have been arrested and have appeared in court in Pakistan with a view to their extradition to the UK. The matter is being taken forward in accordance with the law governing extradition in Pakistan and I am hopeful that the Government of Pakistan will agree to their return to the UK shortly.

The request for the extradition of the three suspects was submitted to the Government of Pakistan in October last year and, as your constituent readily appreciates, the process can often take some time irrespective of the country to which the request is made. But at the outset the UK Government, on behalf of the Scottish Executive, also made its views known to the Government of Pakistan about the importance which we attach to the successful conclusion of this request. I raised the matter with the Pakistani Foreign Minister in February this year, Douglas Alexander also raised the matter on several occasions with Ministers in the Pakistani Government and my officials in the High Commission in Islamabad have taken every opportunity to argue the case for extradition of the suspects with Ministers and senior officials in the Pakistani Government.

The considerable efforts which we have made to secure the suspects' return, and which, more often than not, are not publicised, now appear to be bearing fruit and I am optimistic that the matter will be brought to a successful conclusion soon.

# THE MURDER OF KRISS DONALD: EXTRADITION OF THREE SUSPECTS FROM PAKISTAN

### Purpose

1. To advise you of the assessment of the British High Commission in Pakistan of the earliest date when the Shahid brother and Mohammed Faisal Mushtaq could be available for extradition to the UK.

### **Priority**

2. Urgent

#### Assessment

- 3. Senior officials in the High Commission in Islamabad have discussed with the prosecutor the next steps in the case. Following the hearing on 11 August, the Inquiry Magistrate is due to produce his recommendation for the Ministry of the Interior. He has not done so yet but the prosecutor has undertaken to see if he could expedite matters.
- 4. Once the Inquiry Magistrate's recommendation has been received in the Ministry of the Interior it may take up to 4 days to process. The High Commissioner himself has spoken to the Secretary of the Interior Ministry and requested that delays within the Ministry be avoided. From recent experience with the case, the High Commission think that Pakistani officials will co-operate and expect matters to progress quickly.
- 5. Once the Interior Secretary has agreed the Inquiry Magistrate's recommendation and assuming it is to the effect that the three suspects have a case to answer and should be surrendered to the UK, then a warrant for custody and removal would be issued. It is at this stage that there is a statutory 15 day period to allow for any appeal. This is unlikely as the three suspects have indicated a wish to return to the UK. Even if the suspects request to be returned early this cannot be effected until the 15 day period has expired. Once the 15 day has elapsed the suspects will be available for extradition.
- The further court hearing arranged for 26 August, to which I referred in my minute of 12 August, is simply to enable the Inquiry Magistrate to inform the suspect of his recommendation and should not hold up the Interior Ministry's processing of that recommendation. Accordingly, in the High Commission's assessment the three suspects may at the earliest be available for extradition during the week beginning 5 September.

I copied you into my submission of 18 August about the British High Commission in Pakistan's assessment of the earliest date when the three suspects were likely to be extradited.

The submission mentioned a court hearing to be held on 26 August. We have now had a read out from the FCO about that hearing.

Apparently it was uneventful with the Investigating Magistrate informing the suspects that he had finalised his report containing his recommendation about the case and which he would be sending to the Ministry of the Interior. He did not disclose his recommendation. Once the Ministry receives the report, and if they agree with the recommendation, they will issue an extradition warrant. Once the warrant is served on the suspects there will be a 15 day period in which they may appeal but this is not thought likely. Thereafter they will be available for extradition.

There was one journalist present at the hearing and it appears that she will be looking to place an article in tomorrow's Scotsman. Against the possibility of press enquiries the following lines to take have been agreed with the Crown Office.

- Welcome the further progress being made in the request for the extradition of the three suspects wanted for their alleged involvement in the murder of Kriss Donald;
- Look forward to a final decision being made on the matter in the near future.

Please note that no reference should be made to the country in which the suspects are currently being held.

Extradition Debrief

The visit was first class and it will happen. After lengthy debate and discussion we were assured that the prisoners would be available for deporting on or after the 23 September 2005. We provisionally booked everything for extradition on Friday 31 September with a fall back date of Sunday 2 October 2005.

No commitment was given but all parties were happy to block out the dates chosen. Escorts were arranged, warrants drafted for those days, the prison notified as were airport security. We had the agreement of the British Airways Operations Manager for Afganistan and Pakistan to carry all three on board a single flight. He agreed to sell us totally flexible tickets for the cost of fixed tickets, a saving of at least £15K. We can get all flights fully flexible for less than £20K on World Traveller Plus. That is ten full returns Glasgow to Pakistan and three singles. Negociated a special deal at the hotel of \$140 a night....the High Commission rate, which is about a 40% discount. Cheapest Portman Travel could get was about the same in pounds 160 pounds not dollars, All looked great.

Got hit with a bomb shell on Saturday when BA London refused to permit any more than one on each flight. We again made new provisional arrangements and we are now looking at all our

The High Commission in Islamabad has confirmed that the Pakistani Minister of the Interior has signed a warrant for the extradition of the three fugitives. It was hoped that a copy of the warrant would be served on each of the three suspects on Saturday 17 September from which date the 15 day period in which they could appeal against the decision to extradite them would begin. Subject to any appeal, arrangements are being made to return the suspects to the UK as soon as possible after the 15 day period has expired. All going well the earliest they could be surrendered to Strathclyde Police and brought back to the UK is the first week of October.

#### Conclusion





#### ISSUE

1. Whether you should write to Pakistani Interior Minister Sherpao to thank him and Pakistan for co-operation in securing the arrest and agreeing the extradition of the suspects in the Kriss Donald case.

#### TIMING

2. Routine. The suspects returned to the UK on Wednesday 5 October.

### PREFERRED OPTIONS

3. That you write to Pakistani Interior Minister Sherpao along the lines of the attached draft (Flag A). This will also be an ideal opportunity to raise the bilateral extradition treaty, which is waiting approval by Pakistan's cabinet.

# ARGUMENT & BACKGROUND

4. Teenager Kriss Donald was brutally murdered in Glasgow in March 2004. Two of the suspects were arrested, but three others fled to Pakistan. We do not currently have an extradition treaty with Pakistan, but an ad hoc request for extradition was originally handed over to the Government of Pakistan in September 2004. However, little progress was made. Following discussion at the UK-Pakistan Joint Judicial Co-operation Working Group in London in April 2005, the Pakistanis have been much more co-operative. The police arrested the suspects and the Interior Ministry was instrumental in changing Pakistani legislation to allow extradition of suspects to the UK for a specific offence. The

- 5. Bringing suspects to justice will have extra significance in this case, as it will help to diffuse community tensions in the Glasgow area.
- 6. We have concluded negotiations over a bilateral extradition treaty with Pakistan, and UK Ministers have approved the text. There has been a delay in securing signature as the treaty needs to be approved by Pakistan's cabinet first. Once the treaty is signed, it will need to be ratified by both countries.

# PARLIAMENTARY AND MEDIA

- 7. There has been widespread media coverage of the Kriss Donald case, particularly in the Scottish press. We expect this to continue as the case goes to court.
- 8. Mohammed Sarwar is the MP for Glasgow Central and has played a critical role in this case, liaising with the police and frequently travelling to Pakistan to lobby the authorities to secure the suspects' extradition.

9. There are no risks involved in writing to Interior Minister Sherpao. Following this case, Pakistan is likely to reciprocate by handing over ad hoc extradition requests to the UK. The Crown Prosecution Service is happy to consider these and has offered Pakistan assistance in this regard. But we already know that the two most high profile cases are unlikely to stand up in UK courts.

# THANKING PAKISTAN FOR EXTRADITION OF KRISS DONALD SUSPECTS

#### ISSUE

1. Whether you should write to Pakistani Interior Minister Sherpao to thank him and Pakistan for co-operation in securing the arrest and agreeing the extradition of the suspects in the Kriss Donald case.

#### TIMING

2. Routine. The suspects returned to the UK on Wednesday 5 October.

## PREFERRED OPTIONS

3. That you write to Pakistani Interior Minister Sherpao along the lines of the attached draft (Flag A). This will also be an opportunity to raise the bilateral extradition treaty, which is waiting approval by Pakistan's cabinet. Any letter should also express condolences for the earthquake victims.

# ARGUMENT & BACKGROUND

4. Teenager Kriss Donald was brutally murdered in Glasgow in March 2004. Two of the suspects were arrested, but three others fled to Pakistan. We do not currently have an extradition treaty with Pakistan, but an ad hoc request for extradition was originally handed over to the Government of Pakistan in September 2004. However, little progress was made. Following discussion at the UK-Pakistan Joint Judicial Co-operation Working Group in London in April 2005, the Pakistanis have been much more co-operative. The police arrested the suspects and the Interior Ministry was instrumental in changing Pakistani legislation to allow extradition of suspects to the UK for a specific offence. The

Interior Ministry also covers the police and the Federal Investigation Agency which both played key roles in the arrest and extradition of the suspects.

- 5. Bringing suspects to justice will have extra significance in this case, as it will help to diffuse community tensions in the Glasgow area.
- 6. We have concluded negotiations over a bilateral extradition treaty with Pakistan, and UK Ministers have approved the text. There has been a delay in securing signature as the treaty needs to be approved by Pakistan's cabinet first. Once the treaty is signed, it will need to be ratified by both countries. Islamabad judge that the earthquake could indirectly delay the signing of the treaty.
- 7. You already spoke to Foreign Minister Kasuri, and the Prime Minister spoke to President Musharraf following the earthquake. Hilary Benn also met President Musharraf and Prime Minister Shaukat Azaz in Pakistan last week. So far no British Minister has written to Interior Minister Sherpao to express condolences.

## PARLIAMENTARY AND MEDIA

- 8. There has been widespread media coverage of the Kriss Donald case, particularly in the Scottish press. We expect this to continue as the case goes to court.
- 9. Mohammed Sarwar is the MP for Glasgow Central and has played a critical role in this case, liaising with the police and frequently travelling to Pakistan to lobby the authorities to secure the suspects' extradition.

#### RISKS

10. There are no risks involved in writing to Interior Minister Sherpao. Following this case, Pakistan is likely to reciprocate by handing over ad hoc extradition requests to the UK. The Crown Prosecution Service is happy to consider these and has offered Pakistan assistance in this regard. But we already know that the two most high profile cases are unlikely to stand up in UK courts.

I have been to Pakistan 3 times and have had a series of meetings in London with various personalities. I would like the following to receive letters of appreciation.

In the very early days of the extradition process Her Excellency the Pakistan High Commissioner to the UK was wonderful. She heard my briefing on the case and I stressed the importance, in terms of Community Relations, of getting the three accused back to face trial. She pledged her support and agreed that a one off extradition could be achieved without any reciprocal demands from Pakistan. She did lobby the Pakistan Government on our behalf.

Muhammad Shoaib SUDDLE, Director General, National Police Bureau, Pakistan Ministry of Interior was another pioneer on our behalf. He attended a meeting with Home Office and the FCO in London on 20 July 2004 where he promised to lobby on our behalf from within the Ministry of Interior. I spoke to him a number of times on the phone and he did a lot in the margins to help our cause. His support is greatly appreciated.

My first trip, 6-9 June 2004 was very much a covert visit to establish police to police liaison and to try to secure the support and assistance of all the law enforcement and intelligence agencies. I also took with me a very comprehensive profile of the accused and of their activities in Pakistan. I gleaned this intelligence from an amalgam of sources some secret, so I had to establish a two way trust regarding the provision and handling of delicate intelligence. The outstanding personalities who helped me make it work were as follows.

'ariq PERVEZ the Director General of the FIA in Islamabad. He was outstanding and vowed to support the investigation with his considerable resources.

his assistant

Dep Director, Head of Operations Asif A SYED is the Interpol single door of contact. He showed me the photos sent to him by British Interpol (NCIS Fugitive Unit) which were a disgrace. He also showed an instruction from the UK not to continue with any investigations re Kriss Donald Murder dated 3 May 2004. He and I sorted out these nightmares and he offered his full support to the Punjab police in tracing the accused.

I then travelled to Lahore where I met with the Director of Intelligence for the Punjab Police he listened to my plea for assistance and agreed to help at this stage I cannot confirm to what level he assisted. I will leave him out for now.

I then met the Additional Inspector General (AIG) - Investigations at the Punjab Police HQ in Lahore. Irfan Mahmood KHAN known as Irfan was undoubtedly going to be the key to success. We met over two days discussing the case, the accused and the intelligence profiles. He embraced the cause and we set out a strategy to affect their arrest. Part of that strategy at my behest for him to appoint an in investigating officer

to work with me daily exchanging intelligence, information and developing tactics. He introduced me to

Supt Jawad DOGAR known as Jawad. He is a senior investigator with the Punjab Police under Irfan's command. He talked for a couple of days, bonded brilliantly and established a means of regular if not daily contact. That relationship culminated with the arrest of all three suspects in time for Kriss Donald's 16 birthday on 2 July 2005.

Jawad should be congratulated for his professionalism and his commitment to this case.

My next two visits covered extradition processes, planning and the logistics of returning the three accused to Scotland, safely and securely, to face trial. Many people were seen and advise sought from many corners however certain individual stood out for their efforts.

Second Visit was from 31 August 2005 to 4 September 2005

The Final visit was from 29 September 2005 to 5 October 2005 when their extradition was completed safely and without serious incident.

The first individual who was magnificent from the day he took over the case was Peter BOXER. He was a breath of fresh air compared to his previous incumbent. He was professional, approachable, contactable and reacted to requests with a degree of urgency not previously experienced. He often gave up his own to speak to me or to meet me when I was in Islamabad. I did give him a litre of rather nice malt for his efforts!! He deserves a warm letter of appreciation

His boss European the Commissioner Peter DANIELS, another Scot, in Karachi. He listened to my pleas for assistance and offered his full support.

Shaukat Ali KHAN of the FIA. He is the FIA Deputy Director (LAW). He adopted the role of public prosecutor and he kept Peter BOXER and me right on the processes and on the granting of the extradition warrants. He also appeared in court and led the case for the prosecution. Another real star who battled away for our cause

Umar H GONDAL known as Gondal who is the FIA Deputy Director covering the Islamabad and Rawalpindi area. The jail was in Rawalpindi. We met often to plan the logistics. His officers served the varrants and arranged the prisoner escorts and handover

Finally to British Airways

met all my requests and made all the arrangements on my behalf. Both worthy of a letter.

Previously mentioned (the second was a real star in terms of 10 cops and 3 accused getting through the airport and safely onto the plane. He was professional, paid attention to detail and was extremely supportive. Richly deserves a letter.

Finally to Castal and his crew. (Islamabad to London) Richard is yet another Scot who has the last say on how the prisoners are escorted. I intended to dominate the three accused throughout the flight so that other passengers felt comfortable and there was no opportunity for any of the prisoners to jeopardise safety. I met the Captain twice and we discussed my plans in detail. I made many requests of him nd his crew all of which met no resistance in fact total cooperation in the most pleasant manner. He even neld all the passengers in their seats so we could disembark first, making an announcement as we left thanking Glasgow's finest and wishing us luck. He and his crew were brilliant and incredibly supportive.

That is it the first that is it is a seful.

Thursday is good but 1100 hours perhaps not. will confirm new time on Monday.

The extradition process was frustrating but extremely rewarding in the end, especially when many were sceptical. In policing terms it was an incredible journey. To be able to maintain the level of intelligence that traced and facilitated the arrest of three fugitives from Glasgow in a country as vast, as remote in parts and most significantly a country which houses a population of 150 Million people is as incredible as the success of the historical extradition process.

# THE MURDER OF KRISS DONALD: EXTRADITION OF SUSPECTS FROM PAKISTAN

#### Purpose

1. To suggest that the Minister for Justice issues letters of thanks to the Foreign Secretary, and also to the heads of the Pakistani Federal Investigation Agency and the Punjabi Police for the part which they played in securing the extradition of the three suspects in this case.

# **Priority**

2. Urgent. The suspects were returned on 5 October.

#### Discussion

- 3. Following the return of the Shahid brothers and Mohammed Mushtaq, it would in my view be impolite not to acknowledge the significant contribution made by the FCO to the successful outcome of this extradition case.
- 4. The help and assistance which the Executive received from the FCO was outstanding, particularly from senior staff at the British High Commission in Islamabad. Staff at the High Commission were responsible for identifying a possible solution to the problem caused by the absence of any extradition treaty between the UK and Pakistan. The potential solution was that the Pakistani extradition legislation could be extended non-treaty states such as the UK to enable an ad hoc extradition request from such a state to be dealt with. However any extension would be at the discretion of the Pakistani Government.
- 5. Following the submission of such a request in October 2004, FCO Ministers and officials in both Islamabad and London took every opportunity to lobby Ministers and senior officials in the Pakistani Government to extend their extradition legislation to the UK and to extradite the three suspects. And once extradition had been agreed, the High Commission staff ensured that all the necessary organisational arrangements for the smooth return of the suspects from Pakistan were in place, from the issue of temporary passports to persuading British Airways to accept all three suspects on the one flight.
- 6. The FCO intend to send letters of thanks to the Pakistani Minister of the Interior, Mr Aftab Ahmed Khan Sherpao, whose role was crucial in taking forward the extradition request. They also propose to write to British Airways. The FCO have also suggested that the Executive sends messages of thanks to the Pakistani Federal Investigation Agency (the national police force) and the Punjabi Police. Both come under the oversight of the Ministry of the Interior, and played important roles in the arrest and extradition of the suspects. In



particular the Punjabi police were responsible for working closely with Strathclyde Police to trace and locate the three suspects and arrest them.

- 7. Because requests for extradition directed to non-EU states such as Pakistan are made on behalf of the Scottish Ministers rather than COPFS it would in my view be appropriate for the Minister for Justice to write to the two Pakistani police forces expressing gratitude for their assistance in this case.
- 8. I understand that the Lord Advocate has already written to Mr Mohammed Sarwar, MP to thank him for the important and influential role he played in the successful outcome of this case. The FCO have acknowledged that it is unlikely that the suspects would have been returned to Scotland as soon as they were without Mr Sarwar's intervention.



I am writing on behalf of Colin Boyd QC, the Lord Advocate of Scotland, and myself to express our gratitude to you and officers of the Federal Investigation Agency for the co-operation and assistance we received from your Agency at various levels in securing the extradition to Scotland of Imran Shahid, Zeeshan Shahid and Mohammed Faisal Mushtaq, all three of whom are suspects in the murder of Kriss Donald in Glasgow in March 2004.

This was a brutal crime and it was important for a number of reasons that the three accused, who had fled to Pakistan shortly after the murder, be returned to Scotland to stand trial. I am writing on behalf of the Colin Boyd, the Lord Advocate, and myself to express our grateful thanks for the excellent support, co-operation and assistance which the Foreign and Commonwealth Office provided to the Scottish Executive in securing the successful extradition from Pakistan of three suspects wanted for the murder of Kriss Donald in Glasgow in March 2004.

We are grateful to both you and Douglas Alexander for your interventions with Ministers in the Government of Pakistan on our behalf. And we much appreciate the very hard work carried out by your officials in London and Islamabad to secure a most satisfactory outcome to this case.

Without doubt this was a difficult extradition request because of the absence of any extradition arrangements between the UK and Pakistan. It was also sensitive because of the particular circumstances of the crime. It presented a unique challenge to the Scottish Executive and the Foreign and Commonwealth Office and we are most grateful to the way in which your officials, and in particular Mark Lyall Grant, the High Commissioner, and his staff, responded so well to that challenge.

I feel I must make special mention of the contribution of Peter Waterworth, who identified a solution to the difficulties caused by the absence of an extradition treaty between the UK and Pakistan and the willingness of senior diplomatic staff, mainly in Islamabad but also in London, to take every opportunity to argue the case for extradition with Ministers and officials of the Government of Pakistan.

I should also single out Peter Boxer at the High Commission for special mention. He was the main point of contact both for our officials and for Strathelyde Police. He was professional, approachable and reacted to all our requests with a high degree of urgency. His help was invaluable.





We do not believe that the three suspects would have been returned to the UK so relatively quickly, if at all, without your and Douglas's intervention and the considerable of amount of work undertaken so willingly by your officials in both London and Islamabad on our behalf.
