I was upset to read reports in the press about patients having to go without clean bed linen and towels at Glasgow's Queen Elizabeth University Hospital over the festive period, increasing the risk of the spread of infection. My principal reason for writing is to say that, if ever this situation should arise again, please do not hesitate to get in touch with me and we will do whatever we can to help, as a matter of urgency.
