# Saudi Arabia - Update on Murder of Journalist Jamal Khashoggi

On Thursday last week, Saudi Arabia's public prosecutor concluded that an intelligence officer ordered Jamal Khashoggi's murder, and not Crown Prince Mohammed bin Salman. A spokesman said that the officer was tasked with persuading the dissident journalist to return to Saudi Arabia and that Khashoggi was given a lethal injection after a struggle in the Saudi consulate in Istanbul on 2 October. The public prosecutor has charged 11 people over the murder and is seeking the death penalty for five of them.

There has been reporting in the US over the last few days that the CIA has concluded that the Saudi Crown prince did in fact order the killing of Jamal Khashoggi. The CIA's assessment was first reported on Friday by the Washington Post. The President on Saturday was reported as saying the CIA assessment was "very premature" but "possible". The President also confirmed he will receive a complete report on the case on Tuesday (19/11).

State Dept spokeswoman Heather Nauert said in a statement: "recent reports indicating that the US government has made a final conclusion are inaccurate."

The UK Permanent Undersecretary visited Riyadh on 11 November as the Prime Minister's Envoy on the Khashoggi killing. The Saudis affirm their sincere intention to deliver credible investigation, accountability for those responsible, and restructure of national security systems to prevent a repeat.

The UK Foreign Secretary then visited Saudi Arabia and UAE on 12 November to intervene directly with senior Saudi, Emirati, Yemeni and Omani leaders on the humanitarian crisis in Yemen. He also reinforced the Permanent Undersecretary's message on the Khashoggi killing.

The credibility and integrity of the Saudi investigation and subsequent judicial action is clearly paramount in moving the position forward. We will offer a further note if there are significant developments in the case.

All,

We have a debate in Parliament on Thursday on our inaugural Contribution to International Development Report, led by our Minister Ben Macpherson. With Saudi Arabia still very live in the news, I noticed Ross Greer over the weekend in particular tweeting re "Saudi Arabia's arms dealer manufacturers from Fife". And that SDI had cancelled its RE expert proposal for SA.

Could we please get a core brief on Saudi Arabia, arms sales from Scotland, and ethical trade policies for our Minister to have for the debate? By lunchtime tomorrow if possible please. This will almost certainly be raised by Ross Greer in Chamber, as he has previously raised ethical trade and other SG policies in committee when SG's commitment to policy coherence for development has been raised. (policy coherence for development being that "flow through" of work to support/not harm developing countries, across govt).

The context here is that our Report takes a holistic look at a wide cross-section of Scottish Government international development activity, and presents it within the context of the UN Global Goals. In the Report we consider some of the "do no harm" policies that SG already has in place, eg our Climate Change policies, and then also report on the "additional positive contributions" that other Directorates make (eg Water, Health and Climate Justice Fund) on top of our own international development funding and work. The point that may therefore be made in debate is that SG's "do no harm" policy falls down when it comes to trade policies, with Minister asked to answer that

FMQ Brief: Saudi Arabia

**ISSUE:** Jamal Khashoggi was a Saudi-born journalist who worked for the government, but eventually became one of its most prominent critics. On 2<sup>nd</sup> October 2018, Mr Khashoggi attended the Saudi Arabian Consulate in Istanbul and did not emerge. The Saudi Arabian government has acknowledged that Mr Khashoggi died inside the Consulate, claiming this was the result of a "rogue" operation to confront expat dissidents. Saudi Arabia continues to strongly insist that no member of the Royal family was involved in, or authorised, the operation.

The UK, France and Germany issued a joint statement expressing shock at the death and demanding a full explanation. US President Donald Trump said there had been "deception" and "lies" in Saudi Arabia's explanation.

There are no current proposals for Scottish Government diplomatic engagements with Saudi Arabia. This week, the Scottish government suspended plans to appoint an energy specialist to boost exports to Saudi Arabia.

# **Top Lines**

# Saudi Arabia - Jamal Khashoggi killing

# Who was Mr Khashoggi?

Jamal Khashoggi was a Saudi-born journalist who worked for the government, but eventually became one of its most prominent critics. It is generally accepted that he worked for the Saudi intelligence services at various points during his life, and he was extremely well-connected – to members of the royal family, and the intelligence services both in his home country and in the West.

He worked for a number of Arab media outlets and, during his career, became a critical political commentator, falling foul of the Saudi establishment and being removed from the editorship of a prominent newspaper. He worked for a number of international news outlets including the BBC and Al Jazeera.

In 2016, he was banned from appearing on television in Saudi Arabia, and asserted that the government had also tried to enforce a Twitter ban on him. He fled the country and relocated to the US, when he began working for the *Washington Post*, continuing to publish articles critical of the Saudi state, its various diplomatic disputes and the war on Yemen. In 2018, he established a new political party called *Democracy for the Arab World Now*, and wrote that Saudi Arabia:

"should return to its pre-1979 climate, when the government restricted hard-line Wahhabi traditions. Women today should have the same rights as men. And all citizens should have the right to speak their minds without fear of imprisonment."

# The killing

On 2<sup>nd</sup> October 2018, Mr Khashoggi attended the Saudi Arabian Consulate in Istanbul to obtain documents relating to a previous divorce. He did not emerge from the building and was reported missing. Reports began to circulate that he had been attacked and killed inside the Consulate, and that his body had been dismembered and removed. The Saudi authorities asserted that he had simply left via a back entrance, insisting that such reports were "baseless".

However, on 19th October, it was acknowledged by an anonymous Saudi official that:

- A 15 member team had travelled to Turkey to "confront" Mr Khashoggi as part of an initiative to "persuade" expatriate dissidents to return home;
- The team had gone "rogue", threatening Mr Khashoggi, who subsequently resisted and was restrained;
- As a result of the restraint he lost consciousness and died; his body was disposed of; and
- An investigation would be conducted, and five senior Saudi officials would be immediately removed from their posts.

It was later announced that 18 people had been arrested in connection with the investigation. Saudi Arabia continues to insist that no member of the Royal family was involved in, or authorised, the operation.

#### International Reaction

In a Washington Post interview on Saturday, US President Donald Trump said there had been "deception" and "lies" in Saudi Arabia's explanation, having previously said he found their initial denial and narrative to be credible. He raised the possibility of imposing sanctions but said halting an arms deal would "hurt us more than it would hurt them".

The UK, France and Germany issued a joint statement expressing shock at the death and demanding a full explanation, saying: "Nothing can justify this killing and we condemn it in the strongest possible terms."

German Chancellor Angela Merkel has said she will not allow arms exports to Saudi Arabia to continue given "the current circumstances", and Canadian Prime Minister Justin Trudeau has threatened to cancel a multi-billion dollar defence contract with the kingdom over the affair.

The Secretary of State for International Trade, Liam Fox, French finance minister Bruno Le Maire, Dutch finance minister Wopke Hoekstra, United States Secretary of the Treasury Steven Mnuchin, International Monetary Fund Managing Director Christine Lagarde all withdrew their participation in the Saudi Future Investment Initiative conference, due to take place this week. The Government of Canada has also indicated that they have no intention of sending anyone to the conference. A number of leading businesses and international finance executives have also confirmed they will no longer attend.

Turkish President Recep Erdogan has indicated that he will make a statement to Parliament on the progress of the investigation today (23<sup>rd</sup> October).

There are no current proposals for Scottish Government diplomatic engagements with Saudi Arabia.

SDI currently maintains an office in Al Khobar, Saudi Arabia, and had been in the process of recruiting for a trade specialist in the region to focus on the oil and gas sector. As you are aware, a decision was taken over the weekend to suspend that recruitment process in light of the current situation.

VisitScotland is currently in talks with Emirates Airlines to run a 4 day project in Edinburgh which will involve a Saudi social media influencer promoting Scottish leisure activities to his 1.2m online followers. This project has been assessed as low-risk, and VisitScotland have undertaken the requisite due diligence in relation to the influencer's trip to Scotland.

We are still collating information regarding other collaborations across SG, but initial indications are that ongoing activity is limited. We will provide an update and further advice in due course.

You are invited to note the position.

Joint statement by Foreign Secretary Jeremy Hunt, Foreign Minister Jean-Yves Le Drian of France and Foreign Minister Heiko Maas of Germany:

The violent death of Jamal Khashoggi, within the premises of the Saudi Consulate General in Istanbul had been feared for many days but its confirmation still comes as a shock.

Nothing can justify this killing and we condemn it in the strongest possible terms.

Defending freedom of expression and a free press are key priorities for Germany, the United Kingdom and France.

The threatening, attacking or killing of journalists, under any circumstances, is unacceptable and of utmost concern to our three nations.

Our thoughts are today with Mr Khashoggi's family, his fiancée, and his friends - who have worried about him for weeks, and to whom we extend our most heartfelt condolences.

We take note of the Saudi statement which gives their preliminary findings.

Yet there remains an urgent need for clarification of exactly what happened on October 2nd – beyond the hypotheses that have been raised so far in the Saudi investigation, which need to be backed by facts to be considered credible.

We thus stress that more efforts are needed and expected towards establishing the truth in a comprehensive, transparent and credible manner.

We will ultimately make our judgement based on the credibility of the further explanation we receive about what happened and our confidence that such a shameful event cannot and will not ever be repeated.

We therefore ask for the investigation to be carried out thoroughly until responsibilities are clearly established and that there is proper accountability and due process for any crimes committed.

We will stay in close contact with our Saudi partners in that regard.

The quality and significance of the relationship we have with the Kingdom of Saudi Arabia also rests with the respect we have for the norms and values to which the Saudi authorities and us are jointly committed under international law.
