For me that is the correct score for candidate [redacted]. They were not someone I would have selected for interview if it was just up to me.

I agree with [redacted] about the scoring of the priority criteria and merits of broad and shallow versus narrow and deep and cognoscent that whatever choices we make we need to remember the credibility of the board in the eyes of both farming industry and generally — but am more relaxed that the breadth of knowledge can be teased out using the presentation and role play, and not just relying on the competency based questioning. 

Hi [redacted]: At last night's [redacted]Scotland parliamentary reception [redacted]fairly lightly mentioned (during his address) that some sort of support from Scottish Government with the Scotch Lamb campaign this year would be very welcome. Journalist [redacted] followed up on this with him afterwards. 

Colleagues

Thank you all for your persistence yesterday. I think it took rather longer than we expected – while I had it in my diary for 0930-1630, I was looking forward to an early bath, so going into extra time and penalties took extra effort.

I realise, looking back, that we left a loose end. We had begun a re-evaluation of our scoring on candidate M31, but got diverted onto something else and did not return to finish our consideration. I think he/she suffered a bit from being at the end of the pack, and thus last in our consideration both in our own prep and during the sifting. I think some of us found his/her liberal use of acronyms rather offputting. Can I ask that [redacted] confirms what our collective score for this candidate was, and that we each confirm whether we think this is still correct?

Separately, we got into rather a tangle about how to score at interview on the priority criteria around knowledge/experience of production, processing and/or finance and risk management, where we have asked for evidence of "at least" one of these. We got to a position on this, including a consistent question that could be asked of all candidates so that they could answer from whichever of these areas they wish. But I think there was still some unease amongst us on how to deal with the "narrow, deep" versus the "broad, shallower" knowledge and experience. As this is bound to have cropped up in appointment rounds in the past, and been considered more exhaustively than we managed yesterday (which was more exhausting than exhaustive!), I propose to discuss this with Kevin and the Public Appointments Team with a view to developing a proposed methodology that we can agree in correspondence before we start the interviews so that we avoid yesterday's complexities, get what we need for QMS and keep in line with the requirements of the public appointments process.
