Dear First Minister


As you may be aware, a Scottish Sheriff - Gerard Sinclair – has recently adjudged a paedophile who had been found guilty of the sexual abuse six-year-old child, be released with an *Absolute Discharge*. This ruling was, according to the Sheriff, decided upon because any other would have negatively impacted said convicted paedophile's enamel-white future? *Apropos* this finding: Has that adjudication now become legal precedent? If so, does the judgemental logic only apply to young paedophiles? I ask this because I rather think being found guilty of any crime is bound to have a negative impact on the future of the person convicted?

If I am mistaken, and The Court's newly minted indulgence of convicted criminals does not extend beyond young paedophiles of a certain social background, please let me know as it will have an effect on several money-making schemes I presently have in mind but which, heretofore, I have been reticent to implement due to, what may be, an archaic fear of the punitive legal measures the aforementioned schemes, if discovered, would likely attract.

And one more thing: At the risk of sounding cynical, was The Scottish Government involved in Sheriff Sinclair's decision to grant an *Absolute Discharge* to a convicted paedophile, for the purpose of diminishing the need for an expensive judiciary (even after your cutbacks) by removing the necessity for any formal legal involvement in erstwhile criminal conduct?


Dear Mr Yousaf

I am writing to you in some distress due to the recent news coverage of the trial and subsequent absolute discharge of Christopher Daniel, despite having been found guilty of sexually assaulting a six year old girl, over a two year period.

This case has struck a particular note with me and not just due to shocking outcome of the trial. 

find that Sheriff Sinclair's assumption that "It was fortunate that the complainer appeared to have suffered no injury or long-lasting effects" unbelievable. I can assure Sheriff Sinclair that any person who has suffered any form of sexual abuse will have some form of long-lasting effect. 



 Cases like this when the victim is brave enough to come forward and identify their abuser should be supported, all that this case illustrates is how pointless the justice process is and would deter other victims from stepping forward.

My further concern in this case is the fact that Christopher Daniel is currently a matriculated student at the University of Glasgow studying dentistry. As a member of the dental profession for the last twenty years I feels that this case puts my profession in an unfavourable light. Sheriff Sinclair has commented that "Any recorded conviction for this offence would have serious consequences in terms of the accused's future career". I would suggest that quite rightly a guilty verdict of sexual assault against a six year old should have serious consequences on a career as a health care professional who would be in a position of responsibility and trust. I understand that Christopher Daniel did not disclose information about his upcoming trial to the University and, in fact, dismissed the charges as being minor. His guilty verdict and absolute discharge puts the University of Glasgow in an impossible situation in terms of whether they lift his suspension and allow him back to treat patients, as a known sex offender, or remove him from his course but with an absolute discharge this would be legally unwise.

I understand that you, as Cabinet Secretary, have no oversight of prosecutions but with responsibility for the Justice system in Scotland I would be grateful for your advice as to where to take my concerns further.
I look forward to hearing from you in due course.

Good morning, Mr Yousaf (Cabinet Secretary for Justice) I am writing this from a personal point of view. According to you I am a criminal with a section 38 conviction, "threatening and abusive behaviour" [REDACTED]

[REDACTED] I had my whole world in front of me but now it's disappeared because I dared to question our police force. The above paragraph is just a small point of my anger. I want to know why I am now regarded as a criminal for swearing in public and questioning our police force under "section 38" yet an 18 year old who sexually abused a girl since she was 6 has been admonished and will live his life without any "disclosure" and will fulfil his ambition. I ask the question. is it because his family had money?

First, I know you can't comment on specific cases and I do not expect a reply. For a sheriff to take into consideration someone's potential career whilst passing sentence confuses me, not all sheriffs do this. I was involved in an incident on a bus where I was attacked, I hit back and subsequently faced criminal charges. Now I accept my conduct was incorrect and I should not have acted like that, I also accepted that I would face some form of punishment and handed myself into the police - a process that believe it or not took a week to arrange. I was charged with serious assault with endangerment to life and breach of the peace - if I plead guilty I would have received three years.

[REDACTED] On day one of the trial endangerment to life was dropped as there was not one shred of evidence to support the crown's claims in that regard and by end of trial I was convicted of assault to injury - if this was the original charge or the pf was willing to budge I'd have plead guilty to this. In my solicitors summing up he appealed to the jury that I was a man of character who had acted in the heat of the moment and that a conviction would ruin my career and affect my ability to pay my mortgage and support my family. The judge quickly dismissed this telling the jury that the consequences of the conviction were for me, and only me to concern myself with. I lost my job, the sentence imposed involved a restriction of liberty severely affecting my employment opportunities further exasperated by the community service order. Why has this judge considered this sentence appropriate for this person? My career was not considered, and since I broke the law neither should it have been. The justice system in this country is broken, the time wasted at courts is unbelievable - shadow a solicitor for a week they will tell you. All your powers should be used to ensure this case and the sentence is reviewed, including whether or not this sheriff is fit for service.

This is an outrageous situation. It makes a mockery of our justice system that the judge in this case has saw fit to put the promising career of a young man in front of the safety and well being of others who may be put at risk in the future from Christopher Daniels "curiosity". I ask that you use your position to ask for a review of this case and that you use your position to seek a review of the fitness of the judge in this case to practice. His morals must surely be of a questionable nature to have considered this outcome to be in line with the essence of the law as it relates to sexual molestation. One wonders if this young man was not as well educated or if he had a less privileged background would the judge have been so lenient? I feel if this case is allowed to remain unchallenged it will act as a signal to those committing such offences that the law can be flouted, it will set a precedent that the right to a career and a life untouched by such a label as a sex offender is in some way acceptable, which of course it cannot possibly be. I am writing to you in your capacity as Minister for Justice regarding the well publicised discharge handed down to Christopher Daniels by Sheriff Gerard Sinclair. I am not a vengeful person in any way, but feel strongly that this impossibly lenient sentence sends all the wrong messages about Scotland's attitude to child protection and sexual assault, as well as failing to protect Mr Daniel's future patients and acquaintances.

In short, by failing to record a conviction for Mr Daniel, or to place him on a sex offenders register, the Judiciary of Scotland are broadly being seen to condone the sexual assault of a minor over a 2 year period. This cannot be allowed to stand. The precedent this provides to predators is grotesque. The message to victims is "don't subject yourself or your children to the court system – you cannot expect a conviction". To the world (and I have seen this reported globally in the last 24 hours) the Scottish Justice system seems corrupt to the core and elitist.

And all this before I even mention that Mr Daniels is expected to take up a position of great trust in the community as a dentist.

Please, please have the Attorney General review this case, and the Crown office appeal the sentence. Not for retribution, but for the reputation of Scotland and its Judiciary.
