Dear Minister,

Thank you for your call last week to explain the Scottish Government's thinking around the promised, but further delayed, cut to Air Passenger Duty.

As I referenced on that call, I am meeting with

Since the recovery from the 2008 financial crisis, airlines have consistently said they support expansion into Edinburgh and Scotland on the back of promises by the First Minister and this government that APD would be cut and ultimately abolished to ensure and encourage growth.

That growth would bring widespread economic benefits and reduce the cost of holidays for families in Scotland looking to getaway for that well-earned break. A further delay means those plans are yet again on hold and confidence that your manifesto commitment will ever come to fruition is rapidly eroding.

Taking your decision and our conversations with airlines into account, we have been forced to update our passenger predictions and are now forecasting a reduction/negative growth for the rest of the year/timeframe. This is a sizeable change in direction for Scotland's busiest airport which has experienced growth of around 700k passengers per year since 2012.

This pattern of decline is already in evidence in Glasgow and other Scottish airports and will represent the first decline in over 10 years at Edinburgh Airport. We are clear that the decline will be the direct result of failing to deliver promises that airlines had believed and invested in in the last 3 years.

We must show that we are open and supportive of tourism to change this direction of travel and we want to work with the Scottish Government to at least show the rest of the world there is a desire to achieve this goal. We therefore encourage you to look at cutting APD on new or expanded long-haul flights, something this is within the gift of the Scottish Parliament and would not require budget support.

I would be happy to work with you on how best to explore this move which would not affect Inverness, nor be part of the current political debate on ADT or the budget implications of changing the current tax position.

Importantly, it would demonstrate globally that the Scottish Government still wants to deliver on its promise and is a show of good faith to those airlines who still want to invest and grow in Scotland. It would also be a powerful signal as Brexit continues to cast a long shadow over Scotland and the UK.

I am sure that this would be warmly welcomed by the aviation industry and our airlines as we look to increase connectivity and bring Scotland closer to the world.

I look forward to your reply.

Dear Derek,

Thank you for your recent call to inform us of the Scottish Government's change in direction in its Air Departure Tax policy and a cut to what is the highest aviation tax in the world. Although we disagree on the outcome, your call was appreciated as it is always better to hear it personally than through other channels.

It's no secret that I think this decision has been taken at jet speed and without an in-depth look at the facts and evidence, and that is why I write to you. We can all agree that climate change is an issue which concerns us all and as an airport we are no different. We know that we must have a sustainable operation that encourages controlled growth yet ensures we protect connectivity and our international outlook.

Aviation is already making great strides in becoming more sustainable and actually debunking some of the myths around our industry. Sustainable Aviation is a long-term strategy which sets out the collective approach of UK aviation to tackling the challenge of ensuring a cleaner, quieter, smarter future for our industry, and it brings together major UK airlines, airports, manufacturers, air navigation service providers and key business partners. It responded to the Committee on Climate Change's report and laid out some of the positive steps the industry has already taken and plans to take, such as:

- de-coupling aviation growth from growth in emissions: between 2010-16, passenger numbers in the UK grew by 25.8%, while total emissions only grew by 4.7%.
- member airlines improved their fuel efficiency by more than 13% since 205 thanks to purchasing new technology
- 360 new aircraft are currently on order by UK airlines, which will improve the fleet-average fuel efficiency of UK aviation by 22% by 2050
- Modernising airspace by mid-2020s to deliver a reduction of up to 14% in emissions by 2050, including through more efficient operational procedures – like continuous climb departures and descent approaches which

This shows that we are changing and are becoming more environmentally friendly. This shows there is a sustainable future for aviation. And it shows that we want to be part of this debate.

I strongly feel that we need to raise the level of debate around this issue and allow all industries to have their opportunity to talk about what they are doing in terms of carbon reduction and what improvements they can make. This conversation is crucial before the government makes any further knee-jerk reactions because any decision must protect our economic interests as well as our environment. They go hand in hand and to favour one over the other does not add up.

We all accept that there are challenges ahead of us and industries must have a discussion to map out a way forward. That response will only come from a reasoned and evidence-based discussion which will allow us to take a balanced view and approach.

We admire the desire to show global leadership and want to be part of Scottish led innovation and response. But demonstrating leadership can only work if it encourages others to follow, particularly where Scotland's direct contribution to the solution will be commensurate with our modest size. Others cannot and will not follow if the price of our approach is serious damage to our economy, loss of jobs and inability to support social sustainability as well as climate change.

We must have a discussion which takes all of this into account and leads to a decisive and well-thought out plan of action that works for us all or the country risks losing out. I'm sure you will agree when I say that this debate must happen to protect Scotland's interests, and we want and deserve to be part of it.

A 2016 independent economic impact study showed we contributed over £1 billion per year to the Scottish economy, supporting 23,000 job across Scotland - that's 2,000 jobs and £90m GVA for every million passengers. Since that study, we've added 2.2m passengers, handling 13.4m in 2017. And that suggests we've generated an additional 4,000 jobs and another £180m GVA across Scotland.

Meeting request from Scotland's airports, airlines, business and tourism organisations

We are writing as representatives of Scotland's main airports, airlines, business and tourism organisations regarding the Scottish Government's decision to abandon its manifesto pledge on cutting and eventually abolishing Air Departure Tax (ADT).

In developing this policy position, the Scottish Government consulted extensively with industry, convening its first ADT Stakeholder Forum as far back as 6 August 2015. This forum provided a platform to highlight the detrimental impact of Air Passenger Duty (APD) on Scotland's connectivity and to share the tangible benefits a cut would deliver in terms of job creation and route development.

Strong connectivity drives a range of activities that underpin successful, sustainable modern economies, from inward investment to exporting, productivity and tourism. Unfortunately, when benchmarked against European countries of a similar size, it is clear that Scotland's connectivity lags.

This was confirmed in your Government's recently published plan for growing exports 'Scotland: A Trading Nation' which stated "we do not have as many direct long haul flights when compared to similar sized European nations." The same report outlined your ambitions to enhance international connectivity to allow Scotlish businesses to increase their earnings; to make Scotland more attractive to potential inward investors and to attract more inbound tourism.

It is difficult to see how this can now be achieved in light of the sudden reversal in policy which will serve to further exacerbate our connectivity deficit. Our airports are already reporting a loss of routes and the promised cut in ADT would have provided airlines with the confidence required to invest in Scotland.

All of us share your ambitions for Scotland to become a 'carbon neutral' economy by 2045, however, this decision will do nothing to further that goal. Aviation is a global industry and therefore requires international action to reduce global CO2 emissions. In the UK, the aviation industry has already decoupled growth in aviation from growth in emissions and is investing billions of pounds in developing new sustainable aviation fuels for cleaner and quieter aircraft.

Given the lack of consultation ahead of the decision on ADT and the lack of recognition of the huge steps the aviation industry is taking to tackle CO2 emissions, we are requesting a joint meeting to better understand how the Scottish Government can support an industry that has such an important role to play in strengthening Scotland's global standing.

Our organisations wish to work with you to ensure there is a cohesive, evidenced-based policy backdrop that allows us all to help deliver sustainable economic growth for Scotland. We look forward to your response.

Terminal expansion officially opened First Minister celebrates airport's growth.

First Minister Nicola Sturgeon has officially opened Edinburgh Airport's £75 million terminal expansion, the biggest project in a generation at the airport.

Part of a wider £200 million investment programme at Scotland's busiest airport, the expansion enhances the airport's connectivity options and will support passenger growth to twenty million passengers.

The expansion delivers new gates, new aircraft stands and new international and domestic passenger arrivals halls, as well as new baggage reclaim areas and an extended immigration hall. It also has new retail and food and beverage outlets, including the world's first BrewDog airport bar.

It's the start of a larger programme of investment in key terminal and airfield facilities over the next 5 years, with almost £300 million being spent on a new baggage system, more new stands, improved checkin facilities and a new access road.
