Activity Summary

Since our last progress report we have delivered the following activities:

Workshops: The workshop is open for the public three times a week, where they can work on their making and repairing projects. We provide reclaimed material that is free to use for anyone at the workshop. Aside of the open sessions we run every week a thought session on either tool maintenance, bike repair and basic wood working skills.

Library: The new Tool Library in Portobello is open 3 times a week, making it possible for more people to borrow tools.

Young Tooligan Workshops: Our youth initiative for young people has kicked off. We bring creative workshops to Edinburgh's young people, where they explore reuse and recycling of materials, climate change and what we can all do to reduce our carbon footprints. We have been running these workshops at different youth organisations and will run a series of sessions for schools in December.

Community Program: In September we hosted our Volunteer Assembly where community projects can pitch their building ideas that will change their community for the better. Two projects have been selected by the Tool Library volunteers. The first community build project was in Duddingston where we transformed their community garden and orchard to a space where they can sell their vegetables and fruit they grow. The total build fixed approximately 3.2 tons of carbon that would have gone to landfill and back into the atmosphere.

Volunteer Opportunities: We have actively promoted our Portobello volunteering opportunities in our community and have established a small team of dedicated volunteers. We adapted our volunteer journey to improve the volunteer retention. By the current involvement of our new volunteers we believe this has helped our project.

Reflection on your Successes

Our program of guided workshops is well attended and fully booked. We receive positive reactions from the participants. This has brought in new members to the Edinburgh Tool Library.

The most successful part of the Young Tooligan Program has been the workshops created, each has had great feedback and in terms of bringing climate change and greenhouse gas emissions to life it has worked really well. Feedback from Youth Organisations and education officers has been very positive.

Reflection on your Challenges

Our main challenges are to attract more people to use the open workshop sessions. The Portobello thought workshops are very successful, but we don't see these participants coming back for the open sessions. Even though we had hoped that acquiring the basic woodworking skills will get people to use the workshop for their own projects. This has been a very valuable learning curve for us, as we might need to adapt the workshop sessions to more thought and less open sessions. We are currently testing a change of structure to the open sessions, by bringing in an element of teaching to them to see if that changes the attendance.

For our Young Tooligan Program the main challenge is bringing the program to the schools. We have had a positive reaction from teachers but due to internal structure at the schools is it difficult to plan the workshop sessions. We are now planning to host the school sessions in December.

Outcome 1

By increasing our Tool Library sites from four to six, we will enable over 1,000 new Tool Library members to share tools, rather than buying them new, as well as being able to divert 1200kg of tools from landfill, reducing CO2e by over 2T each year.

Progress Made

Since opening the new Tool Library workshop & library in Portobello our membership has gone up by 68 new members.

The thought workshops for our members have proven to be very popular, it has gained us new members as well as given old members reasons to participate in the activities of the Edinburgh Tool Library. During those workshop sessions we have heard many times that they have signed up as a member but never used any of the services, or borrowed a tool once. These workshops are very valuable for attracting and bringing people back to the Edinburgh Tool Library. Reminding them that we are here and doing these great activities.

We receive many donations. From the last progress report till now we received: 216.39kg of tools that have been diverted from landfill.

Review

The Tool Library and Open Workshop in Portobello is a growing project. In comparison to our main lending site and community workshop in Leith we're currently not attracting the same numbers as they do. This is not strange for a new community project but we are developing different strategies to attract new members. This month we will focus on running more workshops for members and non-members, running promotion campaigns and participate in local activities (e.g. Christmas markets) to attract more residents from the Portobello community to use our services.

Development Officer Feedback:

Perhaps should add that that the total tools saved so far is over 1,000 kg to show that that this Outcome is more then on track to achieve its target.

Outcome 2

We will increase the number of our current members who have repaired an existing item or made something from reclaimed materials by 40% - 320 individuals. We will aim to have 50% of all new members – an estimated 200 individuals - reuse or repair a household item within their first year of joining. We estimate that this will save 7.74T of CO2e each year.

Progress Made

The Portobello workshop is open 3 times a week for members to work on their own repairing and making projects. All our thought classes focus on the use of reclaimed material and during the open sessions members can use any of the wood and timber that is available for free.

Since the last progress report the open sessions together with the weekly thought session has made it possible that 152 individuals repaired or made something from reclaimed materials. We have monitored the attendance of the open sessions as well as the thought sessions.

Review

As mentioned in Outcome 1, our main challenge is to attract more people to use the open workshop session. We have regular members but we would like to see new faces and more people using the workshop.

In our strategy to attract more women we have developed a women's woodshop session, that is run by an experienced female joiner. The woodshop introduces women to the workshop facilities whilst becoming familiar with the tools and developing woodworking skills.

It is for us important that the space is an inclusive environment, where we make it possible for different groups to learn and become inspired by our ethos.

Development Officer Feedback:

Sounds like good progress.

Would be good to provide numbers for the various workshops to better communicate how much they are being attended.

Also would be nice for some additional information such as quotes/comments pictures to better communicate what the project is achieving.

Outcome 3

We will improve carbon literacy and environmental awareness amongst 300 12 – 17 year olds across Edinburgh.

Progress Made

The most successful part of the project has been the workshops created, each has had great feedback and in terms of bringing climate change and greenhouse gas emissions to life it has worked really well. Feedback from Youth Organisations and education officers has been very positive.

Progress Youth Organisations:

Youth organisations are each different, and an open collaboration where nothing is set in stone when beginning the partnership is most effective. Being clear about what each partner needed was essential, and working out what will be most effective for their young people. There has been some difficulty in securing the numbers hoped for in these workshops, and this is due to the nature of the groups and context within which the young people attend the groups. Being flexible, when the workshops are held is essential, as workshops which are run outwith of youth organisations' regular hours cannot guarantee attendance and will likely yield low numbers.

Progress Schools:

The schools programme will take place in December, aiming to hold 8-10 workshops across 6 days in at least 3 schools. The school program will be where we could reach more young people.

Review

Initially we had a lot of difficulty getting our workshop to the right people at the schools, as without a specific contact it was difficult to get through the initial stages of phoning the school or emailing the head teachers.

It is important to note that the Young Tooligans Programme from ETL is in it's first year and is the first youth initiative from the charity. At this juncture it is our strategy to research and develop a programme which reflects the goals of ETL in terms of supporting sustainability, carbon literacy and creativity in our community.

Development Officer Feedback:

As above any supporting evidence such as quotes etc would be good to add to help demonstrate the impact the project is having.

Outcome 4

We will encourage the reuse and reclaiming of materials, particularly timber, by giving people the skills and the tools required to create items from it. Based on the amount of reclaimed materials saved this year, we estimate this would save 21.78T CO2e a year

Progress Made

The Portobello workshop is open 3 times a week for members to work on their own repairing and making projects. All our thought classes focus on the use of reclaimed material and during the open sessions members can use any of the wood and timber that is available for free. For our community projects/workshops we only use reclaimed materials. Our workshops show the range of possibilities you can have when working with reclaimed materials.

Since the last progress report we saved 2830 kg of wood.

Review

In general as a woodworking workshop we provide the right environment where people will make and repair things out of reclaimed materials. We are known for our community projects/builds being made solely out of reclaimed materials, this helps to encourage people to use this material.

Development Officer Feedback:

Great progress in achieving your carbon saving targets.

Outcome 5

We will teach over 200 people how to fix and maintain their bicycle, regardless of the condition or age of the bike, helping increase the lifespan of their bicycles and encourage people to cycle more. We estimate this will save 10.27T of CO2e each year.

Progress Made

Since our last progress report we have started a collaboration with the charity Bikes for Refugees. They are a volunteer led community project who repair and upcycle donated bikes for New Scots. We have teamed up with this organisation and created a series of bike repair workshops. In this collaboration, four New Scots and four ETL members learned the skills to repair bikes for someone who really needs them.

In conjunction with these series of workshops we as well run basic bike repair workshops where members can learn to fix their own bikes.

Review

Our bike repair program is really successful and important. The collaboration with Bikes for Refugees works very well with the ethos of the Edinburgh Tool Library and has given an extra dimension to our bike repair program.

We will run more sessions each month to reach more people.

Development Officer Feedback:

Good work although it does not look like you will achieve the Outcome target of 200 people.
It looks like no carbon saving has been achieved for this Outcome.

We have improved our volunteer retention strategy and are training our volunteers in all the different aspects of running the Edinburgh Tool Library Portobello.

For income generation we are developing a hot-bench renting structure. During the days that the workshop is not in use, people will be able to rent a bench for a morning or a full day. The workshop space and the facilities will be will as well be of good use for this format.

Development Officer Feedback:

Would be useful to include any legacy from the workshops and activities the project is running included here. Plans for the continuation and development of the Portobello site for example.
