#### Project Description

The project will establish the migration routes of salmon smolts (juvenile salmon heading out to the sea for the first time) along the west coast of Scotland, in particular within the Minch Sea, between the Outer Hebrides and mainland Scotland. This is a partnership between University of Glasgow, Fisheries Management Scotland, the aquaculture industry represented by the Scotlish Salmon Producers Organisation, Marine Scotland and the Atlantic Salmon Trust. It is the first year of an anticipated three year project. In the first year up to 800 salmon smolts will be tagged with an acoustic tag, as they migrate out to sea. The fish will then be detected on two arrays of listening stations between (1) Malin Head and Islay (2) Benbecula to the Isle of Skye, and associated smaller arrays between the inner most islands and mainland Scotland. These will be supplemented by 40 acoustic receivers located to intercept fish at key coastal locations. At a local level this is to inform planning responses to coastal developments such as marine finfish farms and renewable energy installations. The information is also required at a national level to inform appropriate policy development, as highlighted by two recent Scotlish Parliamentary enquiries into salmon farming, and as identified by the Scotlish Government Diadromous Fish Specialist Receptor Group regarding marine renewable developments. The information from the project will be used to calibrate a Marine Scotland smolt dispersal model.

What are the targets and benefits for your project including time frame for achievement?

(1) The project will deploy arrays of acoustic receivers from Skye to Benbecula. This will be achieved in spring 2020. (2) Six rotary screw traps will be purchased and deployed by February 2020 and local fishery trusts trained on their use. (3) Up to 800 salmon suitably sized smolts will be tagged with Vemco V7 tags from eight rivers. This will be achieved in spring 2020 (4) The receiver arrays will be collected in July 2020 and the information downlaoded for analysis. (5) The information will be provided to Marine Scotland by September 2020 for use in validating their smolt dispersal model. (6) A preliminary analysis will be completed by November 2020 to guide deployment and project direction in 2021 and 2022.
