Following your query I have been in touch with the Water Industry Team in Scottish Government, who in turn spoke to Scottish Water. I understand that Scottish Water was very much aware of the issue raised by you. They advised that in order to progress the funding aspect, Dumfries and Galloway Council now need to put a formal letter to Scottish Water setting out a request for funding, together with suitable evidence. It will then go into the internal Scottish Water systems for consideration. Scottish Water indicated that to date no 'formal' request has been received, though a number of conversations have raised the potential for a contribution essentially for the pumping work.
