UPDATE ON TAY CITIES REGION INDUSTRIAL INVESTMENT PROGRAMME

Purpose

1. To provide an update on the £10m Tay Cities Region Industrial Investment Programme and seek your agreement to an associated £7.5m funding proposal for the Michelin Scotland Innovation Parc (MSIP).

Priority

2. **URGENT:** An announcement is scheduled for 6 November (para 10).

Background

3. Heads of Terms were signed for the Tay Cities Region Deal in November 2018. The Scottish Government (SG) and UK Government (UKG) will each make £150m available through the Deal to support inclusive economic growth in the region over the next 10 to 15 years.
4. In January 2019 the First Minister announced an extra £50m would be offered by SG, fulfilling a commitment made prior to agreeing Deal Heads of Terms to invest £200m in the region. This investment is aligned with, but separate to, our support for the Deal, given our agreed approach is to fund Deals on a 50/50 basis with UKG.
5. £40m of this additional funding will support the development of the Cross Tay Link Road to the north of Perth. The remaining £10 million is allocated to a regional Industrial Investment Programme (IIP), which will support the existing and future needs of manufacturing businesses across the whole region. The First Minister also indicated that the IIP should explore all opportunities across all industrial sectors, and that she expected future options for the Michelin plant in Dundee to be a key focus of the regional partners' discussions.

IIP development

6. Scottish Enterprise (SE), working closely with the region's four local authorities, have drafted an outline business case for the IIP.
7. In order to optimise regional impact, officials have been clear that we expect the IIP and its constituent projects ultimately to be overseen by the Tay Cities Region Joint Committee. Officials are working with regional partners to finalise the associated governance arrangements.

Michelin Scotland Innovation Parc project proposal

8. SG officials, Dundee City Council and SE have identified an immediate opportunity to make a significant investment through the IIP to support the development of the Michelin Scotland Innovation Parc (MSIP).
9. Michelin is due to close its Dundee plant by June 2020, with the loss of 845 jobs. The impact of these redundancies will be felt across the region – although the majority of Michelin employees live in Dundee, almost one third (32.5%) live elsewhere in the Tay Cities region.
10. Whilst the job losses pose a significant challenge to the regional economy Michelin are committed to delivering a positive and lasting legacy from the site, and are working with public sector partners including SE and Dundee City Council to develop MSIP. The aim of MSIP is to deliver a new future for the site and for the region more widely, focusing on sustainable mobility and low carbon industries. Over time we expect MSIP to become a global location for investment in these emerging sectors, which in turn will bring quality employment opportunities and other benefits to both the region and Scotland as a whole.
11. Michelin has committed to investing £30m to take MSIP forward, which the Cabinet Secretary for Finance, Economy, and Fair Work has pledged to match with £30m public funding over the period to 2027/28. A formal announcement of this commitment is planned for **6 November**.
12. This note proposes that £7.5m of this match funding is drawn from the IIP, to support the following projects:
 - Innovation Hub** (£5m) to facilitate the development and growth of new companies focused on sustainable transport and the low carbon economy;
 - Grow on space** (£1m) to house businesses emerging from the Innovation Hub; and
 - Ancillary works** (£1.5m), namely site preparation and infrastructure work at the core of the Parc.
13. Officials are content that these proposals accord with, and will help to deliver against, the IIP's overarching objective of strengthening the region's industrial sector and investing in the drivers of Industry 4.0.
14. While the focus of the proposed IIP investment is on the Michelin site we expect it to deliver wider regional benefits in terms of employment, innovation, and supply chain activity across the region's manufacturing base. Moreover, the £7.5m being sought from the IIP will form part of a much larger, £60m MSIP investment package that is wholly additional to SG's existing £150m commitment to strengthening the regional economy through the Tay Cities Region Deal.

Financial considerations

15. IIP funding sits within the City Region and Growth Deals budget and was originally flat profiled at ~£1.1m a year over nine years (starting in 2020/21) within current financial plans. However, given the immediacy of the MSIP opportunity and emerging underspends in the wider deals programme, officials will consider whether there is flexibility to make funding available over a shorter timeframe. This would have the benefit of meeting an immediate need to secure the MSIP project while helping to alleviate pressures in future years.

Comms and handling

16. The Cabinet Secretary for Finance, Economy and Fair Work will be on site on 6 November, the first anniversary of the announced closure, to meet with Michelin employees and reaffirm 'Team Scotland's' £30m funding commitment. Arrangements for the day are still in development but are likely to include the launch of the proposed Innovation Hub. Press will be invited to attend.

17. There are no plans to provide a detailed breakdown of the £30m commitment on 6 November. Given the immediacy of the MSIP opportunity it has not yet been possible for SE to seek formal approval of the IIP business case from the Tay Cities Region Joint Committee, although the Chief Executive of Dundee City Council has consulted informally with his counterparts in Angus, Fife, and Perth and Kinross, who have indicated they are supportive in principle. We would suggest therefore that further publicity around the IIP's support for MSIP takes place in due course, once further detail on the projects listed at paragraph 12 is known.

Recommendations

18. You are invited to:

- **Note this update;**
- **Agree that £7.5m of the £10m Tay Cities Region Industrial Investment Programme be utilised for the Michelin Scotland Innovation Parc proposal;**
- **Note that (subject to your agreement) officials will explore options for making this £7.5m available as soon as possible; and**
- **Note the planned announcement by Mr Mackay on 6 November.**

Colleagues,

I had a useful talk with {REDACTED} on the phone.

I have also discussed with James Hynd, Head of Cabinet Secretariat, and we have concluded that there is no reason why this long-planned event should not go ahead on 6 November (which is likely to be confirmed as the first day of the pre-election period). This conclusion also covers the related funding announcement – which is to be jointly funded by Michelin and SG.

SG election guidance for UK general election campaigns covers events which might be deemed to have “*a party political purpose*” or of which “*the purpose is related to the UK general election campaign*”. It also covers and announcements “*which may have a particular impact on UK general election issues, such as policy statements with specific reserved or cross-border dimension*”. The proposed event and announcement do not raise concerns in relation to these points.

The following points are relevant:

- The date of the event has been determined by the anniversary of the Michelin announcement, so there can be no suggestion that the event has been arranged in response to the UK general election. The event has been in diaries for some time, and Michelin executives are also attending;
- The event is part of the ongoing work in partnership between a number of groups, including SG, Scottish Enterprise, Dundee City Council and, of course, Michelin;

- The focus of the event will be on the positive work by the SG and others to save jobs and help devise a new use for the Michelin site, in collaboration with Michelin (as mentioned in the recent Programme for Government);
- The related funding is an essential part of ongoing work to re-purpose the site and has been planned for a long time.

If, as Richard suggests below, Michelin were to be in the lead on the announcement, then this would also reduce the risk of any misunderstandings in relation to the election period, but this is not essential.

I hope this is helpful.

Plans unveiled for future of site.**

The future of Michelin's Dundee site and the creation of new economic and employment opportunities across the region has taken a step forward with a £60 million funding commitment.

The investment, supported by Michelin, Scottish Enterprise and Dundee City Council, will transform the site into the Michelin Scotland Innovation Parc (MSIP) over the next ten years.

The Parc will be an ambitious centre for innovation and skills where industry and academia come together with a focus on sustainable mobility, clean transport and low carbon energy. It will include an innovation hub which will offer office space as well as business and innovation support services. The innovation hub will be a focal point for collaboration between industry and academia.

The joint funding commitment comes a year after it was announced the Michelin plant would close in June 2020.
