The Improvement Service, which collects and analyses the data on our behalf, is in the closing stages of preparing a national level report on delivery progress which will be published over the summer (we're receiving requests from this from MSPs, and they know we have the data, so it will need to be in the public domain before PfG).

The next formal progress data collection from authorities covers the period to 30 September, so will obviously be too late for PfG.

We'd obviously like to reflect the latest possible position in PfG, but there will be a careful balance to be struck between using the most robust and the most recent

indicators (the info we collect through the biannual formal collections should be more robust than the August indicators). We should be able to give sufficiently reliable figures at national level in the second half of August in any case, but I'd suggest that it would be worth PfG team arranging a conversation with our delivery assurance team to chat through what level of detail would be desirable and what the sign off deadlines are for the final document to allow us to reach a sensible position on what to reflect.

PLANNED PUBLICATION OF THE JUNE EARLY LEARNING AND CHILDCARE EXPANSION DELIVERY PROGRESS REPORT

Purpose

1. To update you on plans to publish a national-level summary of the Early Learning and Childcare Expansion Delivery Progress report presented to the Joint Delivery Board (JDB) in June.

Priority

2. Routine. Officials plan to publish the report in w/c 30 July, and so it would be helpful to have a response in advance of this.

Background

- 3. A national summary of the first Delivery Progress report presented to the JDB was proactively published in December 2018, and following the June JDB meeting officials are now making preparation to publish a second such national summary. In line with the previous publication, our intention is to publish the report analysis, but not all of the annexes produced by the Improvement Service to accompany it, as these contain individual local authority data.
- 4. We expect that there will be political and sectoral interest in this report. Tavish Scott has asked the Improvement Service for a copy of the report, and Alex Cole-Hamilton has already asked a PQ (due 7 August) about workforce data included in the report. Key messages likely to be identified from the report include;

Handling

- 5. It is planned that the report will be published on the Improvement Service website in w/c 30 July, and the PQ will be answered, referring to the report shortly after this.
- 6. Officials have been considering lines for media handling, both in general terms, and in relation to some of the specific issues raised [Redacted]. When the report is published, we will draft lines responding to the particular queries raised, but would propose a tone as set out below;

"We welcome this report setting out further evidence of progress by local authorities in preparing to nearly double funded ELC for 3, 4 and eligible 2 year olds from August 2020."

We know that local authorities are working incredibly hard with their local partners to prepare for August 2020, including in many cases phasing in the extra hours early to ensure systems are ready."

Through the Joint Delivery Board the Scottish Government and local government will continue to monitor progress and ensure support is provided to enable local authorities deliver our shared commitment to the increased entitlement."
