

on wild salmon at national level. It is clear that we are not starting from zero: there are a wide range of ongoing projects and initiatives. The strategy will draw together in an accessible form the current strands of work, identify new areas and set out our priorities going forward. Research & scientific evidence will play a very important role in the strategy as evidence not only helps to identify problems, but also helps to identify solutions.

A wide range of policy areas and stakeholders will need to work together to deliver actions to support wild salmon. Rather than a *Marine Scotland Salmon Strategy*, we aim for a *Salmon Strategy for Scotland*, which will draw out how a wider range of parties will work together to protect and enhance wild salmon populations.
