By way of an update, in response to your request below, we have sent the Task Force minutes to our First Minister's private office to check that she has no objection to these being released. We do not anticipate any difficulties with this and we will get back to you as soon as possible and certainly by Friday of this week to meet the 5 day deadline.

The Scottish Government has similarly received a Freedom of Information request for the minutes of the meeting between M. Barnier and the First Minister of Scotland on 10 February. Under the Freedom of Information (Scotland) Act 2002 (FOISA), we have a duty to consult any third party with an interest in the information requested.

I have attached the information that we propose to release. As you will see, part of the meeting note has been redacted since exemptions 32(1)(a)(ii) (relations between UK and any international organisation or court) and s.38(1)(b) (personal information) of FOISA apply to that information. With regard to personal information, our normal practice is to redact names of Scottish Government staff who are more junior than Deputy-Director level. On that basis, do you wish us to redact any names of attendees from the Task Force?

I would be most grateful if you could consult your authorities in order to determine whether they oppose disclosure of this information. Please can you respond within 5 working days in order for us to respond to the applicant within the timescale set out in the legislation.
